FIFTY-FIRST DAY

Tuesday, April 11, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:41 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Captain J.J. Thompson, Command Chaplain, Naval Station, Pearl Harbor, after which the Roll was called showing all Senators present with the exception of Senators Cobb, Holt and McMurdo who were excused.

The President announced that he had read and approved the Journal of the Fiftieth Day.

The following introductions were then made to the members of the Senate:

Senator B. Kobayashi introduced a group of 5th grade students from Liholiho Elementary School.

Senator Crozier introduced a group of students from Kamehameha Schools also from the 5th grade, accompanied by their teachers, Nancy Hemphill, Charlene Christianson, Lindell Ohia, Laurie Seto and Jackie Carroll.

Senator Solomon then made the following introduction:

"Mr. President, it is my pleasure, as your chairman of the Committee on Higher Education, to present the representatives of community colleges and the chairman and members of the Board of Regents in celebrating the 25th anniversary of our community colleges.

"The University of Hawaii had its beginnings in 1907. The Legislature of the Territory of Hawaii established a college of agriculture and mechanical arts on Oahu. The college of Hawaii became the state's Land Grant institution of higher institution. Initially, there were 12 faculty members and five regular students. Several years later, the college moved from its temporary location in downtown Honolulu to Manoa valley, the current location of the University of Hawaii at Manoa, and the college of arts and sciences was added to the college of applied sciences in 1920.

"Following World War II, the University's academic and physical growth progressed. By the early 1950's enrollment had increased to more than five thousand and the institution expanded to include the graduate divisions and the colleges of education, engineering and business administration, and a two-year branch campus at Hilo was also set up.

"When Hawaii became a state in 1959 the University of Hawaii was created as a constitutional agency under the Hawaii State Constitution. Since then, Mr. President, the University of Hawaii has experienced the massive growth that affected higher education across the nation. In the 1960's student enrollment increased as well as the Legislature's financial support for the University.

"The University of Hawaii's community colleges also augmented, representing 46 percent of the student body of the University, offers vocational and technical training to meet the needs of the state's general and pre-professional coarses in the liberal arts which may be transferred to baccalaureate degree programs and outreach programs designed to meet the career development, cultural and intellectual needs of the communities they serve.

"At this time, Mr. President, I would like to yield the floor to my fellow colleagues who will be making the proper introductions and introducing the various the provosts that are here representing the community colleges."

Senator Solomon yielded the floor to Senator Fernandes Salling who introduced Provost David tha of the Kauai Community College; Senator Koki who introduced Provost Peter Dyer of the Windward Community College; Senator Matsuura who introduced Dr. Patrick Naughton, Provost of Hilo Community College; Senator Yamasaki who introduced Provost Alma Henderson of Maui Community College; Senator McCartney, on behalf of Senator Holt, who introduced Dr. Peter Kessinger, Provost of Honolulu Community College; and Senator B. Kobayashi who introduced Dr. John Morton, Provost of Kapiolani Community College.

Senator Solomon then introduced the following: Mr. Lawrence Waku of the Employment Training Office (ETO) also celebrating their anniversary; Mrs. Gladys Brandt, chairman of the Board of Regents accompanied by Mrs. Ruth Ono; and Dr. Joyce Tsunoda, Chancellor of the Community Colleges.

All of the honorees, seated on the floor of the Senate, rose to be recognized and were presented congratulatory Senate certificates and leis.

Senator Solomon also recognized members of the administrative staff of the community colleges who were seated in the gallery.

Senator Tungpalan, on behalf of Senators Menor, Mizuguchi and herself, introduced representatives of the Pearl City High School OIA Championship Boys Soccer Team: Chad Funasaki, Lance Uyehara and David Tetsutani accompanied by coach Ron Mata (Honolulu Advertiser Soccer Coach of the Year). Coach Archie Chung of the Pearl City High Girls Soccer Team (Honolulu Advertiser Girls Soccer Coach of the Year) was also introduced.

The students and their coaches, who were seated on the floor of the Senate, rose to be recognized and were presented the congratulatory Senate certificate and leis.

Senator Tungpalan also recognized Mrs. Ron Matta who was seated in the gallery.

At 12:00 o'clock noon, the Senate stood in recess subject to the call of the Chair.

Senator B. Kobayashi spoke in support of the resolution as follows:

"Mr. President, I'd like to call the members' attention to page 3 of S.C.R. 73, S.D. 1, 'Requesting the Legislative Auditor to Evaluate the Teacher Standards Board as Proposed in Senate Bill 896, Senate Draft 1.'

"The teacher standards board has been an item of concern and controversy, both in the Department of Education and the Hawaii State Teachers Association. It is a situation in which many of our teachers presently teaching in public schools today have certification in areas other than their current area of teaching. At the same time, our schools are such that a variety of courses need be taught. It is sometimes difficult to find in one person the capability of, shall we say, teaching a Spanish language course, teaching a social studies course, and maybe even teaching a health course. Certifications in a multiple of these areas, of course, are difficult to find in any one teacher. This difficulty has lead to our current situation in which we oftentimes have uncertified teachers teaching courses ... so we have teachers teaching outside their certification area.

"This bill will attempt to start the process of a sunrise review for a lincensure program through a study by the legislative auditor which we will receive sometime prior to the 1990 legislative session. It is the expectation that during the 1990 legislative session, equipped with the auditor's study we will then proceed on with the discussion of the bill, of the merits of a teacher standards board."

"Mr. President, I rise to speak in favor of S.C.R. No. 107 and S.R. No. 104.

"The legislative auditor's management audit of the Department of Corrections and the latest critical report on the corrections system by consultants Jerry Enomoto and Patrick McManus again underscores the urgency for timely action to bring about immediate corrective action as well as longer-range improvements.

"The Senate Corrections Committee's conclusion is that the existing management of the corrections department cannot devote sufficient time or effort to develop and execute a comprehensive action plan to deal with the system's many problems. The director and his top aides are too bogged down by day-to-day operations and crisis to be able to move ahead quickly and effectively."

"Therefore, the Senate has taken the position that the corrections system needs top management help, and it needs it from someone with the authority and know-how to get things done as proposed in S.C.R. 107 and S.R. 104.

"In the Senate's version of the State budget, we are providing for \$200,000 over the next two years to support the work of a special master who would be appointed by the governor to oversee and expedite improvements to the corrections system. We will ask the House of Representatives to support these resolutions and this key appropriations provision.

"Once the special master is appointed and is given full authority by the governor to make changes, the corrections system will then be in a far better position to undergo improvements."
