

## FIFTY-SECOND DAY

Wednesday, April 12, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:41 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Lt. Stephen Smith from the Salvation Army, after which the Roll was called showing all Senators present with the exception of Senators Chang, Cobb, Holt and McMurdo who were excused.

The President announced that he had read and approved the Journal of the Fifty-First Day.

The following introductions were then made to the members of the Senate:

Senate B. Kobayashi, on behalf of Senator McMurdo, introduced a group of members of the National Association of Retired Federal Employees who were seated in the gallery with Mr. Harry Lee, past president.

Senator Crozier introduced "a good friend," Mr. Louie Larimer, a retired federal employee who has been a very active member of the Makakilo community.

Senator Ikeda introduced student "shadows" from Niu Intermediate School, Denise Arata and Diane Yasui.

Senator Nakasato introduced Laura McDanel and Dianella Forth, students from the Gifted and Talented Program of Moanalua Intermediate School who were also seated in the gallery. Senator Nakasato said, "Dianella's older brother Frank won a \$500 scholarship I offered two years ago; he is presently a sophomore at Cornell University. Dianella is following in his footsteps."

Senator Nakasato also made the following introduction:

"Mr. President, often we recognize people for their own personal achievements ... what they do and how great they are. Today, I have four very special people. These people give of themselves; help other people. In fact, their mission in life is to help other people.

"This year marks the 25th anniversary of the Hawaii Community Action Program and I have with us today four executive directors from the four major islands on the floor. From Oahu, Ms. Ruby L. Hargrave of the Honolulu Community Action Program; from Kauai, Mr. Roy T. Nishida of the Kauai Economic Opportunity Program; from Maui, Ms. Gladys C. Baisa of the Maui Economic Opportunity Program; and from the Big Island, one of the so-called 'movers' that we saw in the Advertiser a few months ago, Mr. George Yokoyama.

"In the gallery are: Mr. Walter Yim, chairman of the board, Mr. Lawrence Capellas, Mr. Timothy Albao and Ms. Kimi Lane, accompanied by Mr. Walter Choy, executive director of the Office of Community Services."

The honorees rose to be recognized and were presented the Senate certificate of recognition and leis.

At 11:48 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:53 o'clock a.m., with the President in the Chair.
