Friday, April 14, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:55 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Deacon Ernie Carldon of the Blessed Sacrament Parish, after which the Roll was called showing all Senators present with the exception of Senators Cobb, Ikeda, McMurdo and Wong who were excused.

The President announced that he had read and approved the Journal of the Fifty-Third Day.

The following introductions were made to the members of the Senate:

Senator Blair then rose to speak on the resolution as follows:

"Mr. President, I would direct the members' attention to Standing Committee Report No. 1626 (S.C.R. No. 147) and also to Standing Committee Report No. 1509 (S.C.R. No. 137). Two committees have independently come up with the same idea. S.C.R. 147 proposes that we earmark the 4 percent excise tax on health services for institutional and non-institutional long-term care services. S.C.R. 137 recommends that the same monies be earmarked for an insurance program.

"My concern, Mr. President, is not with whether or not we need to provide funds for long-term care services. That's obviously an important consideration in the overall budget. My concern is that when we earmark tax revenues we abdicate our responsibility as a legislature to look at all of the different programs before us and to rank them in their priority on an annual or biennial basis.

"Earmarking revenues is no different than setting up a special fund. If we start doing that for every beneficial purpose, we put ourselves on a slippery slope. Every ostensibly appropriate or needy group could ask us to earmark a certain source of revenue for them. We would very soon find ourselves without the flexibility to react to emerging needs of the community, because everything would be locked in concrete and the legislative prerogative to reassess needs would be lost.

"I think we all ought to be very careful in even asking for this kind of information, because we're raising expectation within the community. We are saying that earmarking is something that the Legislature is seriously looking at and I don't want to see us starting to earmark our sources of revenue to particular programs. The Legislature becomes obsolete, everything happens automatically and the political process becomes frozen in time.

"I urge that we curb our desire to do this sort of thing. It's very bad policy. Thank you."

"I introduced this resolution after attending a meeting for an organization called 'RESULTS'. I had just spent the day working hard in the Legislature and debating the issue of whether banks should be allowed to underwrite insurance. Then, I attended this meeting which previewed a film on poverty and starvation in Africa.

"The problems in Africa relating to starvation were primarily due to political selfishness. Apparently, the leaders in that part of the world are more concerned about politics than hunger, and it is unfortunate that the United States is standing and condoning this. So, the meeting really woke me up and made me realize that there are many important things going on in the world, and there is more to being an effective legislator than just worrying about whether banks should be allowed to underwrite insurance.

"I ask my colleagues to unanimously support this legislation so that we can send the message to Congress that the 15th Legislature of the State of Hawaii strongly supports the Global Poverty Reduction Act."

"Mr President, I'd like to speak in favor of S.R. No. 234 and S.C.R. No. 265 with reservations.

"Mr. President, these resolutions ask that the Fifteenth Legislature of the State of Hawaii express support for the City and County of Honolulu's mass transit system's planning program.

"Mr. President, the honorable mayor of the City and County of Honolulu has been working on the mass transit system for the longest time. In the last few years he has taken trips around the world ... his staff, taken them to Canada, to different parts of the Mainland, also even to France. After all that work, the mayor and his administration have not gotten anywhere.

"The community is in an uproar. Every time I go to any function, constituents or people in general ask me 'what's happening in mass transit?' And I constantly have to remind them that it's the mayor's program. The Legislature is waiting for the mayor to present something to us so that we can help him. I am one of the strongest supporters of mass transit. But, the mayor took the lead on this and for the last at least four years he's made no progress. Now, he's coming before us, asking us to support his program.

"Mr. President, I feel very uncomfortable about this because for the older members of the Legislature, I'm sure you folks can remember when the mayor used to say that he didn't want the stadium, no way was he going to build the stadium. Finally, Governor Burns took over and he built the stadium. And once the stadium was built the mayor jumped in and says, 'What the heck is the state doing the stadium for. That's our responsibility.'

"I feel uncomfortable that the good mayor is setting the Legislature up again. He's using the Legislture's train to get his derailed mass transit back on track and move it on down the line.

"Mr. President and members of the Senate, I ask you to be very careful on how the mayor deals with this issue."
