FIFTY-SIXTH DAY

Tuesday, April 18, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:38 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Lt. Richard Yagesh from the Office of the Chaplain, Naval Station, Pearl Harbor, after which the Roll was called showing all Senators present with the exception of Senator Cobb who was excused.

The President announced that he had read and approved the Journal of the Fifty-Fifth Day.

The following introductions were made to the members of the Senate:

Senator Solomon introduced Mr. Adi W. Kohler as follows:

"It's a privilege for me, Mr. President, to introduce to this honorable body Adi W. Kohler, general manager of Mauna Kea Beach Hotel. Adi Kohler is the general manager of the Mauna Kea Beach Hotel on the Island of Hawaii, Kohala Coast, and is a 16-year veteran of Hawaii's visitor industry.

"Recently he has been honored as 'America's Resort Executive of the Year' by the prestigious American Hotel & Motel Association and is the first Hawaii hotelier ever to receive this distinguished award.

"Adi Kohler has served two consecutive terms on the board of Hawaii Visitors Bureau and the Advisory Committee of the University of Hawaii Travel Industry Management School. He also has helped to raise nearly \$1 million in charitable community contributions through his involvement in the annual Visitor Industry Charity Walk. He has supported the Hawaii Hotel Association's school involvement program by having Mauna Kea Beach Hotel adopt Kohala High School.

"Not only that, Mr. President, that if we refer to the Senate certificate that we will be presenting to Mr. Adi Kohler today, I feel that the 'whereas' clause that is closest to my heart is the last 'whereas' clause where it states that 'Adi Kohler, though not a native son, has adopted Hawaii as his home for his family and has devoted personal as well as professional time to helping his community benefit from the growth of the visitor industry throughout the sixteen years that he and his wife and family have lived in Waimea on the Big Island.'

"Mr. President, at this time I'd like to introduce Mr. Adi Kohler."

Mr. Kohler rose to be recognized and was presented the congratulatory Senate certificate and lei.

Senator Tungpalan then made the following introduction:

"Mr. President, on behalf of Senators Mizuguchi and Menor, it gives me great pleasure to present to this honorable body this year's Hawaii's Spelling Bee Champion Kaly Higa. Kaly is an 8th grader at Highlands Intermediate School and won the spelling bee at the end of the ninth round by successfully spelling words like dasyphyllous, macrurous which to me sounds like some kind of contagious disease. I'm told that macrurous means having a long tail. "Kaly will represent Hawaii at the Scripps-Howard National Spelling Bee on May 31st through June 1st in Washington, D.C. We all recognize how far away Washington, D.C., is from Hawaii and we certainly would like Kaly to know that we in Hawaii support her and wish her the very best. So I would like to present Kaly with this special care bear, filled with love and Aloha, and you can hold it and hug it as you go up to spell those other difficult words.

"Congratulations, Kaly."

The honoree rose to be recognized and was presented the congratulatory Senate certificate, the gift and lei. Kaly Higa was accompanied by her mother Floreine Higa, school principal Mrs. Rhoda Hirokawa and teachers.

Senator Tungpalan also introduced Mrs. Vivian Kaneko as follows:

"Mr. President, it is also my privilege to introduce Mrs. Vivian Kaneko who was recently recognized as the Leeward District Teacher of the Year. Mrs. Kaneko has successfully coached three of the last four state spelling bee champions since the spelling bee was re-established in 1986. She's also coached my son who's one of the worst spellers in the state.

"That is certainly a tremendous accomplishment, Mrs. Kaneko, and we congratulate you and wish you continued success."

Mrs. Kaneko rose to be recognized and was presented the congratulatory Senate certificate and lei.

Senator Tungpalan continued:

"Mr. President, it is also my pleasure to introduce a good friend of mine, Mrs. Leona Yamatsuka, who's grown up with me since childhood. We went to Girl Scouts together and believe it or not, we still continue our friendship on the baseball field. Leona is the Palisades president of the Little League and she is also a successful spelling coach and has assisted Mrs. Kaneko in achieving two state champions. She's told me about the extraordinary commitment that a teacher has to have in the effort to support her students. She's provided that love and nurturing and we want to thank you Mrs. Yamatsuka for that."

Mrs. Yamatsuka also rose to be recognized, and was presented the congratulatory Senate certificate and lei.

Senator Holt then added:

"Mr. President, I'd just like to make a follow-up comment on the first introduction regarding Mr. Kohler. As most of us know, he is the one who through Mauna Kea Hotel has set the standard for the hotel industry. And we can be thankful for him for that and if the rest of the industry can follow his lead Hawaii will be in good shape for years to come."

Senator Crozier introduced Lyle Galdeira as follows:

"During the course of the session, I have introduced several very attractive news commentators to the members and I was accused of being a male chauvinist in only selecting beautiful people. Today, I would like to show that I am not a person that judges a person only by beauty. I would like to introduce someone who is a news commentator with Channel 9. He used to work out of Portland, Oregon, at KGW-TV station and he was known

as Lyle Author. Now that he has come back to Hawaii, he's come back to his regular name Lyle Galdeira."

The Chair then introduced a group of students from Lutheran High School who were seated in the gallery.

At 11:50 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
