

## FIFTY-NINTH DAY

Friday, April 21, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:40 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Father Bob O'Donnell of St. Anthony Parish, Kailua, after which the Roll was called showing all Senators present with the exception of Senator Cobb who was excused.

The President announced that he had read and approved the Journal of the Fifty-Eighth Day.

The following introductions were made to the members of the Senate:

Senator Crozier introduced Margie Andrews as follows:

"Mr. President, the quest for the record continues.

"Mr. President, I've been quite fortunate to have a young lady monitor my Committee on Housing and Hawaiian Programs. She is a student at the University of Hawaii; she is a student taking classes in anthropology and political science. What makes it so unique is that my daughter graduates from college this year with a degree in anthropology, and there are no jobs available in anthropology. My new friend and my daughter will be competing for the non-existent job.

"She's going to write a paper on the people of Hawaii and her term paper will be based on the activities of the Legislature, focusing on our committee. I hope when she does have that term paper she let's us have a copy of it, and we can read it and I hope also that she gets an 'A' and be very critical when you make that paper, but also be sensitive and compassionate.

"Mr. President, I'd like to introduce Margie Andrews from the University of Hawaii."

Senator Tungpalan then made the following introduction:

"Each year for the past 12 years the YWCA has honored exceptional women with awards recognizing their outstanding achievements and contributions to our community and state. Individual awards have been given in the following categories: workplace, community service, trailblazer, communication and arts, professions and youth achievement.

"An organization award and an enrichment award are also given in recognition of an organization, group or individual's commitment to the advancement of women and to the enrichment of the community.

"It gives me great pleasure to introduce exceptional women and organizations who are this year's award winners. These awardees will be recognized at LeaderLuncheon XII, scheduled for next Wednesday, April 26th, at the Hilton Hawaiian Village Coral Ballroom.

"The awards were given as follows:

For outstanding achievement in the workplace, Ms. Penny Bradley, president and CEO of Bradley Properties. Since Penny is on the Mainland, representing Penny today is her daughter Tracy Bradley.

For outstanding achievement in community service, Ms. Amy Agbayani, who has served tirelessly as an advocate for Hawaii's women and minorities through her leadership and commitment.

For outstanding achievement as trailblazer, Ms. Marye Deming, administrator of the Maui Community Correctional Center and the first woman warden in the history of Hawaii.

For outstanding achievement in communication and arts, Hawaii's talented musician and beloved composer who has enriched our lives with her many compositions, Ms. Irmgard Farden Aluli.

For outstanding achievement in the professions, Ms. Ines Viernes Cayaban, who has dedicated her life to public service as a nurse, educator, friend and trailblazer to women of Filipino ancestry.

For outstanding youth achievement, Ms. Lisa Hashimoto, an exemplary student and class president at Mililani High. Lisa was unable to attend today but we wanted to congratulate her.

The 1989 recipient of the organization award given to an organization which has demonstrated genuine commitment to the advancement of women in the workplace is Hawaii Pacific College. Representing Hawaii Pacific College is associate vice president Dr. Hellen Chapin. Welcome and Congratulations.

And finally, but not least, the 1989 recipient of the enrichment award for their leadership and commitment to improving the lives of women, we welcome and congratulate the Hawaii Women Lawyers. Representing the Hawaii Women Lawyers is their president, Ms. Ellen Carson.

"Accompanying this exceptional group of women is a woman who's also exceptional in her own right; she is none other than Betty Tatum, chairman of the Steering Committee for LeaderLuncheon XII, and Sandra Lacar, president of the YWCA Board of Directors.

"We also acknowledge the help and untiring efforts of Christina Kemmer, Director of YWCA Fund Development, and some of the women who have made this year's luncheon a reality. We thank you for your hard work and commitment to acknowledging the important role of women in our community and their accomplishments."

All of the honorees rose to be recognized and were presented the congratulatory Senate certificate and leis.
