## Tuesday, April 25, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:18 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Father James Furman of St. Peter Episcopal Church, after which the Roll was called showing all Senators present with the exception of Senators Chang, Cobb, Fernandes Salling, Holt and Solomon who were excused.

The President announced that he had read and approved the Journal of the Sixtieth Day.

The following introductions were made to the members of the Senate:

Senator McCartney introduced Bob Kim as follows:

"I'd like to introduce a friend sitting in the audience who used to work with me when I worked here and we both worked for the dissidents. I'd like to introduce a good friend of mine, Mr. Bob Kim."

Senator Crozier introduced Andy Yamaguchi as follows:

"Mr. President, on behalf of all of my colleagues who cheered me on to try and attempt to break a record, I want to take this opportunity to introduce someone who helped me define what a record is. Yesterday I tied Ike Sutton's record. Today I broke his record, and possibly we broke it so that no one can ever break the record.

"Mr. President, what is so unique about this record is that it may never be broken, and there's only one other record, in sports anyway, that may never be broken and that record was set in 1938 by Johnny Vandemeer, and for you baseball buffs, you know he played for Cincinnati. What he had done, he had pitched two consecutive nohitters. Now, that's quite a feat and for us to make an introduction every day, 1 don't know if that's a feat, but we did it.

"At this time, I'd like to introduce a man who helped me dig up this information. He works here at the Capitol, not as a lobbyist or as a staff person, but as reporter. Anytime you folks want to know anything about anybody or anything, just check with this gentleman because he is a wealth of knowledge, especially in the sports background because he used to be the premier writer for the Honolulu Advertiser and after seeing his articles, the editor figured out his talents were either being wasted in the sports department or the sports department needed more talent there so they farmed him out to the legislative arm of the Advertiser.

"I'd like to introduce Mr. Andy Yamaguchi."

On motion by Senator Blair, seconded by Senator Reed and carried, Conf. Com. Rep. No. 13 was adopted and H.B. No. 435, H.D. 1, S.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO MOTOR VEHICLES," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:

Conf. Com. Rep. No. 28 (S.B. No. 83, S.D. 1, H.D. 1, C.D. 1):

Senator Levin moved that Conf. Com. Rep. No. 28 be adopted and S.B. No. 83, S.D. 1, H.D. 1, C.D. 1, having been read throughout, pass Final Reading, seconded by Senator Reed.

Senator Blair then made the following remarks:

"Mr. President, I rise to speak against this bill. I note that we have adopted Conference Committee Report Nos. 31 and 91, with respect to other health initiatives, and I feel we should be giving priority to these local programs. Until those matters are fully funded to meet the needs of our own citizens, we ought not to expand the scope of our activities."

The motion was put by the Chair and carried, and Conf. Com. Rep. No. 28 was adopted and S.B. No. 83, S.D. 1, H.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO HEALTH," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:

Ayes, 15. Noes, 4 (Blair, Ikeda, Matsuura, Reed). Excused, 6 (Chang, Cobb, Fernandes Salling, Holt, Menor, Solomon).

Conf. Com. Rep. No. 29 (S.B. No. 1360, S.D. 1, H.D. 1, C.D. 1):

On motion by Senator Blair, seconded by Senator Reed and carried, Conf. Com. Rep. No. 29 was adopted and S.B. No. 1360, S.D. 1, H.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO HOUSING," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:

Ayes, 19. Noes, none. Excused, 6 (Chang, Cobb, Fernandes Salling, Holt, Menor, Solomon).

Conf. Com. Rep. No. 57 (H.B. No. 1902, H.D. 1, S.D. 1, C.D. 1):

By unanimous consent, action on Conf. Com. Rep. No. 29 and H.B. No. 1902, H.D. 1, S.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO COASTAL ZONE MANAGEMENT," was deferred until Wednesday, April 26, 1989.

Conf. Com. Rep. No. 63 (S.B. No. 1344, S.D. 1, H.D. 1, C.D. 1):

Senator Blair moved that Conf. Com. Rep. No. 63 be adopted and S.B. No. 1344, S.D. 1, H.D. 1, C.D. 1, having been read throughout, pass Final Reading, seconded by Senator Reed.

Senator Ikeda rose to speak in favor of this bill.

"Mr. President, yesterday we voted on this bill and then reconsidered the action taken when the chairman of the House committee managing the bill cast a cloud of doubt on the legitimacy of both this bill and S.B. No. 667, because both bills lacked proper public hearing, according to him.

"As I indicated yesterday, both S.B. Nos. 667 and 1344 were treated in the same way in that final amendments to both bills were not discussed over the table. At the last conference meeting held on these measures no agreement could have been reached on S.B. No 1344 since I, as the chair of the Senate committee, had not even decided what those proposed amendments would be. Although I did propose some language changes to the bill at our initial conference meeting, those changes were rejected by the House conferees at that time. I might add that the draft before you contains those previously rejected amendments.

"I guess Mr. Andrews, or Representative Andrews can afford to sign blank checks since agreements apparently mean nothing to him since he cavalierly breaks them as fast as he makes them. Except for the fact that the public will now be denied a public hearing prior to the conversion of land into natural area reserves and that that process will also lack legislative oversight, S.B. No. 667 contains nothing that we can't live without. The issue can be taken up again next year. And certainly the same can be said of S.B. No. 1344, except for the fact that by doing so, we lose the chance to be the first state in the nation to adopt this concept into law.

"One might argue that this should not be the overriding reason for passing this bill, and he would be correct. However, many people including this chairperson and my staff have worked hard on this legislation. While it is by no means perfect, it does represent a fair position and one which is certain to be modified in the future. It also makes a statement and that is that we care about what is happening to our environment and that we are willing to do something about it.

"I disagree with Representative Andrew's statement in this morning's newspaper that this bill is not significant. The bill and the committee reports are correct and in good order so the only compelling reason to suggest recommitting this bill is the question of whether or not another public hearing was required.

"Representative Andrews was asked to go through this formality and refused. As the Senate chairperson I contend that another public hearing was not required. The recess of the conference committee was called on Thursday afternoon, at the request of the House chairman, and it was also left subject to the call of that chair.

"We then received the memorandum of agreement which I read to this body yesterday, Mr. President, late Friday evening and followed its instructions to the letter. If Representative Andrews felt that another hearing was required he certainly did not request one nor did he convene one.

"I guess what I'm getting at, Mr. President, is that if a cloud exists it does so only because of the capricious acts of one individual who lacks integrity and whose ego is totally out of whack. I don't happen to feel that that is reason enough to deny the people of this state landmark legislation. Nor do I feel that such behavior should be given credence by recommitting this bill. It is my contention that no matter how legitimate the process, a person who does not keep his word will still find an excuse to not honor his commitment.

"Mr. President, we were elected to do a job for the people of this state. You and I and the rest of our colleagues have tried to do so to the best of our ability. I don't think that we should let the acts of one individual

who is apparently forgotten why he was elected to stop us from doing that job. Therefore, Mr. President, I ask you and my colleagues to support the passage of this bill. Thank you."

Senator McMurdo then responded:

"Mr. President, I would like to say that I am profoundly grateful to the Senator who has chaired the Agriculture Committee for giving this bill the boost so that it can pass so that we can show that Hawaii is really concerned about the future."

The motion was put to the Chair and carried, and Conf. Com. Rep. No. 63 was adopted and S.B. No. 1344, S.D. 1, H.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO OZONE DEPLETION AND GLOBAL WARMING," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:
