Senator McCartney rose to speak on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Yesterday, when the Governor gave his state of the state message I was very delighted and happy that he took a position on the He'eia Uli wetlands. I would like to commend the Governor on taking such a strong position in preserving and protecting this vital natural resource.

"As you know, Mr. President, the He'eia Uli wetlands are a very important piece of property for Windward

Oahu. It really is the buffer zone between rural Oahu and urban Oahu and once those wetlands are developed the rest of Windward Oahu goes. That is why our community feels very strongly that that piece of property needs to be preserved and protected.

"What I would like to see happen is something where all the parties involved -- the landowner, the public, the state -- can all win and that is in a land exchange. I think it would be good public policy for us to implement a land exchange because it won't cost taxpayers any money out of the general fund and it will also provide relief to the landowner and will also provide a public benefit to the community and to the state. So, the point I'm making, Mr. President, is that the wetlands need to be preserved and protected and we're very pleased that the Governor took the initiative to take such a bold and strong position.

"The benefit is that this natural resource can be enjoyed by future generations to come.

"Thank you, Mr. President."
