

## NINETEENTH DAY

Wednesday, February 14, 1990

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1990, convened at 11:35 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Lieutenant Lani Abella, Salvation Army, after which the Roll was called showing all Senators present with the exception of Senator Nakasato who was excused.

The President announced that he had read and approved the Journal of the Eighteenth Day.

Senator Menor welcomed and introduced the 1990 Teacher of the Year Alice Kotake to the members of the Senate as follows:

"Mr. President, it gives me great pleasure to introduce to this distinguished body Alice Yukiko Kotake, who happens to be not only the pride of Mililani but she was selected by the Department of Education as the 1990 Teacher of the Year for the State of Hawaii.

"The Legislature has been focusing a great deal on the issue of education and we've given that issue a high priority, and much discussion has occurred in this legislative body about the importance of education and the need for educational reform within our public school system. And as legislators who recognize the importance of education in Hawaii, I think all of us would agree that the foundation of a quality education is our hardworking and dedicated teachers to provide the kind of quality instruction that our young people need here in our state.

"In that respect, I think, that it is only fitting that we are taking the opportunity today as a legislative body to honor and recognize Alice Yukiko Kotake for achieving the highest distinction as a public school teacher in Hawaii by being selected by the Department of Education as the 1990 Teacher of the Year.

"Ms. Kotake mentioned to me that if this body, and in particular Senator Kobayashi, really wants to express appreciation to her for her selection as the 1990 Teacher of the Year then we can appropriate funds for a new ten-classroom building for Mililani High School to accommodate the increase in enrollment in our school. So, Senator Kobayashi, please bear that in mind.

"At this time, it gives me great pleasure to introduce to you Alice Yukiko Kotake, our Teacher of the Year for 1990. She's also here with our esteemed principal of Mililani High School, Mr. Byron Yoshina."

Ms. Kotake, together with Mr. Yoshina, rose to be recognized and was presented the congratulatory Senate certificate by Senator Menor. Senator Hagino presented her with a lei.

At 11:41 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:45 o'clock a.m.
