Tuesday, March 13, 1990

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1990, convened at 11:38 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by the Reverend David Lehmborg, First United Methodist Church, after which the Roll was called showing all Senators present with the exception of Senators Holt, Koki and Matsuura who were excused.

The President announced that he had read and approved the Journal of the Twenty-Ninth Day.

Senator Chang then introduced to the members of the Senate Ms. Sara Tompkison as follows:

"Mr. President, the National Voter Slogan Contest is an effective means through which citizen-awareness of the importance of voting in our society is promoted. The 1989 Hawaii Voter Slogan Contest generated keen interest and competition. From over 9,000 entries, one slogan was selected as a Hawaii winner.

"On August 18, 1989, Sara Tompkison's slogan: 'The Freedom to Choose is Yours to Use -- Vote in 1990,' was chosen as the first place winner in the adult division. Ms. Tompkison's slogan placed fourth overall in the National Voter Slogan Contest.

"This morning, I would like to introduce Sara Tompkison and extend the Senate's warmest congratulations to Sara Tompkison for her accomplishments in both the local and national voter slogan contests, and our commendation to her for her important and direct role in encouraging citizens to vote."

The honoree, who was seated on the floor of the Senate, rose to be recognized and was presented the congratulatory Senate certificate and lei by Senator Chang.

At 11:43 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
