The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1990, convened at 11:35 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by The Right Reverend Monsignor William Spain, Holy Trinity Parish, after which the Roll was called showing all Senators present with the exception of Senator Koki who was excused.

The President announced that he had read and approved the Journal of the Thirty-Second Day.

The following introductions were then made to the members of the Senate:

Senator Fernandes Salling introduced Kauai County Council Chairperson Maxine Correa and husband Jerry who were seated in the gallery.

Senator Hagino introduced a group of students, seated in the gallery, from the Wahiawa Store Front Program, an alternative learning school, and their teachers, Shelly Kunihisa, John Morikawa, Wendy Hamane and Collette Toma.

Senator Tungpalan introduced Ms. Nora Saito, a friend and campaign worker, who was also seated in the gallery.

Senator Aki, on behalf of the Senate President, introduced representatives of the Kiwanis Club, who were seated on the floor of the Senate, as follows:

"Mr. President, this morning we extend our aloha and welcome to Robert E. Wikoff, governor of Kiwanis International, California-Hawaii-Nevada District.

"As district governor, Robert E. Wikoff has distinguished himself as a true leader, epitomizing the Kiwanis philosophy of public service and humanitarian works.

"We welcome him to Hawaii and congratulate him for his outstanding contributions to Kiwanis International.

"We also extend our aloha and best wishes to Robert and Barbara Wikoff on the occasion of their visit to Hawaii. We hope their visit will be an enjoyable one and that they will help to spread the message of Kiwanis International during their stay.

"Mr. President, at this time, may I present Mr. Robert E. Wikoff and his wife Barbara, who are accompanied by the lieutenant governor of the 22nd division (Hawaii) of Kiwanis International Mrs. Jacqueline R. Maly and husband Theodore."

The honoree, Mrs. Wikoff and Mr. and Mrs. Maly rose to be recognized. Mr. Wikoff was presented the congratulatory Senate certificate and lei.

Senator Aki also recognized a group of members of Kiwanis International who were seated in the gallery.

Senator Ikeda, on behalf of Senator Crozier, then introduced a group of 135 fourth grade students from Waipahu Elementary School and their teachers, Mrs. Sharon Morisawa, Ms. Nora Saito, Ms. Claire Nakagawa, Mr. Hidemi Tsutsui, Mrs. Agnes Sugiyama and Mr. Tad Iwami who were seated in the gallery.

Senator Chang, in honor of St. Patrick's Day, then introduced and announced the appearance of the Senate's St. "Paddy" -- Senator Crozier. (Senator Crozier was attired in green with a shillelagh in hand.) (Applause and laughter.)

At this time, Senator McCartney introduced Dr. Robert E. Gibson, seated on the floor of the Senate, as follows:

"Mr. President, it gives me great pleasure to introduce a man who was an inspiration to me and an inspiration to many of us here. He is a great man. He is a role model to many of us; a role model to our community. He is a people's advocate who has been working hard on behalf of the people of the Pacific and on behalf of Hawaii for many, many years, and that gentleman is here with us today on the floor.

"Mr. President, the Senate certificate to Dr. Robert Gibson reads:

'Whereas, Dr. Robert E. Gibson has dedicated his life to the service of his fellow man; and

'Whereas, he has achieved a distinguished career in international education, having served as a member of the California school system, as director of the education program for Japanese-American internees during World War II, as educational adviser to the U.S. occupation forces in postwar Korea, and as the first civilian director of education in the U.S. Trust Territory of the Pacific Islands; and

'Whereas, during the more than two decades since his retirement from government system, Dr. Gibson has been actively involved in community service unselfishly giving his time and energy to worthy causes; and

'Whereas, Dr. Gibson has always been a strong advocate of citizen participation and involvement in government affairs; and

'Whereas, in recognition of his many important contributions to our community, Dr. Gibson was one of the first recipients of the Jefferson Award given to volunteer service; he has also received the Hawaii Bar Association Award for his efforts on behalf of Hawaii's senior citizens; and

'Whereas, at the golden age of 92, he remains a vital and active member of our community, serving on the Waimanalo community's Education Task Force (the Waimanalo Neighborhood Board and these are positions that he's held for many, many years); and

'Be It Resolved that the Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1990, acknowledge Dr. Gibson's valuable service for the past forty years and hereby extend its sincere appreciation and mahalo for his tireless efforts and long-standing community service to the people of Hawaii and the Pacific.'

"Ladies and gentlemen, members of the Senate, I'd like to present to you an inspiration to all of us, Dr. Robert E. Gibson, and his wife Ida. We thank you very much, Dr. Gibson, for being here today. It is really a special moment for me and for all of us."

Dr. Gibson and his wife Ida rose to be recognized and were presented the congratulatory Senate certificate and leis

Senator McCartney also introduced Dr. and Mrs. Leonard Mason, seated in the gallery, who accompanied the Gibsons to the Senate.

Senator Cobb then added:

"Mr. President, if people in the audience or on the floor ever wondered where the term 'grey panther' came from, they need look no further than Doc Gibson. Doc, it's a pleasure having you here with us. Thank you."

At 11:48 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
