#### FORTY-SEVENTH DAY

#### Friday, April 6, 1990

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1990, convened at 12:00 o'clock noon with the Vice President in the Chair.

The Divine Blessing was invoked by Father Robert O'Donnell, Holy Trinity Parish, after which the Roll was called showing all Senators present with the exception of Senator Nakasato who was excused.

The President announced that he had read and approved the Journal of the Forty-Sixth Day.

The following introductions were then made to the members of the Senate:

Senator Yamasaki then introduced the delegation from the Fukuoka Prefectural Government, seated on the floor of the Senate, as follows:

"Mr. President, it is certainly a privilege for me, on behalf of the Senate, to introduce a group of legislators and staff members of the Fukuoka Prefectural Government from our sister-state of Fukuoka.

"Hawaii and Fukuoka have had an enjoyable sisterstate relationship since 1981. Our visitors are here to pay a courtesy call and to help plan with us a commemorative event in 1991 for the tenth year anniversary of our sisterstate relationship.

"Mr. President, I am pleased to introduce:

Senator Kosuke Yamanaka, leading the Fukuoka delegation, is the vice speaker of the Fukuoka Assembly who has been a legislator longer than 10 years;

Senator Hisaya Tanaka, another veteran legislator who has served as speaker of the legislature and as chairman of the Fukuoka/Hawaii sister-state committee; and

Senators Keitei Egashira, Yuzuru Matsuyama, Shozo Kuroiwa, Shigeyuki Matsunaga, Kusao Kubo and Shunji Wakasa.

"Accompanying the members of the Fukuoka Assembly are:

Mr. Toshifumi Kobayashi, deputy director general of the Department of Planning and Promotions; Mr. Takei Yamasaki, secretary of the Assembly; and Mr. Daishiro Matsunaga, staff specialist, International Division of the Department of Promotion and Planning; and Mr. Masaru Tanaka, son of Senator Tanaka."

All of the gentlemen rose to be recognized and were presented leis by various Senators.

Senator Yamasaki also introduced Mr. Masatoshi Yumioka, tour director of the Fukuoka delegation, who was seated in the gallery.

Senator Matsuura then recognized and introduced Mrs. Kiyo Miyamoto, "mother of the Ways and Means staff," who was also seated in the gallery.

At 12:07 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

Senator Reed rose to speak on a point of personal privilege as follows:

"Mr. President, I'd like to offer a very brief update on the Pacific Whale Foundation, and the reason I do so is because your Committee on Energy and Natural Resources is considering a hearing where we would ask Pacific Whale Foundation's founder, Greg Kaufman, to come and answer questions that would be offered by this body. Therefore, we need to know the character of the person we plan to question.

"When I spoke to this body last week, I prefaced my remarks by saying that I had spoken to Greg Kaufman the day before and had spent an hour or so on the phone with him going over each of the allegations before I went public with them. In this week's Lahaina News on the front page, which I obtained yesterday, Kaufman denies all the allegations and, tellingly, denies ever having spoken with me.

"The article says, 'Kaufman said Reed did not call him before making his charges last week on the State Senate floor.... Kaufman says, Reed never bothered to even call me.'

"What Kaufman doesn't know is that I taped the conversation. So this is an hour of conversation between me and Greg Kaufman which he says didn't happen. He just says ...."

Senator Blair interjected and requested a brief recess.

At 12:18 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:19 o'clock p.m.

Senator Reed then continued:

"Mr. President, in this state, if two people are having a phone conversation, one person can tape, legally, without telling the other person that he is taping. If you are a third party, if, for instance, Senator Blair had been listening in on my conversation with Greg Kaufman and unbeknownst to me and Kaufman, he taped, that would have been illegal. But for one party in a two-party conversation to tape is perfectly legal.

"So, what I have here is an hour-long, legally taped conversation with Greg Kaufman which he says did not exist. Therefore, I think that we now have an even better indication of the character of the man who is denying all the allegations that I offered to this body last week.

"Thank you, Mr. President, and thank you, Senator Blair."

Senator Blair also rose to speak on a point of personal privilege and said:

"Mr. President, I'm happy for the sake of the previous speaker that Hawaii is a 'one-party consent' state. However, I wonder if this is a common practice of the

Senator and whether or not he is the Richard Nixon of the State Senate. Are all of his telephone conversations with all of his colleagues, since he first arrived here four years ago, are also on tape? Will he yield to that question?"

The Chair posed the question to Senator Reed and he responded:

"Mr. President, it's a very good question. I can only say that I have taped only important conversations." (Laughter.)

Senator Blair then said:

"Mr. President, I'm very relieved to hear that."

At 12:21 o'clock p.m., on motion by Senator Blair, seconded by Senator Reed and carried, the Senate stood in recess until 9:00 o'clock p.m.
