Later, there's a correction to that front page article printed on an inside page and the correction (held up article of correction) you can hardly see it from where you're sitting. It's right over here and it reads: '... a judgment for matter of The correction says that he was not fired because of his violation of the state whistleblower law. The correction is relatively small. You'll never find it if you weren't really looking for it.

"I hope someday this 'ma'ke-die-dead' bill will rise again like the 'unagi' bill. Thank you."
