Thursday, April 2, 1992

The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1992, convened at 11:39 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Daiva Dasa, ISKCON Hawaii, Inc., Hara Krishna, after which the Roll was called showing all Senators present with the exception of Senator Koki who was excused.

The President announced that he had read and approved the Journal of the Forty-Fourth Day.

The following introductions were then made to the members of the Senate:

Senator Iwase introduced the Honolulu Japanese Junior Chamber of Commerce 40th Annual Cherry Blossom Festival queen and her court as follows:

"Mr. President, this past Saturday the Honolulu Japanese Junior Chamber of Commerce held its 40th Annual Cherry Blossom Festival Queen Pageant. This year's theme for the festival is, 'For the Sake of the Children' ('Kodomo no Tame Ni'). I would try to pronounce it in Japanese but I think Senator Yamasaki might laugh at me. The theme itself reminds us all and reaffirms our commitment to the children of Hawaii.

"Mr. President, in this time of rising tensions between the United States and Japan, this year's Cherry Blossom court along with the 1992 Nisei Week Japanese Festival queen and her court from Los Angeles, like Kristi Yamaguchi, has the opportunity to be a bridge of friendship between our two countries and between our cultures, and I would like to wish them well. This year's Cherry Blossom queen and her court are:

"Queen Lesli Lynn Yoshida, who is from my Senatorial district. Lesli is a 1984 graduate of Mililani High School. Lesli's diverse interests include traveling, working with children, meeting new people, jogging and bicycling. Her parents are Patricia and Hugh Yoshida, and I'm sure Mr. Yoshida is known to many of us -- he being the legendary football coach from Leilehua and presently with the University of Hawaii;

"Princess Tracy Eiko Omori, who worked for the Senate Ways and Means Committee and who, I understand, is a great admirer of Senator Mike McCartney. That admiration was clearly demonstrated in my office when I mentioned his name. I think she's still recovering. Her parents are Susan Omori and the late Edward Omori. Tracy is a graduate of Pearl City High School;

"Attendant Amy Misao Imamura, who is a 1987 graduate of Pearl City High School. Her parents are May Iwamura and the late Ronald Imamura;

"Attendant Wendy Shigeko Shintani, who is also a graduate of Pearl City High School, 1986. Her parents are Jim and Jane Shintani;

"Attendant Ann Shoko Tomatani, who is a 1985 graduate of McKinley High School. Her parents are Fushio and Kakuko Tomatani.

"Miss Congeniality, Pamela Leiko Hashimoto, who is a 1985 graduate of Kaiser High School. Her parents are Jane Hashimoto and the late Paul Hashimoto.

"Mr. President, I would also like to introduce Mrs. Lenny Yajima Andrews who was the 34th Cherry Blossom Festival Queen and the general chairman of this year's Cherry Blossom Festival, which I understand was a great success."

Queen Lesli, her court and Mrs. Andrews rose to be recognized and were presented congratulatory Senate certificates and leis by President Wong, Senators Iwase, Cobb, Crozier, Hagino, B. Kobayashi and Mizuguchi.

Senator McCartney then introduced the 1992 Nisei Week Japanese Festival queen and her court of Los Angeles, California, as follows:

"Mr. President, ladies and gentlemen of the Senate, it is an honor to introduce to you the 1992 Nisei Week Japanese Festival queen and her court. We are very grateful to have them here today.

"I would like to introduce Queen Mutsuko Suzanne Sata. Mutsuko is 22 years of age and is the daughter of Marian and Frank Sata. Her hobbies include being an accomplished hunter/jumper equestrian, skiing, ballroom dancing, traveling, fitness, and visiting fine arts museums. Her ambition is to obtain a juris doctorate in law and eventually establishing a career in the public sector where she could serve the diverse demands of the community.

"We also have with us today, Miss Tomodachi, Cherie Aiko Oshiro, Princess Alice Tomomi Akahoshi, Princess Saori Clara Fujikawa, and Princess Shannon Tori Suzuki.

"Thank you for coming to the Senate today."

Queen Mutsuko and her court rose to be recognized and were presented congratulatory Senate certificates and leis by Senators McCartney, Aki, Blair, Chang and Levin.

Senator Holt then said:

"Mr. President, I would be remiss if I did not mention that the chairman of the 40th Cherry Blossom Festival, Lenny Yajima, was a fellow classmate at Harvard. More importantly, Lenny is the granddaughter of former Senator Steere Noda, who was a great Asahi baseball player."

The President, at this time, invited 1992 Cherry Blossom Festival Queen Lesli Lynn Yoshida to the rostrum to 'share a few thoughts' with the members of the Senate.

Queen Lesli addressed the members of the Senate as follows:

"Thank you very much, Mr. President.

"I would just like to say that I'm still really in shock to be given this honor. When my name was called (the night of the pageant) I couldn't believe it. I had to ask Pam Hashimoto, who is Miss Congeniality, if she would pinch me because I really thought it was a dream -- it sounds kind of corny but that's what really happened.

"I would like to thank you for inviting us here today and for honoring us. I really look forward to this year and so does the Cherry Blossom court. I also look forward to the challenges ahead of us. "We will do our best to represent the State of Hawaii, the Japanese community, and the Honolulu Japanese Junior Chamber of Commerce. Thank you very much."

At 11:52 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

At this time, the Chair made the following observation:

"Members of the Senate, before adjourning, I'd like to say a few words not as a matter of personal privilege but on a matter of policy in the Senate.

"We have been receiving calls from the general public with reference to travel. First, I want to make it very clear, for the record that as President of the Senate I have always encouraged travel. I wish more Senators would take advantage of it. I think the experience is a good one. I think fellowship with other legislators, getting information from other jurisdictions and understanding their kinds of situation is important for Hawaii.

"Second, as far as mode of transportation, as President, I have always stated that Senators are entitled to travel first class. That is to say they are authorized to do so. That policy has not changed. Contrary to what may have been said around this building, the policy remains the same.

"Third, with reference to approval of travel, that is the sole responsibility of the President of the Senate. He approves all amounts, per diem and transportation costs. I want to make that very clear.

"We have been trying to deal with the calls to my office as best as we can to explain this to the general public.

"Most importantly, sometime this afternoon you will be receiving a memo from the President's office which is based on a situation which I think is real and which is related to the state budget. The memo is very simple. It makes no mention of any change of policy on being entitled to a first-class ticket to travel, but it does state that since we are asking departments and other agencies to cut their budgets then we should have to seriously look at cutting our own. We in the Senate should not be immune to the fiscal constraints that other state agencies are feeling. For that reason, the memo states that out-ofstate travel for the Senate is being suspended while we determine where internal cost savings can be made. want this to be part of the record and, more importantly, again, my apologies to the general public, we will try to get the message out as quickly as we possibly can, but perhaps the media can get this message out for us."
