The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1992, convened at 11:43 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Lieutenant Colonel Donald Taylor, Chaplain, Schofield Barracks Chapel Center, after which the Roll was called showing all Senators present with the exception of Senators Chang and Mizuguchi who were excused.

The Chair announced that he had read and approved the Journal of the Fifty-Fourth Day.

The following introduction was then made to the members of the Senate:

Senator Matsuura introduced Gabriella Ahmadia, student, Waiakeawaena School, Hilo, as follows:

"Mr. President, this morning, I am very proud to introduce to this body the national first place winner of MADD'S annual poster/essay contest.

"The national first place winner is Gabriella Ahmadia, age 11, of Waiakeawaena School in Hilo.

"As the first place winner in the Hawaii State content, Gabriella's essay titled 'Think and Drive,' was entered in the national competition and was selected as one of 21 national winners. She will receive a \$1,000 savings bond, and other awards as well as a trip to the awards ceremony in Houston, Texas, on May 7th for herself and one parent.

"Let me read her essay:

'Think and Drive

'One of my friends in my 5th grade class is a very sad girl. Jane's parents don't wake her up in the morning. She doesn't eat breakfast with her mom and dad. She eats with her aunt.

'When Jane goes off to school, her mom doesn't say, "Have a nice day." When Jane gets sick in school and has to go home, her aunt picks her up, not her parents.

'No one gets after her to do her homework. And at night, when Jane goes to bed her parents don't tuck her in

'Where are Jane's mom and dad? They were in a fatal car accident. The driver of the car was very drunk. When people drink, they should have someone drive them home.

If people who drink make the right moves, they will not cause sadness to others. It is important to think if you are going to drink.

'Drinking and driving causes accidents.
'One extra drink can kill others or you.

'No amount of coffee or food will make you sober.
'Only you can make the difference.
'Too many people suffer the consequence.

'Designated drivers are one step to safe driving. 'Roads are dangerous enough without drinking. 'If you drink, don't handle your car.

'No one can drink and drive very far.
'Key to safe driving lies in making the right move

'AND DRIVE ... only when you are sober.'

"The author of that essay is Miss Gabriella Ahmadia. With Garbiella are her parents Mr. Jamil Ahmadia and Mrs. Phyllis Ahmadia."

Gabriella Ahmadia and her parents rose to be recognized. Garbiella was presented the congratulatory Senate certificate by Senator Matsuura. Senators A. Kobayashi, Holt and Blair presented the leis.

Senator Matsuura also introduced the following representatives from MADD who were seated in the audience: Ms. Roz Luther, president; Ms. Glee Butz, chairman, poster/essay contest; Ms. Anita DiMauro, state chairman; and Ms. Carol McNamee, legislative liaison.

Senator Cobb then rose to speak on a point of personal privilege and stated:

"Mr. President, I rise to speak on a point of personal privilege.

"I was planning to say this on Friday but that was a holiday so, in accordance with the good news policy initiated by our education chairman, I would like to share a little good news today, especially in view of some of the controversy that has taken place recently.

"I've been learning over the past few months, international business is a wondrous, fascinating way to get to know the world and at the same time to see how it works. The controversy when I indicated that I would gladly provide to businesses in the state \$10.00 for every dollar spent, which most businessmen tell me is a very good return on investment, I started doing a little preliminary research on what had been accomplished to date, as a result of my travels. At the time I was in the former Soviet Union, I had the opportunity to visit the Republic of Georgia and the Institute of Clinical and Experimental Neurology of the Department of Health of the Georgian Republic in Tbilsi, Georgia, initiated a study after our meeting on heart stress, radiation and other elements. I put them in touch with at least five medical groups, one in Hawaii, four on the mainland, plus two health food organizations here in Hawaii. Direct contact was made. A study was conducted and, just before I returned, the results of the study were forwarded to me and one of the executives, in fact the chief executive officer of a health food company, called me and told me that this study directly resulted in an order being received from Malaysia for \$100,000 in several increments; in another order from Singapore of \$6,500.

"I note with surprise the wondrous turn that international business takes in order for something like this to happen. So I did some further checking on it and it turns out that this study conducted in Tbilsi, Georgia, provided independent corroboration of some of the statements and studies that had been made here in the United States, and that when this kind of independent corroboration took place from Russia or a Republic of the Soviet Union, that alone convinced the people to make the order and the Hawaii companies were the direct beneficiaries of that.

"Now, if any member of the media wants the name and telephone number of the chief executive officer for verification of this fact, I will be happy to provide it. But I think a little good news is in order. I'm only sorry that it couldn't happen on Friday but that being a holiday I wanted to share this with the members of the Senate today.

"Mr. President, there will be much more to come. Thank you."
