Wednesday, February 3, 1993

The Senate of the Seventeenth Legislature of the State of Hawaii, Regular Session of 1993, convened at 11:36 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend John C. Park, St. Luke's Episcopal Church, after which the Roll was called showing all Senators present with the exception of Senators Hagino, Iwase and Koki who were excused.

The President announced that he had read and approved the Journal of the Ninth Day.

Senator Chang introduced to the members of the Senate a group of participants in "Project Hoala," seated in the gallery. Senator Chang said, "'Project Hoala,' which is the pre-employment self-development component of the Department of Human Services jobs program, is a part of the 'Work Hawaii' program in the City and County of Honolulu Department of Human Resources."

And, also on a point of order, I'm thinking that we did vote on the positions of officers of the Senate on opening day. I'm kind of confused on whether or not it is proper to undertake this matter at this time, in accordance with parliamentary procedure."

The President responded:

"Senator Solomon, I believe the Senate President has the authority to make such appointments."

Senator Solomon thanked the Chair.

Senator George then seconded the motion.

At 11:43 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:50 o'clock a.m.

The motion to adopt S.R. No. 5 was then put by the Chair and carried.
