Thursday, April 15, 1993

The Senate of the Seventeenth Legislature of the State of Hawaii, Regular Session of 1993, convened at 11:36 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Chaplain Lonnie B. Barker, Captain, United States Air Force, after which the Roll was called showing all Senators present with the exception of Senators Aki, Fernandes Salling, Ikeda, Koki, McCartney and Reed who were excused.

The President announced that he had read and approved the Journal of the Forty-Seventh Day.

The following introductions were made to the members of the Senate:

Senator Chang presented the 1993 Small Business Persons of the Year Award winners, seated on the floor of the Senate, as follows:

"Mr. President, we have with us this morning the winners of the Small Business Administration's 1993 Small Business Person of the Year awards. I've asked different Senators to introduce our honorees, beginning with Senator Ann Kobayashi who will be introducing the winners of the Small Business Person of the Year award; Senator Fukunaga who will introduce the winner of the Women in Business Advocate of the Year, Island of Oahu; followed by Senators Bert Kobayashi, George, Tungpalan, Graulty, Solomon, Tanaka and Ikeda."

Senator A. Kobayashi introduced Bill and Joyce Edwards and said:

"Mr. President, it's a great honor for me to introduce the winners of the Small Business Person of the Year award, Bill and Joyce Edwards of System Center, Inc." (Mr. and Mrs. Edwards stood to be recognized.)

Senator Fukunaga introduced Robert Fujii as follows:

"Mr. President, I would like to introduce and recognize Mr. Robert Masao Fujii of Bank of Hawaii who was named the Minority Small Business Advocate of the Year (Island of Oahu). By way of introduction, I would like to note that Mr. Fujii has been instrumental in initiating economic development programs such as: the Office of Hawaiian Affairs Native Hawaiian Revolving Loan Fund, the Kalihi-Palama Immigrant Service Center's Refugee Micro-loan program, and programs at the Honolulu Japanese Chamber of Commerce." (Mr. Fujii stood to be recognized.)

Senator B. Kobayashi introduced Janet Haole as follows:

"Mr. President, it's a pleasure to introduce Janet L. Haole with Triple Check Income Tax & Accounting Service who is this year's Woman in Business Advocate of the Year (Island of Oahu)." (Ms. Haole stood to be recognized.)

Senator George introduced Reg Baker as follows:

"Mr. President, I have the pleasure this morning of introducing Reg Baker who is a CPA. He is the Small Business Accountant Advocate of the Year (Island of Oahu)." (Mr. Baker stood to be recognized)

Senator Tungpalan introduced Dexter Taniguchi as follows:

"Mr. President, it's my pleasure to introduce Dexter Taniguchi who is the Financial Services Advocate of the Year (Island of Oahu). Congratulations, Mr. Taniguchi!" (Mr. Taniguchi stood to be recognized.)

Senator Graulty introduced Diane Chang and said:

"Mr. President, it's my great privilege and honor to introduce to everyone the program editor of the 'Hawaii Business' magazine, Diane Emiko Chang, who is the recipient of the Media Advocate of the Year (Island of Oahu) award from the Small Business Administration. May I add, Mr. President, that Ms. Chang is now the editor of the Honolulu Star-Bulletin." (Ms. Chang stood to be recognized.)

Senator Solomon introduced Morton Bassan Jr. and stated:

"Mr. President, it is my honor today to commend and congratulate Morton E. Bassan Jr. who has been named the Small Business Exporter of the Year for the Island of Hawaii and the State of Hawaii. He owns the only commercial navel orange orchard in the State of Hawaii and is known for his Ka'u gold oranges. Mahalo nui and congratulations!" (Mr. Bassan stood to be recognized.)

Senator Tungpalan introduced Tomoo Okayama and remarked:

"Mr. President, it's my honor to introduce to our body Mr. Tomoo Okuyama. This individual received the Entrepreneurial Success Award (County of Hawaii)." (Mr. Okuyama was not present.)

Senator Tanaka introduced Cara Yamaguchi and said:

"Mr. President, it's a great honor to introduce Cara Yamaguchi, the Young Entrepreneur of the Year (Island of Oahu). I read her article and she did a terrific job. Competition is always good and I know you'll do good. Congratulations!" (Ms. Yamaguchi stood to be recognized.)

Senator Chang then continued:

"Mr. President, the 1993 winners are accompanied by Ann Nakagawa who represents the Small Business Administration." (Ms. Nakagawa rose to be recognized.)

The honorees were each presented a congratulatory Senate certificate and lei by Senators Chang, A. Kobayashi, B. Kobayashi, Graulty, Hagino, George, Fukunaga, Solomon and Tungpalan.

At 11:45 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
