

## EIGHTH DAY

**Tuesday, February 1, 1994**

The Senate of the Seventeenth Legislature of the State of Hawaii, Regular Session of 1994, convened at 11:36 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Dr. Mike Phillips, Wayland Baptist University, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Seventh Day.

Senator Fukunaga introduced Senator Robert Connor, President of the National Conference of State Legislatures (NCSL), and Ms. Corina Eckle, NCSL liaison for the State of Hawaii.

At this time, the President called on Senator Connor to address the members of the Senate.

Senator Connor's remarks are as follows:

"Mr. President, and other members of this esteemed body, 'Aloha!'

"Let me first of all say to you that it is indeed a privilege and a pleasure for me to be here. This is my first opportunity to visit the beautiful, wonderful State of Hawaii. I come from the first state, the first state that started this nation -- the State of Delaware, very small in size, but certainly very meaningful in our long history in the Constitution.

"Coming to the 50th State is certainly a thrill for me. The beauty of the state and the energy of its people have a lot to offer. You are looked upon with high esteem throughout this country. Many of your initiatives are looked upon by the National Conference of State Legislatures and our other states as being very progressive types of initiatives that make you world renown. I'm especially thinking of healthcare. We were just at a meeting last week where we were speaking about Hawaii and the healthcare movements that you've started.

"The National Conference of State Legislatures is an organization that certainly represents all 50 states and its territories. Together we have a certain strength, and that strength is not only our lobbying efforts in Washington, in trying to keep things moving along so that we always have a state's perspective in mind, but we also have an opportunity to share with each other the initiatives, the goals and objectives that each one of us has as our own individual state's. Sharing that with each other as colleagues is extremely beneficial, as well as our staff having a chance for professional development in sharing with each other. That's the strength of our organization -- an opportunity for meetings, an opportunity for sharing and working toward goals and objectives that are on all of our front burners, so to speak.

"It's indeed an honor for me to be here. As I came in, I noticed friends that I've become familiar with over the years through NCSL, and I appreciated their hospitality. But, I am sorry to see that one of my dear friends is having such a difficult time getting around nowadays, especially with the latest hip and knee soreness that he's experiencing through the basketball traumas these past couple of weeks. Like myself, Tony, once we reach 39, those things start to come upon us, you know. You'll heal, I'm sure.

"Once again, Mr. President and members, my colleagues, really, since I'm a Senator from Delaware and have been there for 14 years, 10 years in the House of Representatives, I feel somewhat like an older member of my own chamber .... coming here gives me a good feeling to be amongst you and your many new and bright ideas, and beautiful land.

"Thank you for this opportunity. Corina will be meeting with the Senate Ways and Means Committee tomorrow; she'll be giving testimony. Hopefully, we'll be taking back from this meeting some good words of wisdom for our other colleagues and, hopefully, an idea will be planted amongst you that membership and participation in our organization are really crucial. Thank you, once again."

"Mr. President, it is indeed an honor, thank you."

The President, on behalf of the Senate, welcomed Senator Connor and Ms. Eckle to Hawaii. Senator Connor and Ms. Eckle were presented leis by Senators Fukunaga and Levin.

At 11:45 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:50 o'clock a.m.
