Senator Solomon rose on a point of personal privilege as follows:

"Mr. President, I rise to memorialize recent praise directed toward the Legislative Auditor. Recent articles in the Pacific Business News by Steve Jefferson and in the Star-Bulletin by Bud Smyser have brought to the public's attention the excellent performance of Marion Higa and informed the public of the crucial role her office plays in the legislative process. Indeed, had not our Constitution provided for the Office of the Legislative Auditor it would be practically impossible for the legislative branch to perform its function in control of the power of the purse—its principal role in our balance of power system.

"The Legislative Auditor is appointed by a majority vote of each house in joint session and serves for 8 years unless removed earlier by us. Consequently, at all times the Legislative Auditor reflects our interests and our concerns as to the implementation of legislative appropriations. In Marion Higa we have the level of expertise and effectiveness that is essential to the proper functioning of our Legislature. We welcome her and look forward to the benefit of many more years of her professionalism and that of her staff. Thank you.

Senator Matsuura also rose on a point of personal privilege and stated:

"Mr. President, I would also like to rise on a point of personal privilege.

"This morning's Advertiser has a letter to the editor, 'Big Island phone service.' I'm not going to read the article but I just want to summarize it. This person, Julie Allen, writes to protest in terms of the pending rate increase that has been asked by Hawaiian Tel. For people on the Big Island, as you know, phone service is far from adequate. There are many places where they don't have private lines, dedicated fax lines are unheard

of, and there are a lot of ratepayers on party lines. What she's saying is that you've got to open up competition, and she suggests opening up the competition to companies like SPRINT and AT&T. Her letter to the editor reads as follows:

'I have protested to the Public Utilities Commission about the request by GTE Hawaiian Tel for a rate increase. But protesting is strictly a stop-gap measure. As long as GTE Hawaiian Tel is the only service being offered, we will continually be subjected to rate increases and substandard service.

'Here on the Big Island, hard as it is to believe, there are many large areas where private lines are unavailable and dedicated fax lines unheard of. An "across the islands" rate increase leaves those without adequate services paying the way for those who do have them.

'But enough of shortsightedness. Here is an opportunity for the Public Utilities Commission (PUC) to show foresight and provide the public the service that it is committed to. There is an easy solution to this request for a rate hike and that is to refuse it. It is time to end the monopoly and open up the interisland market to SPRINT and AT&T.'

"Mr. President, companies like AT&T are not interested in providing local services. Recently GTE Hawaiian Tel made a statement that the negative aspect of opening up competition is that the other telecommunication companies will concentrate their services to Oahu and will not provide telecommunications services to all the neighbor island exchanges, which are in GTE's estimations, 'losers.' Pacwest Network, Inc., a reputable telecommunications company offered to buy, in cash, all the exchanges that are 'losers' from GTE Hawaiian Tel. That written offer from Pacwest was not accepted.

"The president of Time-Warner Telecommunications offered to provide a telecommunications service similar to what GTE Hawaiian Tel was offering. The only difference being that Time-Warner Co. was willing to let Time-Warner shareholders pay 60 million dollars for the infrastructure cost, while GTE Hawaiian Tel wants to pass the infrastructure cost to the ratepayers of Hawaii.

"My concern is that when a company like GTE Hawaiian Tel, a public utility company that is self-insured, comes in for a surcharge, I want to make sure that the surcharge is fair and warranted. I have been trying for the past eight years to have the PUC examine GTE Hawaiian Tel financial books. The reason why GTE Hawaiian Tel has never had their financial books examined for the past eight years is that they were making enough money and didn't need a rate increase.

"The PUC guarantees public utilities like GTE Hawaiian Tel a reasonable profit. GTE Hawaiian Tel has not been audited for over eight years. This year GTE Hawaiian Tel came in for a 50.4-million-dollar rate increase. An audit done by the Consumer Advocate shows that GTE Hawaiian Tel in 1993 over-earned 30 million dollars beyond the guaranteed reasonable profit from its regulated services. This huge over-earning does not include profit from the unregulated operation of the telephone company such as sales of telephone instruments, etc.

"When I say over-earned, that means utilities such as Hawaiian Tel are allowed to take 11.25 percent profit of the capital investment. That's 12 percent! If you look at the prime rate today, it's only 3.5 percent. It's a really good deal if one can get that kind of return on your

investment capital. In 1993, they got all their profit up to 12 percent, but they made 30 million dollars more, on top of that. Now, that is unconscionable. That excess profit went to GTE shareholders and we, the ratepayers of Hawaii, paid for that excess profit.

"PUC didn't know the profit margin of GTE Hawaiian Tel because it was never audited for the past eight years. When we initiated a service for the hearing-impaired, there was a surcharge; 911 service, another surcharge; Iniki damage, still another surcharge. The best way to have done this is what the PUC recommended, go for a It is a legitimate way to get a rate rate increase. We don't need these surcharges! The only increase. problem associated with a rate increase was that GTE Hawaiian Tel would have to open up their financial GTE said that, at most, they make only 5 percent. I have testimonies stating these facts. No one could challenge their statements because they've never been audited and we believed whatever they said. We trusted them for telling the truth. Therefore, we passed the hearing-impaired surcharge. Then came service, and again, we passed another surcharge. Then came the 911

"When Iniki came, I felt sorry for the Kauai residents. As I stated in my floor speech, before I asked my Hilo constituents to pay for all the surcharges, that Hawaiian Tel was not making a whole bunch of profit. But, because we didn't have any data, we voted 'aye.' I'm going to admit that I also voted 'aye.' Another surcharge was passed on to all the ratepayers in Hawaii. Because GTE Hawaiian Tel was self-insured, GTE stockholders should have paid for the damage. GTE stockholders saved millions of dollars of premium costs. They took the chance, but we paid for the consequences.

"I'm not trying to target Hawaiian Tel, please don't misunderstand me, all I'm looking for is fairness for the Hawaii ratepayers. Maybe I am a little sensitive, but when I look at my telephone bill, touch-call service costs me \$1.65 a month. Other states don't charge for this service. If the ratepayers want to jam up Hawaiian Tel, buy and use rotary dial telephones instead of touch-call telephones. It will create a chaos for Hawaiian Tel. Why should GTE Hawaiian Tel charge \$1.65? It would be more appropriate to charge \$1.65 for the ratepayers who are using rotary telephones because the technology is moving to digital. Touch-tone is something all the telephone companies in the United States want to achieve, yet, we get charged for this service in Hawaii. Why?

"What upsets me is that everything that I had said in my floor speech last year has come to fruition. I predicted the excess earnings. Now, I see this audit report and it really upsets me. I wasn't going to say anything until I read that letter to the editor. I have an obligation to support this lady because she is right. Why didn't GTE take the excess 30 million dollars and provide better service to the Puna area and get them all on a private line instead of party lines? They have 30 million dollars over and above the maximum profit they were allowed to take. Why didn't they do that? Why didn't they provide 911 service with the excess earnings? Why didn't they buy an insurance policy to pay for all the damages? Who benefits from the Iniki surcharge? GTE stockholders. GTE is not owned by Hawaii's people.

"Another thing that is also upsetting is their rate increase. GTE Hawaiian Tel had requested a 50.4-million-dollar rate increase in May 1993. The proposed increase includes jumps in residential basic rates ranging from 62 percent (on Oahu) to 137 percent (on Lanai) and results in a flat fee of \$21.95 on each island. 'We are concerned by the proposed rates,' Totto said. 'First, it will cause the greatest hike in rates on the neighbor island. Second, the proposed increase is likely to push

more than 6,000 residential users off the telephone system because they cannot afford the increase. Although the increases affect the whole state, this will hit neighbor islanders, the elderly, and those with a fixed or low income hardest.'

"Another serious concern, consumer advocate Totto said, is that 'other companies in the GTE family are syphoning off revenues that belong to GTE Hawaiian Tel.' For example, the auditors reported 1993 Hawaiian Tel revenues should be increased by 3 million dollars to reflect revenues from Yellow Pages Advertising that should be attributed to GTE Hawaiian Tel, but are now being paid to GTE Directories Corp. which is an unregulated GTE subsidiary.

"Questionable allocations of costs by affiliated GTE companies to GTE Hawaiian Tel is another area resulting in a suggested reduction of 4 million dollars. These include expenses that have little or nothing to do with providing telephone service to Hawaii ratepayers. Examples:

Art work for mainland offices (for example, \$35,000 oil portrait of a past CEO);

GTE corporate 'image' advertising expenses;

GTE executive incentive bonuses;

Sales expenses and incentives (including sponsorship fees paid to the National Football League and grants to the Dallas Symphony Orchestra);

Sports activities costs (for events such as the Pro Bowl and Super Bowl);

Charitable contributions (which, when recovered from rates, become involuntary contributions from ratepayers); and Lobbying expenses.

"I was trying to get GTE audited for many years. The Legislature put in the budget last year monies to force PUC to do an audit on the state Selex system. Did you know that not a single CPA firm would take the job. Why? Are they scared of what they would uncover?

"We as Legislators have got to protect the ratepayers. That is our job. It's time that we stand up and support people like Julie Allen because she's saying, 'Help me, I can't stand these party lines.' I know what party lines are like. I still remember my old telephone in Waialua -- 3 Blue 704. (Laughter.) I guess what I'm trying to say is that we, as legislators, have to provide some fairness, and if a utility company is regulated, then we have to make sure that the ratepayers are paying what is considered a fair rate.

"Another thing that upsets me is that Hawaiian Tel is also involved with international calls. AT&T came in as an intervener and the PUC rejected them. PUC wouldn't let AT&T be an intervener. Why wouldn't the PUC allow AT&T to come in? Who is most knowledgeable about the revenues that GTE Hawaiian Tel makes on international calls but AT&T. Yet PUC didn't allow them to come in. Why? The chairman of the PUC is going to get a letter from me because, although my investigating committee will be terminated soon, I think it's time that the people of Hawaii get some answers, and I'm going to try to get some of the answers. I'm a ratepayer and I have a number of phones in my office, and I object to paying this touch-call charge every month. I still believe that the state should be able to use our microwave system and I don't think PUC has any business regulating the state government telecommunication system.

"These are some of my objections, Mr. President, and I apologize to this honorable body for airing out some of my frustrations! Thank you."

Senator Solomon rose again on a point of personal privilege and said:

"Mr. President, on a point of personal privilege. Not to make light of the situation, I think that the points raised by the previous speaker are very important ones, not only as it relates to GTE, but also to HEI and HIG. I could go back in my 12-year tenure and I can pull out my floor speeches, concerning this subject matter and you will see that this has been our concern for a long time. I was never able to get an audit of HEI in terms of the impact its diversified portfolio had on the electrical rates that our people are asked to pay. And as you know, every year they've asked for rate increases and now I just wonder, where did they get the \$37 million for HIG? I think that this Legislature has a lot of challenges ahead on lowering rates for the payers of utilities.

"Not only that, Mr. President, I'd like to remind you that when I chaired the Committee on Agriculture, and this was one of the first committees that I chaired when I came into this body, that your Committee on Agriculture at that time embarked on a very ambitious plan to look at price fixing on food in the State of Hawaii. There was an article in the Star-Bulletin on this very serious problem. Buying food is an everyday basic. Now, when you buy a box of Kellogg's Cornflakes and have to pay six bucks, I think that's telling us something.

"These are the issues -- although our plate has been full up till now, with firearms, same sex marriage, shipboard gambling and who knows what else -- that, as the session progresses, the Senate committees will start looking at these serious problems that face our residents every day in the State of Hawaii. I'm hoping that the Ag Committee will meet the challenge of high prices and meet with the supermarkets and the producers to determine how and what is causing these problems.

"Thank you very much, Mr. President."

Senator Holt then responded:

"Mr. President, in response to the previous comments, I'd be happy to work with the Majority Leader on those problems. Thank you."
