Senator Matsuura rose on a point of personal privilege, as follows:

"Mr. President, may I be permitted to make a statement on a point of personal privilege?

"Mr. President, I just happened to look at an Advertiser article here -- 'Phone bill up 28 cents to fund 911 system. Beginning Tuesday, all telephone users will be paying 28 cents more per month so GTE Hawaiian Tel can complete a statewide Enhanced 911 emergency telephone system.' I'm just going to read the latter part of the article. '"This statewide expansion of E-911 is the result of legislation passed in June 1993 calling for implementation within one year," said Jenny Wong, vice president of external affairs. "The legislation also authorized the company to recover the costs to provide the service through a surcharge."' she said.

"The reason why I bring this article up is that I spoke previously on a point of personal privilege that GTE Hawaiian Tel had, for 1993, over-earned \$30 million. Yes, they over-earned \$30 million, and that's beyond the 12 percent that they are allowed to earn by law. With that thirty million dollars, they should have used some of that to pay for the E-911 cost. GTE Hawaiian Tel is continually charging the ratepayers more surcharges when they have all this excess earnings. We, as Legislators, have allowed GTE Hawaiian Tel to charge these surcharges to the ratepayers.

"Mr. President, I've been trying to audit GTE Hawaiian Tel for I don't know how many years. GTE Hawaiian Tel has not been audited for over eight years. Today I got the sad news that even if GTE Hawaiian Tel was audited for other years like 1992, 1991, 1990, 1989, etc. -- and over-earned in all these past years, whatever they over-earned from 1992 backwards -- there is no way the ratepayers can recover the over-earning. That's gone to the stockholders of GTE.

"I feel as if I have let the people of Hawaii down because we, the ratepayers, have paid for all of these excessive profits -- these so-called over-earned profits beyond the 12 percent that they're supposed to get by law. I feel that we have literally lined the pockets of GTE stockholders with millions of dollars. If you think \$30 million was excessive in 1993, we should take a look at 1992, 1991, 1990 profits. The over-earnings must have been large. We won't know unless GTE Hawaiian Tel is audited for 1992, 1991, 1990, 1989, 1988, 1987, 1986, etc.

"I introduced a resolution to audit GTE Hawaiian Tel for the past eight years. We will recover what they have over-earned in those years. The audit will prove that GTE Hawaiian Tel misallocated illegally some of their costs. Once this is proven, GTE Hawaiian Tel will have an obligation to return all of that over-earned profit back to the ratepayers of Hawaii. The other western states require an audit every year and an extensive full audit every third year. P.U.C. commissioners of other states cannot believe that GTE Hawaiian Tel has not been audited by the P.U.C. for over eight years.

"Thank you very much, Mr. President."
