By unanimous consent, Stand Com. Rep. No. 2500 and S.B. No. 2017, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE RESEARCH CORPORATION OF THE UNIVERSITY OF HAWAII," were recommitted to the Committee on Ways and Means.

Stand. Com. Rep. No. 2501 (S.B. No. 3014, S.D. 2):

By unanimous consent, Stand Com. Rep. No. 2501 and S.B. No. 3014, S.D. 2, entitled: "A BILL FOR AN ACT RELATING TO THE STATE POST-SECONDARY EDUCATION COMMISSION," were recommitted to the Committee on Ways and Means.

Stand. Com. Rep. No. 2508 (S.B. No. 2499, S.D. 1):

On motion by Senator Ikeda, seconded by Senator Hagino and carried, Stand. Com. Rep. No. 2508 was adopted and S.B. No. 2499, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE VISITOR INDUSTRY," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

Stand. Com. Rep. No. 2513 (S.B. No. 2754, S.D. 2):

Senator Ikeda moved that Stand. Com. Rep. No. 2513 be adopted and S.B. No. 2754, S.D. 2, having been read throughout, pass Third Reading, seconded by Senator Hagino.

Senator Levin rose to speak against the measure and stated:

"Thank you, Mr. President, I rise to speak in opposition to this bill.

"Each of us in this chamber is a temporary occupant of the Senate. We have borrowed the desks that we sit at. The chairs have been loaned to us by our constituents.

"In some cases, we occupy the positions for a couple of years. Others of us are fortunate enough to stay a bit longer. But even for the best of us, these are temporary assignments only. And I think that each of us wants to pass on to our successors a better Hawaii than we inherited from those who came before us.

"Once in a while there comes an issue before us that truly has long-term ramifications and to make wise decisions on those issues, it would help if we could be mind readers and predict the future. Perfect wisdom, unfortunately, is an impossible task and we can never be sure. So we each make our judgments and we hope for the best.

"One thing that might help to guide us are the words of the author of the Hippocratic Oath. Hippocrates said, 'Make a habit of two things -- to help or at least, do no harm.' If we follow that precept all the time, we would be compelled to be very conservative in our approach. And we might think that we are being told by those words to take no risks at all. I would not subscribe to such a reading, and yet on issues such as gambling I think that we would be well advised to keep that admonition in mind.

"I think we know the potential consequences of legalized gambling in Hawaii. The damage that can be done to our social fabric. The addiction that some people will succumb to. But really, we are talking about two addictions, not just one. There's the commonly thought of addiction which is to the individual who's going to gamble away the rent and food money in order to make up for previous losses, or to achieve a life of wealth and splendor. But there is a second addiction we need to worry about, and that is the addiction that government experiences, the addiction to more and more revenue, and the need for more and more revenue.

"In fact, many of us are being up-front about it, even today. Most are not suggesting that we should legalize gambling because it will make Hawaii a better place. Most of us are being straight-forward and saying that we need the money. Perhaps it's for mass transit; perhaps for education; perhaps for general transportation needs. But whatever the 'worthy cause' might be, most of us are frankly admitting that we are supporting this option as a way of increasing tax revenue and for no other reason.

"We often talk about sending mixed signals. That's often been the argument when someone dares to suggest that our drug laws are too harsh, or our criminal sentencing laws are too rigid. Yet what kind of signal are we sending today with this gambling bill?

"I enjoy Las Vegas, I think most of my colleagues do also, or at least many do. But I do not choose to live there. In fact, none of us chooses to live there. Do we really want to bring Las Vegas to us?

"I know we're only talking about shipboard gambling, today. But we must not ignore the fact that during most of our political lifetimes we have had presented to us, and we have taken up at one time or another, virtually all forms of gambling: lottery, horse racing, dog racing, offtrack betting, bingo, casino gambling. We have said no to all of them. We've built a firewall. And I fear that once we breach that firewall, inevitably it is only a matter of time before the complete variety of gambling is available in Hawaii. After all, we're going to 'need' that We will absorb whatever new revenue is money. generated from shipboard gambling, and then we will want more -- for human services, for extension of the transit system, for better education, for whatever good and positive motives that people may have, and the variety of gambling options will be brought in one by one.

"There's also the issue of what happens on Hawaiian land. Sovereignty is coming, and it is going to be a very positive thing. I think most of us hope and expect that the sovereign nation will be somehow integrated and disbursed throughout our island state, perhaps using Hawaiian Home lands, perhaps ceded lands, or whatever. If the firewall against gambling has been breached, and if the new Hawaiian nation wants full-on gambling, do we really believe that anyone will be able to resist, legally or ethically, such a demand?

"Even if you do not share my fears that this is a first step on a long path, I would ask you to question whether shipboard gambling is the best thing for us. What will happen to the gambler who loses whatever he or she decides they can afford, during the first hour of the cruise? What is that person going to do for the next three, or four, or five hours? Is the person going to go

off into a corner and read Shakespeare? Or, is the person going to find some money somehow, somewhere, to continue to gamble to win back what was lost, or simply to avoid boredom. The person who gets on that gambling ship is going to be a captive audience for the length of the cruise. Any of us who have been in a casino knows how hypnotic and, yes, addictive those gambling tables and those slot machines can be.

"I received a copy of Senator Dan Inouye's letter to our President and so did all my colleagues. I would like to quote from that letter. He starts out by saying that he is not taking his position from the standpoint of morality or ethics, but rather:

'from the standpoint of good governance. First, gambling adds to the welfare rolls, as well as other government supported human services programs.

'Second, large amounts of cash associated with gambling provides an opportunity for money laundering and other criminal activities.

'There is no question that our crime rate would increase.

'Third, Hawaii's tourism industry does not need gambling. I would be very skeptical about taking a chance on destroying what the tourism industry has worked all these years to achieve.

'And fourth, offshore gambling is the first step to bring gambling into Hawaii. Other forms of gambling will find their way into our communities. At that point, it will be too late.'

Still quoting from Senator Inouye

'We as lawmakers and government leaders will pay dearly in social costs -- financial outlays and human tragedy -- in the end. I hope and pray that the members of the Hawaii State Legislature will take a hard look at the impact of gambling on the State of Hawaii -- its impact on our crime rate, our tourism industry, and most importantly, its impact on our communities, people and children.'

Those are the words of Dan Inouye.

"I do not know whether there are any undecided votes out here on the floor. If there are, I would urge you to weigh the speculative short-term gains against the potential long-term losses. Taking into account that balance, I would urge my colleagues to vote 'no' on this measure. Thank you.

Senator Matsuura also rose in opposition to the bill and said:

"Mr. President, I also rise to speak against this measure.

"I agree with my colleague from the Big Island. Once we allow legalized gambling in the State of Hawaii, the Hawaiian groups will be next to follow because that's the only thing that's keeping them from getting into the legalized gambling today. Any tribal group, like the Indian tribal group, cannot initiate a gambling operation if the state laws do not permit gambling. If this bill passes, it opens the door for the Hawaiian groups and I will support them.

"Many of you may not realize, but Sam Boyd, the person who built the California Hotel and all the casinos in Las Vegas, actually got his start in Hilo, Hawaii. Mr. Boyd worked for Mr. Hisanaga and from there he went to

Las Vegas and was successful in a tremendous development project, catering to the Hawaii visitors. If one goes to the California Hotel you will see a lot of Hawaii people. That gives you a false impression that if you have legalized gambling here, Hawaii people are going to gamble here instead of going to Las Vegas. I think the reason why a lot of Hawaii people go to Las Vegas is not just for the gambling but they have good entertainment and shows and the hotel and food costs are Las Vegas is nothing but desert. reasonable. 'Bugsy' found and started Las Vegas, that place was a It's interesting that the people who own the casinos, don't gamble. I talked to a lot of executives and the reason they don't gamble is because they know that Las Vegas was built on losers, just like myself. It is unfortunate that people have that hope of making the big megabucks, but they're contributing to the economy of Las Vegas has done a fabulous job of Las Vegas. promotion in Hawaii.

"There is no doubt that the State of Hawaii is the best place in the world for gambling, but I don't think we're quite ready for that kind of move.

"The Gold Coast in Australia was known as the Great Barrier Reef and the sales pitch was that. Today, the Gold Coast is also a mecca for gambling. And I hope that Hawaii doesn't get that kind of reputation that if you want to gamble, come to Hawaii. The gambling ship may be initially going out to the open ocean, but the gambling ship may also operate docked at the pier and before you know it, the gambling operators will come on shore, just as it has happened in Mississippi, and all the other states where they had gambling on riverboats. If you open up the door, there isn't going to be an end because there's lots of cash. Transactions are in cash and that's where the danger begins.

"So, for us Legislators who have not even allowed lottery, to go to a full scale gambling on a ship is hard for me to understand why we're making such a drastic change in policy. I think if we had the laws and the rules and the experience of Las Vegas, Nevada, we may be ok, but I don't think we're ready for it today. I hope that those of you who are undecided as to which way you're going to vote that you'll consider the future of Hawaii and the children, in casting your vote. Thank you."

Senator Solomon then rose in support of the measure and stated:

"Mr. President, because I'm thinking of the children and because I love Hawaii, I'm going to be voting in support of this bill.

"Mr. President, as you know, at this point in our history, we need little imagination to conceive of a future marked by misfortune, slow to grow and hampered by unwanted restraints. That is the prospect that confront us, as our economy, with distressing speed, slides toward the death of opportunity. If I sound gloomy, I'm entitled. On the Big Island, sugar is fading away, and there is no ready replacement.

"I hasten to say that it is much too early to forecast the end of plantation agriculture. Maui and Kauai will continue to make crops for years into the future.

"But along the Hamakua and in Waialua, the old order is changing, and a generation of farm families are losing their ties to the land, the self-respect of gainful employment and the confidence of reliable lifestyle. There is no ready replacement.

"We have positive beginnings: a mountain top of telescopes on Mauna Kea and Haleakala pondering the

strangeness of the universe; a research center pursuing the connections among cold ocean water, electricity and aquaculture; a geothermal resource that promises steady power. But when, Mr. President, will that happen?

"The demand that we confront is for jobs, new jobs, new industry to take the place of those we are losing to the end of sugar in our corner of the islands. There is tourism, yes, and it's a great industry -- non-polluting, export-earning, compatible with differing environments. But recent economic downturn has pointedly reminded us that there are limits in even so well-established destinations as Hawaii.

"What we urgently need is a means to build on our existing economic base without sacrificing the features that make tourism a healthy industry.

"Mr. President, that opportunity is legal gambling, and it offers more promise to both the tourism industry and the overall economy that might first seem to be the case. It is superficial to note that Hawaii and Utah are the only states which do not permit gambling. We should license a half-dozen offshore cruise ships to offer legal gambling on trips between the islands or just offshore. Examination of other states' experience with riverboat gambling reveals that shipboard gambling will bring in large earnings, valuable tax receipts and a more diverse visitor industry.

"Better still, it need not replace any existing visitor industry trade. Shipboard gambling would be marketed as an added feature of Hawaii's visitor product. Our promotion of the islands in our own country and Asian markets would continue to highlight such familiar and dependable assets as our magnificent natural environment. In that the last two years the number of states considering riverboat gambling has increased to more than 15. Their experience indicates that such gambling is a multi-million dollar resource.

"To produce the maximum in revenues, while maintaining oversight, cruise boats must go to sea several times a day, draw participants from surrounding population areas and be shielded from cut-throat competition.

"Hawaii is ideal. The islands have an ever new population of visitors, and destination areas are close to landings. With a moderate admission fee, several trips a day and vessels ported statewide, earnings may exceed \$100 million a year. Mr. President, we have here a proposal that accomplishes key policy goals. It raises revenues; it creates jobs and it offers an enjoyable pastime for visitors and residents alike. Let's seize the opportunity and accept it. Thank you."

Senator George, rising to speak against the bill, said:

"Mr. President, over the years, a lot of gambling proposals have floated past me. It's ordinarily been fairly easy to resist the temptation to accept the extra money because economic times were affable and we usually managed, without too much stress, to find money to fund worthy programs. It's harder now to resist the temptation when funds may be available through gambling for programs in which I take a great deal of interest --education and transportation. In order to resist the temptation I found myself asking myself the old question, 'Does the nobility of the end justify the means?' My answer to that is 'No.' Colleagues, I hope you'll join me in voting 'no.'"

Senator Koki also rose in opposition to the bill and stated:

"Mr. President, I rise to speak against this bill. This bill does not pollute the lung; it certainly pollutes the attitude and the mind.

"We're always looking for a quick fix which we must abstain from and resist the temptation of legalizing a vice. Soon we'll probably be getting calls of legalizing prostitution and drugs. Gambling is an addiction that can be worse than the addiction of drugs.

"What I'm concerned about is that we are losing the essence of what has made Hawaii great. We have a bill that's going to be mandating the 'Aloha Spirit,' teaching the 'Aloha Spirit.' Does gambling encourage the 'Aloha Spirit?' I think not. I don't think that it will encourage the 'Aloha Spirit' if the mentality of doing what is necessary to raise money prevails. Let's not destroy what has made Hawaii a very special place. Thank you."

Senator Graulty then rose to speak in support of the bill and stated:

"Thank you, Mr. President, I rise to speak in support of the bill.

"As we consider the proposal before us to create a new industry for our state, we should put aside horror stories about the deadly embrace of gambling and focus on facts. Fancy has it that organized crime will instantly follow gambling into any new market. The fact is there is no more likelihood of such a development than with any other new industry; in fact, less, because enterprise touched with gaming throughout America has been greeted with more stringent controls and government supervision than any other enterprise, and rightfully so.

"Mr. President, your Committee on Judiciary was concerned about the impact that gambling may have on law enforcement activities. A study was done by the State of Virginia to look at riverboat gambling and see the impact that it might have on crime in the various states that have adopted riverboat gambling. I have with me today the summary of those findings and the study itself from the State of Virginia, which studied riverboat gambling in Iowa, Illinois, Louisiana, Missouri and Mississippi. Those findings indicate that interviews with chiefs of police, sheriffs, prosecutors and security chiefs of riverboat casinos reveal that there have been occasional criminal offenses related to riverboat gambling. consist of public intoxication, driving under the influence of alcohol, disorderly conduct, petty theft, bad checks, shooting by both patrons and casino employees, traffic crashes and congestion. All law enforcement officials interviewed stated that while riverboat gambling does increase crime rates, it has not created a negative impact on their area of responsibility.

"In some cities, task forces or additional patrol boats or beats were created in preparation for an expected impact on law enforcement. All have disbanded the task forces or beats due to lack of calls for services. 911 calls have increased in most areas, while most authorities report these calls for service have not had a major impact.

"Only one jurisdiction, Galeena, Illinois, reveals emergency medical calls for service had impacted on their local rescue squad. Rescue squad is a volunteer operation and having personnel available seven days a week had caused some concern.

"Prosecutors who have prosecuted the above-mentioned criminal violations, as well as violations of riverboat gambling statutes, also report no observable negative impact in their area of responsibility. They unanimously related that the current statutes regulating riverboat gambling are well written, and to date they have not

encountered problems prosecuting kinds of cases that we would expect are related to riverboat gambling.

"Mr. President, your Committee on Judiciary also took some testimony from a very successful businessman who is responsible for much of the growth in the tourism industry in our state, Mr. Chris Hemmeter. Mr. Hemmeter had some very interesting comments about gambling and I'd like to quote from his testimony. He says:

'Gaming throughout America has become the new pastime. Gaming in the decade of the '90s is to the visitor industry what golf was to the visitor industry in the '80s. It is becoming an essential ingredient in the overall matrix that makes up a successful visitor industry. It is desired by conventioneers and group travelers as well as free independent travelers. Gaming is an average \$12-per-hour form of entertainment and visitors spend an average of four hours per visit to a gaming facility. Gaming should not dominate the state's visitor industry, but rather enhance the visitor industry by offering another option which is so highly sought after throughout the nation.'

"A recent study by Yankelovich Inc. indicates that Americans visited casinos 92 million times last year, twice as often as they did three years ago. And for the first time, Mr. President, more Americans visited casinos than attended all baseball games in America. The Yankelovich survey of 100,000 households in America found that 27 percent of Americans gambled at least once last year, up from 17 percent in 1990. This group spent over \$13 billion in the gaming industry, more than was spent attending all the movies in America. Four years ago, only Nevada and New Jersey had legal casinos, and to date, 23 states allow it. The study went on to show that gamblers have higher incomes, more education, and hold more white-collar jobs than the average American. More women gamble than men, 54 percent versus 46 percent. And the study went on to forecast that 28 states will have casinos by 1997.

"Mr. President, the gaming industry is the fastest growing segment of the visitor industry in America. Assuming that the State of Hawaii wishes to stay in the forefront of the visitor industry, it is essential that the gaming industry be seriously studied as to its appropriateness for our state.

"Nancy Todd, in a recent article entitled 'Legalizing Gaming and Doing It Right,' stated that enabling legislation and citizen involvement are the most important steps in bringing gaming to America. She indicated that each of the following areas should be included to facilitate the passage of legislation:

- (1) Type of gaming to be allowed and exactly where it will be conducted;
- (2) The precise manner by which it will be regulated and the nature of the state's regulatory industry;
- Provisions for calculating the tax revenue and setting up precisely how the money will be spent; and
- (4) Provisions for state, county or local option.
- "Mr. President, Senate Bill 2754 includes all four.

"Mr. Hemmeter went on to say that his company was developing a riverboat gaming facility where he will employ over one thousand individuals in the gaming operation with an indirect impact on employment of an additional three thousand jobs. There are numerous other examples throughout the United States where the gaming industry has brought about significant new employment and where there has been a transformation from government deficits to government surpluses, and

examples where existing taxes have been reduced significantly in communities where gaming has been introduced. In addition to high government revenues and numerous job opportunities which cross the spectrum from computer analysts to maintenance people, from card dealers to accountants, gaming has brought other benefits to communities. In many instances, crime in a community has actually declined with the opening of a gaming facility, for the basic root of crime is poverty and lack of opportunity coupled with a desire for a better future.

"The economic stimuli brought about by the gaming industry have in numerous instances caused unemployment to drop and better paying jobs to increase, setting the opportunity for our children to return home to a future of opportunity rather than despair and unemployment. The economy of Hawaii which is based on tourism provides a bellwether to the future. The gaming industry can be an economic stimulus within the visitor industry.

"Mr. President, I'm tempted to suggest that Hawaii's durable opposition to gaming may be more a measure of our missionary past than the result of thoughtful study of our circumstances. Let us be done with the mythology that surrounds proposals to commence legalized gaming. Let us open our eyes to the real world. Let us recognize that gaming is a legitimate enterprise, no more touched with wrongdoing than any other, and fully capable of sustaining itself in high regard. Let us be done with the double standards that hold horse racing and sports betting in high regard but produces opposition to shipboard gaming.

"Mr. President, members of the Senate, we must be sound business people in this matter. We are seeking a new source of revenue that will finance essential government operations, yet enhance our visitor industry. Let us authorize shipboard gaming and welcome resulting growth in our visitor industry and new strength in the education and transportation programs it will support. Thank you, Mr. President."

Senator Iwase also spoke in support of the bill and said:

"Mr. President, this is a very tough issue for me. I did sign 'With Reservation' on the committee report coming out of the Judiciary Committee. There is the moral issue facing us on the question of gambling. There is also, for me, the question of the need for more revenues.

"I'm going to vote to support this bill because I represent a district which is suffering from a burgeoning population and it requires transportation improvements. The cost of such improvements are high. Last session we passed a bill to the House, in the absence of rail, a proposal to build a tunnel under Pearl Harbor that's \$1.8 billion. A rail system would be \$2 billion. A bus transit system would probably be several hundred millions of dollars. People have to understand that there have been some who voted for development in leeward and central Oahu and I assume that there are political benefits to be derived from that, and yet on the other hand chose not to support needed transportation improvements caused by the developments which they voted for. That, I think is irresponsible.

"My colleague from the Big Island, the first speaker, who went to Harvard and perhaps that is why he mentioned Shakespeare, I would like to quote to him a line from Shakespeare's Romeo and Juliet: 'What light from yonder window breaks.' For me, Senator, this is a ray of hope for transportation improvement in my district, and I will support this bill for that reason. Thank you."

Senator Reed then rose to speak against the measure as follows:

"Mr. President, may I rise and speak very briefly in opposition? I think this is a false light from yonder window.

"Mr. President, I feel that this is an irresponsible way to increase revenues. If we, as a community, have things that we actually need, be it rapid transit or better schools, which I certainly concur with, then we, as a community, must be willing to pay for that kind of service. We must be willing to, as a community, agree to increase our contributions in the form of taxes to provide for our children and to provide whatever we want in terms of services to the community. To attempt to provide this kind of illusory source of revenue through gambling is an irresponsible way of increasing revenue.

"And finally, Mr. President, it is certainly one thing if people choose to gamble, that is their right. But in this situation, what you would have is government encouraging people to gamble, and that is clearly inappropriate.

"So, I will be voting 'no.' Thank you."

Senator Holt rose to speak in support of the bill and said:

"Mr. President, I rise to speak in support of the bill.

"First, let me commend you for taking this bold and courageous initiative forward despite perceived political fall-out for introducing and supporting such a controversial measure.

"Most importantly, Mr. President, I'd like to point out that if this would do what the opponents have previously stated -- that gambling will destroy what has made Hawaii a special place -- then those who benefit from Hawaii being a special place would be totally opposed to this bill. Mr. President, I'd like to point out that our tourism industry is not here today in numbers lobbying against this bill. They did not testify in committee against this bill. The HVB, state marketers for tourism, is not against this bill. The Hawaii Hotel Association, representing most, if not all of the hotels in Hawaii, are not against this bill.

"Mr. President, if our number one industry which provides most of the jobs in our state (the voters in your district are employed by these hotels in this industry) is not opposed to this bill, then they, like me, believe that Hawaii will continue to remain a special place, despite passage of this bill. I urge all my colleagues to vote in support of this measure. Thank you."

Senator Ikeda also supported the measure and stated:

"Mr. President, I rise to speak in favor of this bill.

"Mr. President, it's altogether too easy in our mid-Pacific paradise to neglect the hard facts of government and political life. Since the advent of statehood and jet aircraft, an ever-growing tide of visitors to our shores have created a booming visitor industry whose growth underwrote resort development and strengthened an economy in transition. In the last two years, however, our earnings have fallen off. It is not just that the number of visitor arrivals has slowed, equally important from the standpoint of revenues, the over-building of hotel rooms has produced vacancies subject to no tax.

"However, Mr. President, my colleagues in this Legislature are far from restraining their spending habits of more opulent days. For the fiscal year 1994-1995, the Legislature is considering a total of 166 general fund appropriation proposals worth more than \$250 million. Adding special funds appropriations to that would amount to more than \$400 million. Plainly, these proposals must be curtailed. Just as important, however, we must seek new revenues that together with prudent cuts will allow us to balance the budget.

"The governor has proposed a half penny excise tax to underwrite the local share of the transit system and, not surprisingly, the Legislature, mindful of impending elections, has refused. That decision is a definition of what is politically possible. The Legislature will not approve taxes that fall heavily on island residents. That leaves the transient accommodations tax, which could be popular, except for the negative impact on the industry that I have already mentioned.

"Mr. President, if we are to solve our financial problems under these constraints, we must look farther afield than has been our practice. This wider view reveals a revenue source that has the benefit of boosting tourism, yet generating new funds for tax strapped agencies that are essential to our well-being, such as education and transportation. That source is legal gambling, specifically gambling aboard cruise ships transiting the islands or sailing from ports throughout the state.

"It is not possible to predict with certainty the earnings shipboard gambling will generate in Hawaii, but the experience of Illinois, one of the most aggressive states allowing gambling aboard riverboats, is very encouraging. Illinois' ten riverboats carry more than 12.5 million visitors a year, raise almost \$715 million in gross revenues and produce over \$170 million in direct tax revenues. In addition, the riverboats create over 8,500 jobs earning an average of \$23,000 a year.

"With slightly more than half as many boats and fewer than half as many customers, Hawaii can expect returns of more than a \$100 million in revenues and a dramatic increase in employment. Moreover, shipboard gambling here can offset out-of-state gambling by Hawaii residents. It is estimated that Hawaii now exports \$5 million a week, \$250 million a year to Mainland gambling locations like Las Vegas.

"Hawaii also will benefit from its oceanic location. Mainland jurisdictions have found themselves in competition with neighboring states that also sponsor riverboat gambling. While Hawaii would have several ports, all would be within the state. Receipts from gambling would go into a separate fund from which state and county shares of gaming income would be paid.

"Mr. President, this Legislature over the years has debated many forms of gambling, from horse and dog racing to casino resorts. Always in the past, we had the luxury of adequate revenues to operate the state without recourse to gambling. Now, however, we face different circumstances. We cannot predict an immediate return to good health for our tourism industry, and we have no enthusiasm for new taxes.

"I might add that I shared the same fears expressed by others of potential social problems several years ago when social gambling was passed by this Legislature. I have to admit, fortunately, that my fears were unfounded. I'd also like to add that the previous speakers' concerns regarding Hawaiian groups embracing gambling as a means of raising revenues are really interesting. As I recall, a bill was introduced last year by one of the

speakers which would have authorized casino gambling on Hawaiian Home lands. I find this about-face curious, to say the least.

"Mr. President, we can create a legal, closely regulated gambling industry that will create new jobs and revenues. We should recognize that education and transportation are major public enterprises, which at this moment are in desperate need of support, and we should act decisively on this matter. Thank you."

Senator Matsuura rose again in opposition to the bill as follows:

"Mr. President, the last speaker mentioned about a person who introduced a measure that will allow the Department of Hawaiian Home Lands to provide some of these gaming programs on their land. I am the person who introduced that legislation and I'm willing to admit that.

"And the reason I did that is because, like I said previously, feasibility studies have shown that if one is interested in promoting gambling, the best place in the world for legalized gambling is Hawaii. I know of the history of the Hawaiian people, how they had lost their lands like the American Indians. If we are going to allow gambling to take place in the State of Hawaii, I want the Hawaiian people to be the first in line to take advantage of it. If we're going to go the gambling route, then I want the Hawaiian people to be one of the beneficiaries.

"Many of you have mentioned about revenues from gambling. If we are talking about revenues for the state, then I say, pass the bill such as the telecom free zone in Kapolei. Do that, and I can assure you that the revenues that we will get for the State of Hawaii will far exceed what we will get from gambling on ships.

"I have written to 230 'Fortune 500' companies that are doing business in the Asian market, in the Pacific Rim, and everyone of them says if we have a telecommunication free zone in Hawaii, they will come and put up their Pacific headquarters in the State of Hawaii, which will mean a lot of jobs, high paying jobs, in the field of high technology. These bills have all been killed! How many high tech bills have made it up to this point? Just a few. Yet, that's the kind of measure we should be voting on today, instead of a gambling bill. The technology of telecommunications is moving fast and we are geographically in the right spot in the whole world to take advantage of it. We should be passing the telecommunication bills instead of passing a gambling bill if we are interested in generating revenues for the State of Hawaii.

"The Judiciary chairman mentioned that more people go to casinos than going to a baseball game. I would rather see families go to see baseball games than going to these casinos to gamble.

"If gambling is such a good idea, then I say, don't restrict it to the ships, put it on the land just like Las Vegas. If it were so good, why is it that I have never seen children in any casinos. The reason why they're kept out is because I don't think gambling is such a good idea.

"As far as I am concerned, today, I am going to vote 'no,' and Mr. President, I would like a roll call vote on this measure. Thank you."

Senator B. Kobayashi also spoke against the measure as follows:

"Mr. President, I rise to speak against the measure.

"An earlier speaker had made a connection between gaming and golfing, suggesting that gaming was a recreational trend of the '90s. I would suggest, perhaps, that for some people, present company excepted, that golf may be a game involving chance. Of course, most of us consider golf a game involving skill, but gaming is never a situation of skill. Gaming is always a situation in which some people lose so that other people may gain.

"Years ago, I had the accidental privilege of speaking to an expert from the Mainland who was visiting the islands, on the topic of substance abuse addiction, specifically, alcohol. And after a bit of conversation, I found him giving me advice about a bill, being discussed at that time, on lottery. I asked him how he knew so much about gambling and he said that it was a hobby of his to learn more about gambling addiction because of his professional interest in substance abuse addiction. He made a great number of very cogent similarities between the kind of addiction involving gambling and the kind of addiction involving substance abuse.

"Essentially, substance abuse and gambling addiction are very real and difficult behaviors to correct. They are behaviors which are basically hidden, oftentimes, from the general public and even from family members. They have some very detrimental effects long before they are fully opened by the individual and known to family members, and once addiction takes root, it is very difficult to undo.

"One of the prior speakers had mentioned that it is not possible to estimate the revenues that might be derived from this bill. Another one of the speakers suggested that perhaps gaming should be studied and that four significant points be determined prior to legislation of this sort is approved. I would note that the legislation before us contains a blank percentage amount for expenses incurred for the administration and enforcement of the gaming board. It is difficult, at this point, to estimate the administration costs of this gaming board and, I would suggest, difficult to estimate the social ill effects of gaming in general to our citizenry. And until we do indeed have a good study of the advantages and disadvantages of gaming, I would suggest we study the issue further. Thank you."

Senator Koki rose again and added his remarks against the bill:

"Mr. President, we have been ranked number fifty in pro-business climate and we have been squeezing businesses till most are suffering and many are giving up. A lack of revenues is not simply from the tourist slump, it is because of our anti-business attitudes and business regulations. The fix is not gambling. The fix is an environment in which business may prosper. The more business prospers, the more taxes they'll pay, the more employees they'll hire and the more taxes they will pay. So I agree with Senator Matsuura, the fix is, it may be a little more difficult, but it takes a comprehensive effort and study to start to promote Hawaii as a place of doing business. Thank you."

"Mr. President, I rise to speak in support of this bill.

"Not only do I want to thank the previous people that the Senator from Hilo thanked, but I think we need to thank Senator Kanno and Senator Ikeda for pushing out those bills and working on them. That's why we're voting on them today. It's a good message of reform that we're sending out regarding the Retirement System. Thank you."

"Mr. President, I'm going to speak against this measure.

"When I saw this bill, I checked to see if there were others in Hamakua who may be interested in bidding for this slaughterhouse facility. I made a few phone calls to the people who were presently involved in the slaughterhouse business in the Hamakua district. There appears to be four other slaughterhouse operators who are interested in bidding for this facility. The major problem that I see in this bill is on page 4, section 3, and it reads:

'The department may negotiate and enter into leases of lands eligible under section 4 of not less than fifteen years but not more than thirty-five years with any person who, as of December 31, 1994, holds a revocable permit for a slaughterhouse and feedlot or for any other agricultural purpose, issued in accordance with sections 166-6 or 171-55.' (Hawaii Revised Statutes)

"I'll give you an example of why I think the language of the bill narrows it down to pretty much one person. I talked to a Mrs. Andrade, and the Andrade family has been in the slaughterhouse business since 1906. Perhaps, they're the oldest slaughterhouse operation in Hamakua. She sent me a set of letters as to what happened to her regarding this property. The first letter was dated June 28, 1993, and is addressed to Mr. Yukio Kitagawa, Director of Agriculture. She saw, at that time, an ad saying that the state will be leasing the slaughterhouse and the feedlot and so on. Mrs. Andrade's letter is informing Mr. Kitagawa that she is interested in leasing the property. Mr. Kitagawa replies to her a few days later, on July 2nd, and he says, 'Yes, it is going to go up for a lease. However, it's going to be a one-year lease, revocable on a monthly basis.' Mr. Kitagawa says 'We will need some commitment of your intent and would like your reply by Tuesday, July 6th,' which was four days later. It just doesn't make sense for anybody to pursue this lease because of the pre-conditions of what one had to do to qualify. The pre-operational requirements for a revocable permit of that facility would have cost hundreds of thousands of dollars. And Mr. Kitagawa, in his letter 'Please study the terms and conditions very carefully. We'll base our selection decision on your reply to those terms and conditions. You should be aware that the improvement and corrective work will require large capital outlays with no guarantee of reimbursement of such expenditures, nor of being selected for the long term lease.'

"No sane person would ever go for a month-to-month lease with the condition that you may not recover a penny of the cost of your improvement. So she didn't. So

another person who doesn't live in the Hamakua district -- a person in Honolulu whose name is Donald Lau -- evidently got the month-to-month revocable permit.

"This bill does favor the person who already has the month-to-month lease. The four slaughterhouse operators were shocked that we were going to vote on this bill today. I called the Department of Agriculture and they told me that it is their intent to go out for bid. I told them that we're going to vote on this bill today and they were surprised that we had such a bill on the docket.

"It would be better not to pass this bill and let the Department of Agriculture go out for bid. This lease has become very lucrative because there are now federal funds to provide for the generators. Senator Inouye also got a military contract for the meat because of the Hamakua situation.

"With all of that background, I feel that it is better that we let the Department of Agriculture continue with its lease procedure and let it go out for public bid. Thank you."

Senator Hagino then rose to speak in support of the measure as follows:

"Mr. President, I rise to speak in favor of the bill.

"I appreciate the concerns of the previous speaker and I think the chair of the Ways and Means, when she passed this bill out, recognized some of the problems or concerns. That's why there is a defective date on the bill, as far as implementation, so this bill will have further scrutiny.

"As far as the section that was cited, section 3 of the bill, unless my ears are wrong, we did have a unanimous vote on a previous bill and that previous bill has almost identical language on that bill. This one has to do with agriculture leases on the Hamakua Coast. In fact, section 3 on page 5 of the previous bill is the exact language that the previous speaker just spoke of. For that reason I urge my colleagues to vote 'yes' on this bill. Thank you."

Senator B. Kobayashi rose in support of the bill and said:

"Mr. President, speaking for the bill, I believe that the current language in the bill simply says that departments 'may' negotiate and enter into leases of lands eligible. I would urge that the department stick to its statement that it is going out to bid and that it indeed go out for bid for these leases. The bill only allows them to negotiate, but if there is a commitment to go out to bid, they can ignore this paragraph. Thank you."

"I hate to be casting 'no' votes, but I think this bill pretty much takes out the sole source bidding process on all the airport projects.

"When we prepared the procurement bill, you have to understand that there was nothing wrong with sole source bidding as one of the procurement processes. going to be situations where you are going to need sole source bidding as one of the bidding procedures. In the procurement bill, we put a lot of conditions for sole source bidding. If we are going to eliminate the sole source procedure from the airport contract, we will be taking away an alternative that one may have to use. don't want all of you to think that sole source contract is a bad, bad, bad thing. When sole source contracts were being given out freely and amendments to the sole source contracts was totally out of control, those were the abuses that should have never happened. Nevertheless, let me just say that all sole source contracts are not altogether totally bad. There is a place for sole source contracts and that is the reason why we kept it in the procurement bill when we passed it. That's the reason why I'm voting 'no' on this bill. Thank you."

Senator Fernandes Salling then rose in support of the measure as follows:

"Mr. President, I have to confess I'm a bit baffled by the contradictory positions that the previous Senator has taken on this issue. To the best of my recollection (I'm speaking in favor of the bill) all throughout the special investigatory hearings that the good Senator held, it appeared that airports and sole source contract, with respect to airports, was indeed one of the big problem areas that we needed to get a handle on. And it was for that reason that we decided, as the committee on transportation, this year, to move out this bill to instruct the Department of Transportation that with respect to those contracts, which I believe the Senator had identified, you are looking at millions and millions of dollars in sole source. With respect to that big problem area, we wanted to insure that this be done fairly and this be done by public bidding and it is for that purpose that we have passed this bill.

"Now, I'm aware that the procurement bill that was introduced by the Senator and worked on with others in this body last year did not address this issue specifically. We felt that based on some of the findings of the investigative committee that it should be addressed, and addressed in this manner, and it is for that reason that I'm urging all of my colleagues to pass this bill. Thank

There is a very close working relationship with Anuenue facilities at Sand Island which is under the DLNR fishery program. In fact, this issue was tabled last year, after overwhelming and unanimous opposition by over 40 industry members, including DLNR and DOA. I just called the DOA today and they don't have the room to house this new program. This bill is moving again this year, despite DLNR and over 30 members of the industry going on record as being strongly opposed to this transfer of responsibilities. I was at the hearing and there was only one person who testified in favor.

"The industry believes that the current organizational placement is working well. So, why change it? The aquaculture development program has grown to a \$20 million a year industry in products and service since its inception. Hawaii is the acknowledged leader in the United States in aquaculture planning and development.

"I see no advantage to this move; I only see significant disadvantages and extreme counter-productive impacts.

Whenever you change and make the move, you will be incurring unnecessary expenses.

"Proponents of this bill say that moving aquaculture to DOA would be consistent with federal policy and that additional resources will be available with the DOA organization.

"In truth, federal aquaculture efforts occur in a joint Subcommittee on Aquaculture, which is located within the President's Office. The U.S. Department of Agriculture is a member of this subcommittee, together with the Department of Commerce and the Department of the Interior. It is implied that this move is needed to access federal resources in the U.S. Department of Agriculture. But this is not the case. Support within USDA can be accessed by aquaculture interests within DLNR right now. And there are no present or future funding advantages by having the aquaculture funding function in the state Department of Agriculture. Furthermore, aquaculture in Hawaii is more closely related to fisheries and the Anuenue facilities on Sand Island which is under DLNR.

"Those who are in favor of this move cite greater resources in DOA. DOA has great responsibilities for agriculture, especially at a time when the sugar industry may be at its demise. Transferring the aquaculture program to DOA, where no resident expertise exists, could mean aquaculture would get lost in the shuffle. It is claimed that DOA has various support programs and services in place. But when you examine closely, most of the support programs are regulatory in nature and have no development interest in aquaculture.

"DLNR divisions provide much more beneficial interactions for aquaculture development activities. DLNR currently oversees state lands and freshwater, coastal resources, fisheries development and restoration of Hawaiian fishponds. The aquaculture development program staff understands and works closely with these vital components of DLNR. The interactions with the DLNR divisions far outweigh the benefits of any closer interaction with DOA divisions, which are largely regulatory.

"DLNR manages the land, water, fisheries and the coastal resources. It is deeply involved in preserving our treasured ancient Hawaiian fishponds, and it should continue to successfully manage aquaculture development for the state.

"Mr. President, we have public hearings primarily so that we can get input from the public and the administration. In this case, both departments, DOA and DLNR, totally oppose it. Everybody who had testified last year, this year, and I'm talking about all the industry people, strongly, strongly opposes this bill. I don't know why we're passing this bill. Why have public hearings? For this reason, Mr. President, I'm voting against this bill and I would request a roll call vote on this measure. Thank you."

At 12:52 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:57 o'clock p.m.

Senator Reed rose to speak against the bill as follows:

"Mr. President, to underscore the comments of the previous speaker (for those of us who recall the previous speaker's comments), approximately a dozen people testified on this bill, Mr. President, and all of them were in opposition. Last year, approximately 65 people testified in the House on this bill, every one of whom opposed this bill. I urge a 'no' vote. Thank you."

Senator Hagino, rising in support of the measure, requested a ruling from the Chair as follows:

"Mr. President, I'm rising to speak in favor of this bill, but before I do so, Mr. President, I would like a ruling on a conflict of interest. I work for Oceanic Institute and some of the comments made about this bill has to do with Oceanic Institute. I am in support of this bill."

The Chair ruled that Senator Hagino was not in conflict.

Senator Hagino continued:

"Thank you, Mr. President.

"First of all, I would like to address that conflict of interest question that arose, and this is part of the reason why I'm strongly in favor of this bill, not because Oceanic is in support, but they did not come out and publicly speak in favor of this bill, knowing the situation. But I rise to speak because much of the comments that were made, also stated that Oceanic was pushing this bill and as I stated earlier, they did not come out in favor or against the bill. I had this thought in mind before Oceanic ever came out with this idea. This has been an idea of mine. To move the aquaculture department to the Department of Agriculture, in my mind, it just makes sense.

"As I continue, Mr. President, I'd like to address some of the points made by the previous speakers. As far as the amount of speakers against the bill, if we are going to go strictly by that rule then the gun control bill should not have passed. I believe the testimony was overwhelmingly against the bill. So as far as the administration being against the bill, Mr. President, we do have three branches of government -- the legislative, the executive and the judiciary -- operating independently of each other. I think that's one of the reasons why, in previous years, we passed the legislative analysts bill, because we recognized that we depend on the executive department a lot for expertise. By creating the legislative analysts we would have an independent frame of view and a different point of view.

"Many years ago, Mr. President, a lot of us talked about the '54 revolution in which there were a lot of dreamers in that '54 revolution and they thought of things that were never thought of before. Now we are recognizing a lot of the fruits of their labor. These people were allowed to dream in '54, and now in 1994, I'm asking my colleagues to allow me to dream.

"This is the third of three bills that hopefully will pass; the other two have passed. One is the agribusiness development corporation, the other is the change of GACC, and this is the third bill. All three of these bills taken together will make the Department of Agriculture a more pro-active department. One of the problems that was cited earlier is that the Department of Agriculture historically has been a regulatory department. These bills will make it a more pro-active department. It will give them the tools necessary to help out the agriculture industry, and hopefully the aquaculture industry also.

"The previous speaker from Hilo talked about aquaculture and if I remember correctly, in the 1980s when we broke in together in the House, he was chairman of the Ocean and Marine Committee at that time. And at that time he talked about playing a part in the 'green revolution,' and now it was time for the 'blue revolution.' Many years have passed since the 1980s and I would like to be a part of that 'blue revolution' that has not occurred

yet. I think that this is one of the tools that will make that 'blue revolution' a reality.

"There's a comment, sad as it is, that if it is not broken, why fix it? I believe that's the same type of comment that was made by the United States auto industry in the 1970s and what it does is it really preserves the status quo. They said the cars that we have in the '70s is what the public wants. Gas is cheap and the public likes big cars. Here we see in the 1990s that the auto industry is in big trouble. Much of the trade deficit that we talk about is because of the trade deficit due to automobiles, and at that time in the '70s the auto industry was not willing to adapt to the situation. I think now we have the possibility of adapting to the situation and putting aquaculture in the forefront by moving it to the Agriculture Department.

"As mentioned, aquaculture in many of the states is in the agriculture department. Eighty percent of the states have it in agriculture. Four out of the top five aquaculture states have their aquaculture in the agriculture department. As mentioned, Hawaii is a leader in aquaculture development. We are not in the top five aquaculture states in the United States.

"Anuenue fisheries was mentioned and Anuenue fisheries will continue; their importance is recognized. It is also important in the fishery components and we're taking out the aquaculture portion. A memorandum of understanding or whatever form it will be taking to be necessary, would continue to have Anuenue resources available through this aquaculture sector. Some of the misinformation that was going around was that the staff will not be hired. We have taken care of that in the bill. We said that existing staff will also move over to the Department of Agriculture to continue the flow that has already started.

"Mr. President, with these items that I just mentioned, I'm hoping that my colleagues will support the bill. Thank you."

Senator Reed, speaking against the measure, then stated:

"Mr. President, I rise to speak in opposition to this bill.

"Mr. President, I realize that decisions are never made behind closed doors in the caucus. I know that my colleagues don't come out here for public debate with their minds already made up. I know that no Senator would vote for a bill that he or she opposes just to go along with the committee chairman or as a favor to a colleague. I know that floor speeches are vital to this process and I know that my colleagues rely upon floor speeches for their decision-making basis. I also know that we can never predict votes. I know, for instance, Mr. President, that we couldn't say that the vote on this particular bill will end up being 13 to 12.

"I'd like to suggest, however, that we consider the numerous calls and faxes we've been receiving suggesting that this bill would put many religious institutions, such as Brigham Young University, out of business, and weigh that in casting our vote on this particular bill.

"Because I know how important floor speeches are, Mr. President, I have thought long and hard about what could possibly be the most persuasive argument I could make to my colleagues who are dependant upon this kind of input, and trying to think of what I could possibly say to urge you to vote against this bill. I have decided that probably the most persuasive argument that I could come up with to urge you to vote against this bill can be summed up in four words -- Rick Reed introduced it.

"In closing, Mr. President, I'd like to also call for a roll call vote. Thank you." $\,$

Senator Tungpalan then added:

"Mr. President, I was going to vote against this bill, but now that I heard that it's Rick's bill, I'm going to vote for it."

Senator Holt rose to speak in favor of the bill as follows:

"Mr. President, speaking in support of the measure, I believe that the members have expressed a lot of concerns because of some provisions in the bill. They've received a lot of phone calls. The chair has received those concerns and in speaking in support of this bill has made a commitment to the members that we will address those concerns adequately and that we would like to keep this vehicle alive. The religious concerns by those religious institutions that were not addressed in this draft, will be addressed if the bill comes back from the House. Thank you."

Senator Chang then said:

"Mr. President, I'm in possession of two letters from colleges."

The Chair interjected:

"Senator Chang, are you speaking for or against the measure?"

Senator Chang responded:

"I will be voting in favor of the measure. However, I do have letters of concern from two major universities in our state and I find their concerns persuasive. I am pledged, and I think the committee chairman and the supporters of the bill are pledged, to working vigorously with all affected institutions to insure that all legitimate concerns and operations of our institutions of higher learning are incorporated into the final product. This preliminary proposal should be viewed as one that raises certain issues for discussion and does not cement the Senate into any position until these issues are appropriately and conclusively resolved. With that pledge, I will be voting for the bill."

Senator Baker also rose in support and said:

"Mr. President, I rise to speak with reservations on this measure.

"I'd like to associate myself with the remarks of the previous speaker, our majority floor leader, because I think he ably expressed some of the concerns that a number of us have on this measure. But, Mr. President, I also know that we're upon a deadline and there is no other vehicle that can be used to address these very important and serious matters. Therefore, I will be voting in favor of this bill.

"It's a measure that is not perfect, but how many of us can say that any bill we've drafted or sat and worked on in committee is ever a hundred percent perfect. There can always be improvements in any complicated measure that we draft. We've been assured that our concerns will be addressed and because I know that the chair of the committee and one of the chief sponsors of this particular measure, a colleague with impeccable integrity, will keep these commitments, I feel reassured in voting for this measure at this time. Thank you."
