He has to handle the restrictions that may come, but I have complete faith in him, I know we all do, and we trust that he will do a fine job because he has done so in the past.

"From the huge amount of positive testimony, I'd like to quote from one of them. This person says:

'In addition to being bright, articulate, hard-working and extremely knowledgeable, his professional integrity is above reproach. Eugene Imai is also a seasoned professional who works well with others. He's one of those rare individuals who not only does everything well, but can and does inspire others to do likewise.'

"And so, Mr. President, I urge confirmation of Eugene Imai as budget director of the State of Hawaii. Thank you."

Senator McCartney also rose in favor of the nominee and said:

"Mr. President, I rise to speak in favor of the nomination.

"I had the pleasure of meeting Mr. Imai when I was working in the Senate back in 1983 and '84 when he was the administrative assistant for Jack Suwa at the Department of Agriculture. Since then, and all the way through working with him at the Department of Education and now at Budget and Finance, he has always been, in my mind, what truly exemplifies what public service is all about. He is dedicated, compassionate, fair and he has a high sense of integrity. I know he is going to do an excellent job in his new position as director of Budget and Finance.

"I urge all the members to support his confirmation. Thank you."

Senator Ikeda, rising in support of the nominee, then said:

"Mr. President, I rise to speak in favor of this nomination.

"I've had the pleasure of working with Mr. Imai, not just as the current director of Budget and Finance but also when he was with the Department of Education, and I must say that I appreciate his straight forwardness and his honesty. I think that he is an excellent nominee and I want to offer my congratulations to him for being the new director of Budget and Finance.

"I look forward to a continued working relationship with him. Thank you."

Senator Matsuura also rising in support of the nominee, then stated:

"Mr. President, I also rise to speak in favor of the nominee.

"A lot of people don't know that Eugene Imai is a general. I didn't know that until he came in with a star. He's not only a good administrator as a finance person, but he is a good general. There are very few persons who make it to a star. Thank you."

MESSAGE FROM THE GOVERNOR

Gov. Msg. No. 252, letter dated March 17, 1994, as provided in Section 9, Article VII, of the Constitution of the State of Hawaii, requesting immediate passage of H.B. 3322, which makes supplementary appropriations and authorization for the expenditure of additional funds in fiscal year 1994 for the payment programs, was read by the Clerk and was placed on file.

THIRD READING

H.B. No. 3322, H.D. 2:

Senator Levin moved that H.B. No. 3322, H.D. 2, having been read throughout, pass Third Reading, seconded by Senator Ikeda.

Senator Ikeda rose in favor of the measure, as follow:

"Mr. President, I rise to speak in favor of this bill, but with some serious reservations.

"Because of the need and the fact that if we don't pass this bill, recipients won't get their payments, we really have no choice in this matter. We need to pass this measure.

"However, Mr. President, as you are aware, an audit done by our legislative auditor is extremely critical of the way the department has handled these payments. There is also a question of whether or not mismanagement has occurred, and whether or not 20 to 30 million dollars have actually been misspent or whether the monies are still in the department's various accounts, as the department claims. There is a real need to clear up all of these questions raised by the auditor in order to ensure that these kinds of discrepancies and errors do not occur in the future. There is also a need for the department to focus on ways to cut down on over-payments, since we generally are not able to recoup over-payments.

"Despite the fact that we have all of these problems that need to be looked at and resolved, we have no choice, as I said earlier, but to approve this \$10 million appropriation so that the recipients of these welfare payments can continue to subsist.

"I would like to say, however, Mr. President, that unless measures are taken to resolve some of these outstanding problems which have been brought to our attention, I will be very reluctant to vote in favor of additional emergency appropriations in the future.

"Thank you."

Senator Solomon then rose in favor of the measure and stated:

"Mr. President, speaking in support of this bill, I would like to support the previous speaker.

"I think that her remarks are well taken. This is a crisis situation and this is a situation that cannot be taken lightly. There's been too many times in the past where the executive has used emergency appropriations as a way of getting the dollars to those that need the dollars, however, we have a fiduciary duty, here in the Legislature, to be sure that these monies are accounted for. Unfortunately, we have this situation that exists in the Departments of Health and Human Services where we sometimes can't make heads or tails as to their budget situation.

"So again, Mr. President, I'd like to urge all of my colleagues that it's time we heed the cautious words of the chairwoman of the Ways and Means Committee in urging our Senate committees to continue to work conscientiously with the respective departments to get the answers that we deserve. Thank you."

The motion was put by the Chair and carried and H.B. No. 3322, H.D. 2, entitled: "A BILL FOR AN ACT MAKING EMERGENCY APPROPRIATIONS FOR THE PAYMENT PROGRAMS," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:
