"Testimony in support of his confirmation was overwhelming. We heard from attorneys who appeared before him who had won cases and those who had lost, in both the civil and criminal courts. All were impressed with his knowledge of the law and the fair treatment they received. His hearing went on for more than an hour because of the volume of testimony presented by attorneys, friends, neighbors, church members and staff members. It was truly overwhelming and reflective of their admiration and respect that continues to grow for this wonderful man.

But needless to say, Mr. President, when I attended the hearing, Judge Acoba I think had close to maybe a hundred, all in support.

"It gives me great pleasure to support his appointment. Thank you."

"Mr. President, I speak in support of Richard Perkins.

"There was an extremely long list of attorneys who sent in testimony in support of Rick Perkins. We heard from his many friends here in the Capitol and his many friends outside of the Capitol, but the most impressive testimony was presented by Darcia Forester, a law student who has worked for Rick and his partner for three and a half years. I'd like to read from her testimony, and I quote:

'I would like to tell you about Mr. Perkins in the context that I've known him. He has been my boss, my advisor, my mentor and my friend. There are simply no words adequate enough to express my deep respect for Mr. Perkins. He is intelligent, competent, thoughtful, dedicated, fair-minded, and he knows and respects the law.

'I've had the opportunity to work closely with him and to see what an outstanding attorney and individual he is. I've watched him prepare legal memoranda for the motions he files in court. I've watched him spend countless hours researching and preparing cases for trial. And I've watched him write numerous appellate briefs.

'Mr. Perkins works hard. I know of no other person who works harder than he does. I've seen him talk to his clients and opposing counsel, usually a deputy prosecuting attorney, and he treats everyone with respect and dignity and is never condescending. I've seen him reduce his attorney's fees for poor clients and I can assure you that he has helped countless people, without asking for or receiving any form of compensation for his time and effort.'

"I know we all know of these attributes of Mr. Perkins and I urge his confirmation. Thank you, Mr. President."

Senator Solomon also rose in support of the appointment and stated:

"Mr. President, speaking in support of this nominee, I urge all my colleagues to vote 'yes.'

"Mr. President, it's going to be the court's gain and the Legislature's loss with regard to Richard Perkins. He has been a tremendous resource force here, in all my years of service. I've always felt that with Perkins, you could get a real fair assessment of the situation. One thing with him is that he never really tells you what to do, he just gives you the pros and cons and you make up your own mind. I think that this is a tremendous quality for a judge. And because of this, I am confident that he will serve Hawaii well. He's truly a 'keiki o ka aina.'

"And with this, Mr. President, I urge all my colleagues to vote in support."

Senator Tungpalan, rising in support of the nominee, then said:

"Mr. President, I also rise in support of Mr. Perkins.

"I surely will miss this individual. There were some very dark times when it appeared that no light could be passed that would be able to deliver us in a manner in which we could serve with integrity, yet he was there to provide the counsel and to give us the balance that really was needed in times, as I said, were very dark for the Senate. To have seen him serve, especially when we were, at times, rudderless, and do so with equanimity and with equality and fairness to all, is something that speaks well of this individual.

"I especially want to thank him because it was he that I turned to when I had been asked to vote a certain way with special consideration of a check. And it was he that

helped me to do the right thing and I shall always remember this individual for that reason. I will be voting with a great deal of pride because he is indeed, not only an able counsel, but a dear friend."

Senator Reed added his support of the nomination and stated:

"Mr. President, I rise also in support.

"You can tell a great deal about a person by how that person relates to members of a minority. Richard Perkins has consistently related to minority members of this body with the same respect that he has with members of the majority. I wholeheartedly support his nomination. Thank you."

Senator Holt also supported the appointment of the nominee and said:

"Mr. President, I'm speaking in support of the nomination.

"Most of you know that he is a Kamehameha alumnus and on that basis alone the vote should be unanimous. Everyone here knows about his professional abilities, but I'd like to take a few minutes to share something I know of him that most of you don't know.

"Going way back to my high school days, I was surrounded by Perkins when I was at Kamehameha -- and that's an understatement! Rick was a senior when I was a sophomore on the baseball team. He was a slick fielding first-baseman and one of the best power-hitting left-handed hitters to come out of the ILH. graduated, I thought I'd seen the last of the Perkins, but I inherited two more Perkins -- David, the next in line, who was an outstanding second-baseman, and Mike, who was a sophomore when I was a senior. Both continued in the ability, same expertise, same outstanding sportsmanship that Rick led. I believe he was the oldest of the brothers that played at Kamehameha. They were all all-stars and all-staters. Additionally, I had Rick's sister, Kathy, as my classmate at Kamehameha. I think she's out there in the audience as well. I haven't seen her in years. Kimo, who I've never had the opportunity to play with, was a little baby when I used to go to Aiea and visit the Perkins family.

"I'd just like to say, based on what I know of the family and their relationship to the community alone, again I state that it's a long tradition of commitment to these islands which Rick will carry on as he sits as a judge at the circuit court level. I wholeheartedly support his nomination and urge all of my colleagues to do so. Thank you."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 23. Noes, none. Excused, 2 (Chang, Hagino).

Senator A. Kobayashi then introduced Judge Richard Perkins, seated in the gallery, accompanied by his mother Mildred and other family members. (Judge Perkins and his family rose to be recognized.)

Ldr. Com. Rep. No. 2540 (Gov. Msg. No. 176):

Senator A. Kobayashi moved that Ldr. Com. Rep. No. 2540 be received and placed on file, seconded by Senator McCartney and carried.

Senator A. Kobayashi then moved that the Senate advise and consent to the nomination of DEXTER DEAN DEL ROSARIO for 13th Judge of the Circuit Court of the

First Circuit, for a term of ten years, in accordance with the provisions of Article VI, Section 3, of the Hawaii State Constitution, seconded by Senator McCartney.

Senator A. Kobayashi rose in support of the nominee, as follows:

"Mr. President, I speak in support of the nomination of Judge Dexter Dean Del Rosario, who drives a nice yellow Volkswagon bug. Judge Del Rosario is such a good, decent person. All of the testimony recited the same fine qualities and in her testimony, Susan Arnett states and I quote:

'As a Lana'i native, Judge Dean Del Rosario brings with him to the bench the experience of growing up in Hawaii and achieving success through diligence and hard work. The respect he has for his own parents' hard work and those of the generations that have come before us is an intangible but very important factor in what makes him such an excellent choice to serve in a difficult, demanding role of judging other persons who come before him.'

"This is Judge Del Rosario, a really fine person, and I urge confirmation. Thank you."

Senator Baker also rose in support of the nominee and said:

"Mr. President, I rise to speak in support of the nomination of Dexter Dean Del Rosario to the Circuit Court of the First Circuit.

"I speak, especially, on behalf of my Lana'i constituents who grew up with Judge Del Rosario and know him to be a man of conviction, integrity and compassion, a child of the plantation community of Lana'i who hasn't forgotten his roots or the values that he learned there. Even though he moved to Maui, then on to Oahu in pursuit of his legal career, Lana'ians felt comfortable calling on him for advice and assistance, and he willingly would fly over to Lana'i to help out.

"Mr. President, the State of Hawaii is fortunate to have talented and able persons such as Dean Del Rosario to offer themselves for public service. I am pleased to share with you the pride that Lana'i has in the ability and accomplishment of one of her native sons.

"I urge all of my colleagues to join me in supporting Mr. Del Rosario's confirmation to the circuit court bench. Thank you."

Senator Matsuura added his support for the nominee, as follows:

"Mr. President, I also speak in support of the nomination.

"Not too many people come out of Lana'i High School to become a judge. As you know, Mr. President, I've been trying for 14 years to write the common sense law for Hawaii and I have failed. In Judge Dexter, I think that we are putting on the bench, somebody that has the local common sense. I've interviewed a lot of judges, but you talk about a local person, that's Dexter. If I'm ever going to face the court, I want Dexter to be the judge. I know that I'll get a fair trial."

Senator Solomon, also rising in support of the appointment, then said:

"Mr. President, I also speak in support of this nominee.

"I'd like to speak in support of the previous speakers' remarks, especially those of our Senator from Maui and Lana'i because I was also very much impressed when the judge came to talk to me. He said, 'You know, Senator, I'm from Lana'i.' And I said, 'Oh, you are? You know the Kapuikis?' He said, 'Oh yeah, I know them.' So right then and there we had a lot of things in common and the thing that impressed me the most is that he really wanted to be a horse trainer before he had aspired to a legal career. We had a long discussion, Mr. President, because dealing with horses and cattle is close to my heart. I was impressed and I said, 'Well, any man that can handle a horse, can handle human beings easily.' So I said, 'In that case, judge, you have my wholehearted support.

"And with that in mind, Mr. President, I'm urging all my colleagues to vote 'yes' for Judge Del Rosario. Thank you."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 23. Noes, none. Excused, 2 (Chang, Hagino).

At this time, Senator A. Kobayashi introduced Judge Dexter Dean Del Rosario, seated in the gallery, together with his wife and children. (Judge Del Rosario and his family rose to be recognized.)

Senator Solomon rose on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"I rise on a point of personal privilege concerning the recent reckless and irresponsible charges levied against the Hawaiian people regarding the disappearance of the ka'ais. Because, make no mistake, when stated publicly with no proof or evidence that a crime has been committed by 'Hawaiians' we're talking -- 'reckless and irresponsible.'

"We're also talking guilt by association and racial stereotyping. In fact, this is the worse kind of racism -to indict a race as somehow inherently composed of thieves. The Bishop Museum should be condemned in the most clear fashion for alleging the commission of a crime -- the theft of the ka'ais -- to a particular race. As you know, Mr. President, there was an article that recently appeared in the paper and now we have Hawaiians assembling in Ho'oponopono for racial and 'forgiveness.' Why? Because we 'cleansing' Hawaiians are all too quick to accept this racial classification. We Hawaiians do not need racial What we need is the courage to set people straight when they engage in blatant racism directed toward us.

"Mr. President, if anybody needs a Ho'oponopono session, it should be the Bishop Museum.

"Thank you very much."
