Senator McCartney rose on a point of personal privilege, as follows:

"Mr. President, I rise on a point of personal privilege.

"I'd like to thank both you and Senator Ikeda, Ways and Means chair, and Representative Ige in helping put together H.B. 3657, H.D. 2. At your direction you also worked with the auditor to invite Dr. Cooper to come down and do an analysis of the Department of Education's budget and expenditures, and I'd like to ask if I may insert some of the auditor's findings into the Journal.

"One of the points I'd like to make to the members is that we are spending over 35 percent in general fund monies to education over general fund revenues. There's a lot of money going into education. I think that we're all concerned on how that money is being spent and whether it's actually getting to the schools or not. That will be the focus of our legislation. I'd like to request that we submit the auditor's findings of Dr. Cooper's analysis into the Journal."

The Chair so ordered and identified the attachment of the auditor's findings as Exhibit "A."

Senator Reed also rose on a point of personal privilege as follows:

"Mr. President, if I may rise on a point of personal privilege.

"An event happened in the last few days, while we were in the midst of debating bringing H.B. 2312 out of committee, that warrants, I think, some analysis by this body, relative to rules that regard media access to the floor. We had a person who claims to have media credentials on the basis of his publishing a newsletter -- a very special interest newsletter -- and on the basis of that publication has access to the floor. What it turned into was not reporting, but lobbying.

"I think this raises the obvious specter of having anybody who publishes a newsletter, whether it is the opposite viewpoint on homosexuality, as this one was, or whether it is the League of Women Voters or MADD or every church bulletin that is published, to have people here who are able to come onto the floor of the Senate and lobby. I'm all in favor of lobbying in the halls, in the office, on the streets or wherever, but there ought to be a line over which the media is not allowed to come in or at least those who are not truly media.

"I would like to ask that the leadership review this matter and look at the rules to see if our rules need to be tightened or look at the possibility of issuing some kind of press credentials so that we really take a look at whether or not those who are posing as reporters truly are. We at least ought to insist that they can offer some pretense of objectivity. The Advertiser and the Star-Bulletin manage to give at least a pretense -- at least until election time. We should demand that at the very least, of those who claim to be representatives of the media when they come onto the Senate floor. Thank you." Senator Solomon then rose on a point of personal privilege and said:

"Thank you very much, Mr. President. I rise on a point of personal privilege.

"Today's Advertiser has a news article concerning the same-sex marriage bill. I hope nothing I said, as your majority leader, gave Bruce Dunford of the Associate Press the impression that the Senate, as a body, had issued an ultimatum to the House over this legislation. I want to make it clear that the Senate would not pass legislation on to the House with such an accompanying ultimatum. The House is our co-equal partner in the public business of this Legislature. We expect and receive the respect due the Senate and we extend the same degree of respect to our House colleagues.

"It is my observation, from my position as your majority leader, that the individual members of your Senate accord the House every respect and courtesy. Naturally. each of us intends and hopes our individual legislative commitment will prevail, but that doesn't mean that we don't value or will not engage in the give and take of the democratic legislative process.

"Thank you, Mr. President."

The Chair thanked Senator Solomon for the clarification.

I'm not so sure, Mr. President, the newspapers and I, for many years, have been going in the same direction and in opposite directions, but on this particular issue, evidently it seems like Mr. Dayton or the newspapers seem to be flies on the walls. Yesterday, after our hearing that we had on the insurance code, my staff was working with the insurance commissioner to address these very important issues -one, to provide insurance fraud -- and it's interesting to note that this morning's paper has articles on the same issues. I find it very, very refreshing to see that the newspapers and I are on the same track.

"I want to inform this body that we are continuing to work on language we hope to include in the insurance code legislation by tonight that will address these very important issues. Thank you."

The Chair remarked:

"I hope that the newspapers will be agreeing with you at the end of this evening." (Laughter.)

Briefing Memorandum on Expenditures for Public Education

The Legislature requested the Office of the Auditor to arrange for the services of Dr. Bruce Cooper to conduct an analysis of expenditures on public education in Hawaii. The Office of the Auditor has been working with Dr. Cooper and the Department of Education to collect and organize expenditure data for the analysis.

Preliminary data is now available that can provide an overview of the total cost of public education. More data is being prepared for Dr. Cooper to conduct his detailed analysis. This briefing is to present the preliminary expenditure data which is shown on the attached pages. Dr. Cooper's detailed analysis is expected later.

The data presented was obtained from the Department of Education, the State Comprehensive Annual Financial Report, and accounting records of the Department of Accounting and General Services.
