Senator McCartney rose on a point of personal privilege, as follows:

"Mr. President, I know it's Friday, but I'd just like to make a point of personal privilege, if I may.

"Mr. President, there's been a lot of debate and discussion about the Senate omnibus bill and I want to be the first to say that I'm very proud of the bill in the Senate. We want to thank you, Senator Ikeda and our staff, who helped put together a good piece of legislation.

"I want to share a point of departure where I think there is a lot of anger and a lot of concern coming from the Board of Education and the Department of Education. The responsibility falls with me, so I want to clarify that for the body. As you all know, I tend to work collaboratively, sometimes called 'Mr. Win-Win,' trying to make everybody happy, and that doesn't always work out. Over the past three years, we strove to be collaborative, 'Mr. Win-Win,' and tried to make everybody happy, and if you look at the record, we've always assumed that the department and the board would internally restructure, down-size, and move personnel to the schools.

"Mr. President, I'm here to report to you that has not happened. It's easy to point blame and say this couldn't happen, that couldn't happen, but we always assume that it will happen, and it hasn't been done. It's like my head has been hitting against the wall and I finally feel the wall, Mr. President, and we have to turn around. We're taking a different direction, and that different direction is challenging. It is not always pleasant; sometimes it's painful, but like giving birth to a new baby, we're going to be very excited about the new baby, but that process of birth is painful.

"Somebody has to assume leadership and move the educational reform agenda forward. What is in our bill is

nothing different that has been talked about for years. In fact, in 1989 the Board of Education talked about putting themselves out of business once we enact school/community-based management.

"Mr. President, there's been a lot of talk; there's been a lot of rhetoric -- there hasn't been a lot of reality. Our educational omnibus bill is drawing the line in the sand and saying we need to move the agenda forward, not to empower the Legislature, not to empower the board, not to empower the department, but to empower the schools. That's what the education omnibus bill is about. The department is not happy. The board is not happy. They're asking people to call you and fax you and tell you that this bill should be killed. I think it's a very good bill, Mr. President. What this bill does is empower schools. This is a departure from the old Mike McCartney of 'Mr. Win-Win' trying to make everybody happy -- it just doesn't work that way.

"Another example of that, Mr. President, is the confusion on the interpretation of the proviso about moving money between budget categories. Again, that was put together in my office when we were trying to move from 17 EDNs to 5 EDNs in one week. That was written between the superintendent, myself, Representative Ige and our staff. Again, I need to assume responsibility for the drafting of that proviso. Representative Ige had one concern. The superintendent had another concern. Who was in the middle? Senator McCartney trying to be 'Mr. Win-Win Collaborative.' What happened? Tremendous miscommunication and misunderstanding from the department's side and from the legislative side. We look at what happens, it's not clear. In our omnibus bill, Mr. President, it will be very clear. We will say that:

1. You cannot move money out of school-based budget, period; and
2. All administrative funds shall be capped at 6.5 percent, and administrative and instructional expenses will be separated so that we can be accountable for the taxpayers' dollars.

We're responsible for raising revenue. We're held accountable for how it is spent. The omnibus bill clarifies things and makes things crystal clear so that misunderstandings about who can move money and who can't move money, and whether it violated legislative intent or not, will no longer exist.

"I want to apologize to the body for writing language that wasn't clear enough because I was trying to be 'Mr. Win-Win,' 'Mr. Collaborative.' I think the time for that is over. We all know what needs to be done. We just have to have the courage to do what is right.

"Thank you very much, Mr. President."

The Chair remarked:

"Senator, the Chair has every confidence in you and the Ways and Means Chair. You'll be convening a conference committee with the House and we hope that the omnibus bill is up for a vote next Thursday."

Senator A. Kobayashi, at this time, introduced Mr. Richard Davi, president and CEO of Kapiolani Medical Center, who was accompanied by his wife and several representatives of the Kapiolani Health Care System. Mr. Davi was presented a Senate certificate and all of the guests were presented leis by various Senators.

At 12:18 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:21 o'clock p.m.

Senator Ikeda then rose to speak on a point of personal privilege and said:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, I would just like to commend the Education Chairman for his remarks. It takes a big person to admit to making mistakes and then trying to correct them. However, I don't really believe that the Education Committee Chair has made mistakes, I think that he has proceeded as one should, in trying to get the opinion of people involved and, working with them. Unfortunately, as you and I well know, this problem has persisted for years, probably longer than he's been alive, and there's no quick and easy solution to this situation that we face.

"However, Mr. President, I think that everyone who is critical of the bill should take a leaf from the Education Chairman's book, that is, to put aside their ego's and in doing so, to focus on what the goal and the results we seek would be -- which is to improve schools and provide our children with a better education. And if we can do that, then I think there will be a meeting of the minds on this bill which will result in not only good legislation, but a vast improvement in the education system as well.

"Thank you."
