The Senate of the Seventeenth Legislature of the State of Hawaii, Regular Session of 1994, convened at 11:45 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Major James Greaser, Resource Management Chaplain, Installation Chaplain's Office, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Ninth Day.

Senator Hagino rose in support of S.C.R. No. 282 and S.R. No. 229, as follows:

"Mr. President, I rise in favor of these resolutions, but with reservation.

"First, I must clarify. I think the last time I did something like this, I ended up killing the Department of Environment, and I don't want to kill this resolution. My reservation is not with the person who this tunnel is going to be named after. My reservation is with the inconsistencies of the Department of Transportation.

"Earlier this year, I had wanted to name something after the late Joe Leong. I went to talk to the family and we thought maybe they wanted the cafeteria at Sunset Beach named after him because he fought long and hard for that cafeteria, but their request was that the Haleiwa bypass be named after Joe. So we asked the Department of Transportation what their policy was in terms of naming highways, and they told us that their policy is not to name highways after any person. After hanging up, (sometimes the light comes on a little bit later) I started to think -- there is a Nimitz Highway; there is a Farrington Highway; and there is a Kamehameha Highway; and also there are other highways named after people. So that's strike one against the Department of Transportation.

"Strike two is this -- now they have this resolution that asks that H-3 be named after Mr. Harano. I don't doubt that anyone who's worked this long and tirelessly for the state deserves some type of recognition, I just hope the same type of thing will be considered for Representative Joe Leong. I understand that the House is passing this same resolution over to us and I hope we will consider naming the bypass for Joe Leong in that resolution.

"Thank you."

Senator Fernandes Salling also rose to speak in support of the resolutions and said:

"Mr. President, just briefly. I can assure the previous speaker that we will take that into consideration. With respect to the naming of the H-3 tunnel, I believe one of the key factors which we should point out is that Mr. Harano is going to be retiring at the end of this year after probably 40-something years of service in the DOT. This is the primary reason for this honor.

"Thank you."

RECONSIDERATION OF ACTION TAKEN

Stand. Com. Rep. No. 3063 (S.C.R. No. 88, S.D. 1):

At 5:27 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 5:29 o'clock p.m.

Senator Koki rose on a point of personal privilege, and stated:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, today's headline reads, 'HGEA strike sweeps state' and the 'Federal Reserve moves to boost interest rates.' At first glance, there seems to be no correlation between these two headlines, but a closer look reveals a very serious problem for a number of Hawaii residents.

"The state Bureau of Conveyances, the government agency that records the transfer of real property, is closed. For the duration of the strike, no one in Hawaii will be able to buy or sell a home.

"The Federal Reserve raised short-term interest rates this morning by one-quarter percent. That increase follows two similar interest rate hikes earlier this year. The result has been a significant increase in mortgage

rates. So it is essential that anyone borrowing money to buy a home complete the transaction as soon as possible.

"I was contacted by a taxpayer earlier today who has been granted a \$300,000 mortgage loan at 7 3/4 percent. He must complete the purchase of his home by Wednesday or be forced to renegotiate his loan at 8 1/4 percent or higher. He will have to pay an additional \$20-25,000 in interest because the State of Hawaii cannot record the transfer of title.

"Other homebuyers and businesses are facing the same dilemma. If the strike continues for a long period of time, interest rates will continue to rise and the financial losses to our citizens will be even greater. Some may even be involved in 1031 exchanges where millions of dollars may be at jeopardy if they do not meet closing deadlines.

"The right to purchase a home is a basic right in Hawaii. It is essential that the state protect that right, even during a strike of government workers.

"I am told that health, safety and welfare are the only criteria for declaring a state service essential. Surely the mental health and welfare of homebuyers qualifies under that criteria.

"It's the state's responsibility to see that essential services are maintained ... that our citizens do not suffer undue harm.

"I've asked the governor's office to declare the bureau an essential service and I urge my colleagues to do likewise.

"Thank you."

Senator Matsuura also rose on a point of personal privilege and said:

"Mr. President, I rise on a point of personal privilege.

"I also read the Star-Bulletin editorial regarding a \$22.5 million appropriation for the interisland airport to make it Hawaiiana. Since the Department of Transportation officials didn't request the funds, it gives an impression to the public that the Department of Transportation doesn't really know for what purpose the money was put in. The last action we just took also gives a bad impression. I have no objections to motorcyclists getting combat wounded license plates, but I think we give the public a wrong perception as to how we make these changes. A resolution gets changed at the last minute on the Senate floor. I don't think there was a hearing regarding the motorcyclist license plates. Except for a very few people, we didn't know what the changes were, and we voted on that resolution. We are giving the public an impression that we do things not following the proper legislative procedures. We're giving the public a cause to be concerned. We should try to avoid these short cut actions because we have enough problems trying to maintain credibility in the Senate.

"Thank you."

Senator B. Kobayashi, rising on a point of personal privilege, then said:

"Mr. President, I rise on a point of personal privilege.

"Relating to the comments of the prior speaker, I too had a call this morning regarding the same matter -- the strike and the closing of the DLNR Bureau of Conveyances.

"The person who called me was an HGEA member who had agreed upon a sale price and interest which was to be increased approximately 4/10 of 1 percent. Comment was made that 4/10 of 1 percent over 30 years is a great deal of money. She was concerned that the bureau was completely closed, not even taking anyone who was willing to wait in line a long time. She, herself as an HGEA member, was willing to personally stand in line and do the recordation if that opportunity was available to her.

"Thank you."

Senator Fernandes Salling also rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege.

"This is in respect to the comments that were made by the Senator from Hilo, Hawaii. According to Senate Rules, this is how we handle the resolutions. I also wish to point out to the Senator that these were issues that were discussed at hearings of which he sat as a member of the committee. These were issues that we could not deal with by passing a bill ... but, however, one which would have to be addressed in resolution form. It was not something unknown to those who attended the hearings.

"Thank you."
