"Mr. President, I have some good news. On February 1st, the Maui High Performance Computing Center hooked up to the National Information Super Highway. Now, what does this mean? The National Information Infrastructure, or NII, of the 90's has been compared to the interstate highway system of the 1950's. However, instead of carrying people and cargo, we will transport information. Government's not going to do this. We are going to attract businesses and private enterprise, and that's what's going on in Congress right now.

"I'd like to also challenge the Education chair. Right now, very few classrooms have basic phone service, but I'd like to challenge the Education chair to see that by the

year 2000, every classroom in the State of Hawaii is hooked up to the Information Super Highway so that every classroom will have an on-ramp to the super highway. Ability to provide on-demand interactive voice, video and data service to every classroom would mean that social and demographic barriers to a good education would be reduced, if not eliminated.

"Interesting enough, Hawaii is the western most stop on the National Information Highway and is therefore ideally situated to be the link between the United States and Asia. Thank you."
