

FIFTY-SECOND DAY

Wednesday, April 20, 1994

The Senate of the Seventeenth Legislature of the State of Hawaii, Regular Session of 1994, convened at 11:36 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Robert Fraser, First Unitarian Church of Honolulu, after which the Roll was called showing all Senators present with the exception of Senator Reed who was excused.

The President announced that he had read and approved the Journal of the Fifty-First Day.

Senator Iwase, with the assistance of Senators Matsunaga, Tungpalan, George, Chang and Hagino, introduced the 1994 Cherry Blossom Queen, Kendelle Chiemi Yamamoto, and her court. The young ladies were presented leis by various Senators.

The President then invited Queen Kendelle Yamamoto to the podium and she addressed the members of the Senate and guests as follows:

"This is the second time this week they've done this to me in telling me to come up and give an impromptu speech. At John Robert Powers they told us how to answer impromptu questions, but not actually give a speech. I think I'm going to write one and stick one in my pocket from now on.

"First of all, I'd like to thank you for having us here today. I know your schedules are very busy but it's a real pleasure to know that we do have the support of the State of Hawaii.

"I'd like to give you a brief agenda of what we'll be doing this year. Besides making appearances around the State of Hawaii, we'll be going to San Francisco, Seattle, Los Angeles and Japan. Basically, our goal for this year's 42nd Cherry Blossom is to take the beauty and the culture of the Hawaiian Islands wherever we go and to share it ... share it with the people on the mainland and in foreign countries because there's a lot about the islands that the people don't know. Also, we'd like to learn as much as we can about the Hawaiian culture, the language and the arts and bring it back to the islands to share it with the local people here.

"I'd just like to thank you again for taking time out of your busy schedules and having us here today. Thank you."

At 11:51 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
