FIRST DAY

Wednesday, January 18, 1995

In accordance with the provisions of Section 10 of Article III of the Constitution of the State of Hawaii, the Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1995, was called to order at 10:00 o'clock a.m., by the Honorable Malama Solomon, Temporary Chairman of the Senate.

At this time, the members of the Senate and guests rose to sing the National Anthem and "Hawaii Pono" led by Ms. Haunani Apoliona, Mr. Jerry Santos and Mr. Wally Suenaga of "Olomana."

The Divine Blessing was then invoked by the Reverend Piula Ala'ilima of the Lahaina United Methodist Church, who was escorted to the rostrum by Senators Baker, Chumbley and Tanaka.

Nominations now being in order for a temporary clerk, Senator McCartney nominated T. David Woo, Jr., seconded by Senator Aki.

Senator Ihara moved that the nominations be closed, seconded by Senator Matsuura and carried.

The Chair declared T. David Woo, Jr., as Temporary Clerk of the Senate.

**MESSAGE FROM THE GOVERNOR**

Gov. Msg. No. 1, dated December 21, 1994, informing the Senate that he appointed Whitney T. Anderson to the Senate, effective December 21, 1994, to fill the vacancy created by the resignation of Mary George from the State Senate, 25th Senatorial District, and pursuant to Section 17-3, HRS, Mr. Anderson's term will expire on General Election Day of 1996, was read by the Clerk and was referred to the Committee on Credentials.

Senator Fukunaga then moved that a committee of three Senators be appointed by the Chair as a Committee on Credentials to examine the certificates of election of the newly elected members of the Senate and to submit a report of its findings to the Senate, seconded by Senator Iwase and carried.

The Chair thereupon appointed Senators Fukunaga, Iwase and Liu to serve on such committee.

At 10:12 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 10:14 o'clock a.m.

Senator Fukunaga moved that Special Committee Report No. 1 be adopted, seconded by Senator Iwase and carried.

The Committee on Credentials was thereupon discharged with thanks.

The Chair, at this time, appointed Senators Matsunaga, Levin and Anderson to escort Chief Justice Ronald T.Y. Moon of the Hawaii State Supreme Court to the rostrum to administer the oath of office to the newly elected members of the Senate.

The Senators escorted Chief Justice Moon to the rostrum and were thereupon discharged with thanks.

Chief Justice Moon administered the oath of office to the newly elected members of the Senate who were standing at their respective desks.

The Roll was then called by the Temporary Clerk showing all Senators present, with the exception of Senator Fernandes Salling who was excused.

Nominations for officers of the Senate being next in order, Senator Grauly placed in nomination the name of Senator Norman Mizuguchi for President of the Senate, seconded by Senator Tanaka.

Senator Holt moved that the nominations be closed, seconded by Senator Kanno.

The motion to close the nominations was then put by the Chair and carried unanimously and the Temporary Clerk was directed to cast a unanimous ballot for Senator Mizuguchi as President of the Senate.

The ballot having been so cast, Senator Norman Mizuguchi was declared unanimously elected President of the Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1995.

At this time, the President addressed the members of the Senate and guests as follows:

"Members of the Senate, thank you very much for the honor you have bestowed on me to serve as your Senate President. Thank you very much for your vote of confidence.

"Governor Cayetano, Lieutenant Governor Hirono, Chief Justice Moon, Mayors Harris, Yamashiro, Kusaka and Lingle, distinguished guests, Members of the Senate, people of Hawaii:

"In recent days the emerging condition of the Hawaii economy and State finances has been discouraging. As everybody now knows, the news is bad. With each new meeting of the money committees, with each new disclosure by the administration, the estimates of our financial shortfall have grown more pessimistic.

"Moreover, our cost of living remains among the nation's highest, joblessness exceeds the national average, and we have just been reminded again by the Council on Revenues that tax returns will not support an expanding government.

"It is a case of hard times and tough choices.

"From a shopping list of hard-to-resist programs, we must select only those that will produce a generous return on investment. Our task is to consider carefully which programs are absolutely necessary and which programs can be curtailed.

"The capital improvements program, for instance, is bloated by previously authorized projects. Some are kept alive by token appropriations year after year, and many have no lapsing dates. The Legislature should look beyond narrow interests and wipe the books clean of unnecessary projects.

"The Legislature should act immediately to establish, with existing personnel, a school construction unit in the Department of Accounting and General Services specifically to fast-track and guide school construction from start to finish. This approach could evolve into a project-staffed system that overcomes the weaknesses and lack of responsibility of the present system.

"The Hawaii Visitors Bureau also deserves our attention because the present commingling of public funds and private contributions prevents proper oversight. We need a system which clearly defines the use of state appropriations. To assure accountability, public funds should be utilized exclusively for advertising and promotion, whereas HVB staff and administration should be supported by private sector funds. It should also be required that the private sector match state funds for additional promotions.

"Last year, we passed the Omnibus Education Act and took a giant step toward reforming the public school system. We hope to see an early initiation of the various reforms of the Act. Meanwhile, this is a perfect opportunity for the business and professional community to help the public schools. For our part, we will encourage school communities to continue the momentum of student-centered reform.

"At the higher education level, we should develop a better funding formula for the University of Hawaii system. One such formula could be the retention by the university of the tuition and fees it collects coupled with a determination of the appropriate ratio of support from general revenues. I will ask our Higher Education Committee to analyze various funding formulas with the aim of providing greater autonomy to the university system.

"The huge increase of Hawaii's prison population poses a critical funding and management problem. Left to conventional wisdom, more prisons would be built but at spectacular costs and with a tremendous drain on our

limited resources. One promising cost-savings alternative is to send longer term and non-resident inmates to mainland states where costs of land, construction, and operations are lower. We should pursue preliminary contacts with those mainland jurisdictions which have expressed an interest in joint prison arrangements with Hawaii.

"However, cost-savings and better management can take you only so far. The State's financial crisis is real, and it must be dealt with.

"Fortunately, there are alternative revenue sources. Every state but Hawaii and Utah has approved some form of gambling as a significant money earner. Lotteries abound. Casinos are everywhere. Riverboat cruises bring in millions. With its large visitor population, Hawaii is a natural for legalized gambling.

"The experience of mainland states supports the view that cruises and shipboard gambling can generate healthy earnings. Shipboard gambling avoids the more common criticisms of legal gaming. It would be conducted offshore, apart from our residential communities. And importantly, it would create more jobs.

"Turning to the counties, I have long believed that the government that spends public funds should also be responsible for raising them. This means that the counties must have adequate taxing powers. I propose that we provide the counties with the authority to levy some form of piggyback on the general excise tax. Let each county decide whether it can hold to the present taxing and spending levels or whether it needs to raise new revenues. And let each county justify its decision to its people.

"When times are hard and choices tough, we also learn anew the importance of the social safety net that we have created over the years -- the combination of direct income, social services and health care that spells the difference between self-respect and bottomless poverty.

"Essential as these programs may be, they nevertheless are costly, especially when the economy falters. Each time recession strikes, we renew the search for less expensive alternatives.

"For the time being, it appears more productive for this Legislature to proceed with local insurance reform, while closely following events in Washington, D.C. Workers' compensation is clearly the most disputed insurance system with business, government and labor searching for solutions and agreement. Reforms should reduce costs without cutting benefits to deserving injured workers and restructure the delivery system to operate more efficiently and fairly. We in the Senate will review the various studies that address the issues of workers' compensation. We will also review the option of triggering the state fund to assist small businesses which are especially hard pressed by the costs of the program.

"Hawaii's expensive auto insurance system plainly requires reworking. A properly-structured system that gives consumers the right to choose among competing insurance programs can offer promise and may offer significant rate relief to Hawaii's drivers. We must explore the programs offered by both a tort-based insurance system, under which drivers would have the right to sue, and a no-fault system under which they would forego law suits in favor of more economical medical and wage loss coverage.

"The Hawaii Prepaid Health Care Act, as good or better than any national proposal, provides almost universal coverage when linked with the State's Medicaid-

based Quest system. Anticipating a lower-quality federal plan, Hawaii should continue to seek exemption from federal legislation and pursue its own improvements.

"Much has been said and done about the housing shortage. For the Senate's contribution to this ongoing debate, I recommend a plan that would have the State provide house lots and off-site improvements, subject to architectural guidelines. Homebuilders could build starter homes and expand at the pace their pocketbooks allow.

"We must also capitalize on opportunities for more intensive use of our costly infrastructure. A case in point is the Aloha Stadium: a sprawling center for sports and entertainment, which is idle much of the time. I recommend that in addition to its current use, we put it to work full time as a combined park-and-ride center with a facility for child care. The result would also be relief from traffic congestion for area residents and the provision for much needed child care services.

"Finally, with respect to the question of Hawaiian Sovereignty, we, as a single state, cannot speak for the whole of this country. But as the people of this State, the homeland of native Hawaiians, we must keep open minds and hearts. This is what Aloha is made of, the spirit that makes this island state perhaps the most coveted place in the world.

"When times are hard and choices tough, sound political judgement is critical. Voters expect more government bang for their electoral buck. The Senate this year is embarking on a new era of openness. Membership in senate committees will be limited, encouraging greater participation. A quorum will be required for decision-making, which will be by formal, recorded vote. In addition, the Legislature should enact important campaign financing reforms that would level the political playing field and reduce the influence of special interests.

"Hard times. Tough choices.

"They test the resilience of this Legislature and measure the resourcefulness of its leaders and members.

"In the unstated agreement reached at the ballot box, we Senators committed ourselves to a high standard of conduct, a greater depth of insight and an added determination to see the public's business done.

"We welcome the challenge. Let us begin.

"Thank you very much."

Senator Liu, Minority Leader of the Senate, then responded as follows:

"Mr. President, Governor Cayetano, Lieutenant Governor Hirono, Chief Justice Moon, the Mayors, distinguished guests, colleagues, and to all who call Hawaii home:

"Revolution!

"Upheaval!

"Monumental!

"Words used to describe a power change that affected all of us here in one way or another. That event? The Democratic Party's legislative victories in Hawaii over forty years ago.

"Like the tales of Beowulf and Maui the Sun God, the mythology surrounding that event has grown, and still

proves to be a potent elixir for the battle weary defenders of the Democratic Party flame...and so the domination continues...for a while longer.

"But unlike in past years, when I and other Republican leaders have given opening day speeches warning of dire consequences should our words go unheeded -- this year there has been another -- revolution -- upheaval -- another monumental change in the political landscape affecting not only Washington, D.C., but our whole nation -- a change so significant that unlike in past years, I can say that although I am a Minority Leader here in Hawaii, I am also today a member of the Majority Party of our country.

"As proof, look not only to the control of both houses of Congress, but, also to 19 state legislatures, tied with Democrats who had control of 24 going into election day; 30 governorships; 15 states where Republicans control both the legislature and governor's mansion, compared to only 7 for Democrats; 472 new legislative seats won by Republicans versus 11 for Democrats.

"And this is not just a case of party labels changing with no impact on the direction of our country. From the macro to the micro, changes will be taking place and debated with unbridled vigor.

"Media coverage will be massive so that every American, who has even only a passing interest in government, will know that changes are imminent. You have mentioned some of them this morning, Mr. President.

"This is the stage and backdrop that the Cayetano administration and legislature's leadership must perform on this year.

"If we address issues on the 'fringes' rather than at the core, the work here will be perceived as and become trivial. Our ability to deal with the transformation of national policies will be crippled; ironic that would be, when the result of those policies if handled well, should lead to unprecedented state control over the use of federal tax dollars within our own communities.

"The people of Hawaii expect that the substance and symbols of change will be delivered to them:

- Accountability and giving government back to the people -- that's what term limits are all about after all is said and done. We need full and open debate and consideration of this issue.
- In time for the next ballot, the people of Hawaii should be able to decide whether or not our attorney general should be elected and free from excessive influence from the executive or legislative branches; free to investigate; free to prosecute those who violate the public trust. Governor Cayetano has supported this idea; let us help him make this a reality.
- We must do whatever it takes to cut the 'paradise premium' or 'paradise tax,' the extra 35% to 40% that we pay to live here compared to the mainland; cut it by at least 10 percentage points in the next two years.
- We must guarantee to the children of this State that no more bathrooms and no more closets will be used as teaching or counseling environments in our public schools.
- It took the Department of Hawaiian Home Lands 74 years to award a mere 6,500 leases to beneficiaries.

And all parties involved -- the state, the federal government, etc. -- should not take more than four years to award the next 6,500 leases to beneficiaries.

"Five years ago, Mr. President, in my last opening day speech I said:

'...large surpluses are dangerous...because they tempt politicians to spend and commit to obligations without knowing what the future costs will be...let people keep their surplus...'

Well, the money was not given back in full, or saved. The extravagances of unnecessary government expansion must now be addressed to the tune of what I think is conservatively estimated at around \$150 million over the next two and a half years.

"The cuts will come, and I applaud the honesty thus far with which the new administration is facing them right now. However, beyond the immediate necessity of the moment, the more important test will be demonstrated by actions, actions to show that it is now understood that government cannot and should not try to do it all.

"A good first step would be to seriously implement the hundreds of management and program reforms recommended by the Legislative Auditor's office over the last ten years.

"A huge leap could be made by listening to the private non-profit and business sectors -- the real engines of real opportunity in the State -- and act on reforms to workers' compensation law and policy that will make it what it was intended to be -- a true cost-effective safety net for the injured worker, instead of what it has become, a wasteful process, a barrier to economic recovery, and a major reason why we are the only state in the union entering 1995 that is losing jobs.

"If we do take on Hawaii's problems in the fashion that I have called for, we will become operationally more coherent, more focused in our goal setting processes, and regain the confidence of the public. And the foundation upon which this will build will be a dynamic economy driven by the private sector and individual initiative rather than one propped up by state government.

"In addition, as I have alluded to earlier, we will be able to take advantage of greater home rule and autonomy, which are finally coming our way from Congress. From healthcare to welfare to housing, this is the direction that Hawaii's governors and legislatures have asked the Congress and the executive branch of the federal government to move in for years.

"In this different atmosphere, fear and denial are our greatest enemies. Indeed, instead of bemoaning minority status, certain members of our congressional delegation should be working more closely with the majority in Washington, and with us, in facilitating this transition.

"Instead of fighting policies, such as NAFTA, supported by the President of their own party, certain members of our congressional delegation should be developing strategies which will aid in constructive outcomes on issues like sovereignty, the future of the military in Hawaii, and the 1995 farm bill as it impacts agriculture and rural development in our State.

"Of course, Mr. President, Hawaii's Republicans stand ready to help in this dialogue with Washington. But the main point is that a reinvigorated federalism focused on giving the states the ability to control their own destinies

is an opportunity that must be grasped with confidence -- not timidity.

"Mr. President, the tenor of the 'Revolution' of 1994, whether one agrees with the basis for it or not, is perhaps best summed up in this statement found in the Contract with America: 'If we break this contract, throw us out.' Perhaps not poetry -- but to the point.

"I ask Hawaii's people to heed this message from our Nation's Capitol in reviewing the work of this Legislature. Be objective, be tough, be demanding. To reach the kind of performance and outcomes I have outlined this morning will require going beyond the normal politics; it will require discipline in sticking to the fundamentals. It will require public scrutiny.

"If this is not done, I believe that history will pass judgement on this period as one of a missed opportunity.

"Much better for it to be written, Mr. President, that we slew the twin serpents of apprehension and fear, and in their place left hope and vitality for a new Hawaii.

"Thank you, Mr. President."

At 10:42 o'clock a.m., the Senate stood in recess subject to the call of the Chair. At this time, the members of the Senate and their guests were entertained by "Olomana."

The Senate reconvened at 11:11 o'clock a.m.

The President, at this time, extended appreciation and thanks to "Olomana" and to Mr. Richard China, their sound technician.

The President then announced that nominations were in order for the office of Vice President of the Senate.

Senator Ige placed in nomination the name of Senator Mike McCartney for Vice President of the Senate, seconded by Senator Tam.

The ballot having been so cast, Senator Mike McCartney was declared unanimously elected as Vice President of the Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1995.

On motion by Senator Baker, seconded by Senator Liu and carried, S.R. No. 2 was adopted.

At this time, Senator Anderson rose on a point of personal privilege and said:

"Mr. President, I would be remiss if I didn't thank the Governor, even though he is not here, for allowing me to serve with such a distinguished group of colleagues, but more than anything, Mr. President, Hannie and I have been discussing it and we'd like to thank you and the Speaker of the House for calling all of these people together to celebrate our 37th wedding anniversary today. Thank you very much." (Laughter.)

The Chair then responded:

"You are quite welcome, Senator Anderson, and I presume that lunch is on you?" (Laughter.)
