#### ORDER OF THE DAY

#### THIRD READING

S.B. No. 1, S.D. 1:

Senator Ikeda moved that S.B. No. 1, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Baker.

At 11:43 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:45 o'clock a.m.

Senator Ikeda rose to speak in support of the measure as follows:

"Mr. President, I rise to speak in favor of this bill.

"Mr. President, for the most part this bill does not reflect any increases, and it definitely does not include increases in House and Senate appropriations. There is a slight increase for the Legislative Reference Bureau, and the largest increase is about eight percent for the Ethics Commission. Other than that, it is a very tight budget --very little change.

"I would like to commend the Legislative Auditor and other offices for restricting their spending and even reducing their budgets given these hard economic times.

"There is one point I would like to clarify, Mr. President. At the hearing there was a question regarding the public access room and how it was to be funded. It was my impression that we paid for it through a joint agreement between the House and Senate and that the funds came out of our budgets. However, because we extended the life of the public access room, we passed a separate bill last year to cover its funding. It is my understanding that you will be introducing or have introduced a bill this year to do the same thing.

"With that, Mr. President, I urge all to vote in favor of this bill."

The motion was put by the Chair and carried, and S.B. No. 1, S.D. 1, entitled: "A BILL FOR AN ACT MAKING APPROPRIATIONS TO PROVIDE FOR THE EXPENSES OF THE LEGISLATURE, THE LEGISLATIVE AUDITOR, THE LEGISLATIVE REFERENCE BUREAU, AND THE OMBUDSMAN," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Senator Solomon rose on a point of personal privilege as follows:

"Thank you, Mr. President. I'd like to rise on a point of personal privilege.

"Mr. President, first I would like to thank our esteemed Minority Leader for the remarks that he made on Opening Day.

"I'd like to quote from the Senate Journal in reference to those remarks, especially those affecting the Hawaiian issues on sovereignty. He says:

"...the political landscape affecting not only Washington, D.C., but our whole nation -- a change so significant that unlike in past years, I can say that although I am a Minority Leader here in Hawaii, I am also today a member of the Majority Party of our country....'

"He goes on to discuss the problems with the Department of Hawaiian Home Lands -- that it took over 74 years to award a mere 6,500 leases to beneficiaries, which, Mr. President, I would like to state at this time, with no help from the federal government. And as of today, Mr. President, we have received no aid from the present administration, especially the Congress, although our President has acknowledged the overthrow of the Kingdom of Hawaii with the 'apology bill.'

"Unfortunately, the new leadership in Congress is starting to backpedal on whether or not it will acknowledge the 'apology bill.' With the acknowledgement of the 'apology bill' we can move forward toward settling trust obligations to the Hawaiians, especially to those beneficiaries of the Department of Hawaiian Home Lands.

"The Minority Leader goes on to say:

'Instead of fighting policies, such as NAFTA, supported by the President of their own party, certain members of our congressional delegation should be developing strategies which will aid in constructive outcomes on issues like sovereignty, the future of the military in Hawaii, . . . '

and so on.

"I would be happy, Mr. President, to transmit to our Minority Leader, Public Law 103-150, which is a Joint Resolution apologizing to the native Hawaiians on behalf of the United States for the overthrow of the Kingdom of Hawaii. It is five pages long and it is quite comprehensive. Most importantly, it sets the foundation for the fact that the federal government recognizes its trust obligations. Mr. President, this resolution was signed by Thomas Foley, Speaker of the House, Robert Byrd, President of the Senate (pro tempore) and approved November 23, 1993, by President Clinton.

"So with our esteemed Minority Leader with a majority status now in Congress, I am hoping that we can count on him to communicate our concerns and ask for his assistance in convincing his colleagues to bring this 'apology bill' to fruition and also ask for an interpretation of their trust responsibilities to the Department of Hawaiian Home Lands and the native Hawaiian population here.

"Thank you very much, Mr. President."

Senator Iwase then rose on a point of personal privilege and said:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, on January 21, 1995, former State Representative Peter S. Iha passed away. He was a member of the First Hawaii State Legislature and he had 71 good years on this earth.

"I had the honor and privilege of working for Representative Iha when the Legislature met at Iolani Palace and was housed in the Armed Services YMCA and also when we moved to the brand new State Capitol in 1969.

"There were many colorful figures in the Legislature back then whose names today fill the history of our Legislature and our State -- such leaders as Elmer Cravalho, George Ariyoshi, Doc Hill, Billy Fernandes, Nelson Doi and Dave McClung.

"Mr. Iha served from 1959 to 1974. He was a quiet and gentle person who shunned the public limelight.

"But he made his mark; he made his contribution to the growth of this State as it moved to open up our society, to break glass ceilings, to provide opportunities, and to obliterate class distinctions.

"We today are the beneficiaries of the sacrifice and work of both the colorful and the quiet leaders of another time -- men like Peter Iha.

"We all, Mr. President, wind our way through life with the help of other people. Mr. Iha was one of the 'Givers' who took the time to help people, and we will remember him fondly.

"Mr. President, at the appropriate time, I would like to request a moment of silence in honor of Representative Peter S. Iha, who leaves behind his wife, Janet; two sons, Arnold and Bobby; and his daughter, Patti.

"Thank you, Mr. President."
