He had a gift of writing and a sense of humor that brought pleasure to all of us.

"Mr. President, I think he wrote some of the best heart-warming Senate certificates. I know a lot of us in this body know Senate certificates are really important because this is how we really touch the people in the community, and Tom really had that knack.

"Tom, I just want to say that we will miss you very much and bid you a very fond Aloha. Thank you."
