

## ELEVENTH DAY

Friday, February 3, 1995

The Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1995, convened at 11:38 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Sister Katherine Theiler, Director, Spiritual Life Center, St. Stephen Diocesan Center, after which the Roll was called showing all Senators present with the exception of Senators Anderson, Fukunaga and Solomon who were excused.

The President announced that he had read and approved the Journal of the Tenth Day.

## MESSAGES FROM THE GOVERNOR

The following messages from the Governor (Gov. Msg. Nos. 114 to 116) were read by the Clerk and were placed on file:

Gov. Msg. No. 114, dated January 5, 1995, transmitting a report prepared by the University of Hawaii pursuant to Act 289, Section 94, SLH 1993, illustrating the programmatic impact of authorized positions and dollar amounts that were restricted by executive order or other restrictions in the previous fiscal year.

Gov. Msg. No. 115, dated January 11, 1995, transmitting the 1994 Annual Report of The Research Corporation of the University of Hawaii, pursuant to Section 307-6, HRS.

Gov. Msg. No. 116, dated January 18, 1995, transmitting a report prepared by the Department of Human Services pursuant to Act 252, Section 56.3, SLH 1994, on the methodology of payment program projections.
