THIRD READING

S.B. No. 87, S.D. 1:

On motion by Senator Graulty, seconded by Senator McCartney and carried, S.B. No. 87, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE RELEASE OF PRETRIAL INMATES," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 21. Noes, 2 (Anderson, Liu). Excused, 2 (Aki, Solomon).

S.B. No. 100, S.D. 1:

Senator Graulty moved that S.B. No. 100, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator McCartney.

Senator Anderson rose to speak against the measure as follows:

"Mr. President, I'd like to speak against the bill.

"Mr. President, I guess I've learned in our sessions that I strongly oppose this bill, being that I've been on the other end. As a Republican of 35 years, having to get a letter from the top level of any party to say that you are or are not a member of that party, I think, is taking things too far. The current law merely says that all you have to do is declare what you are. There are only two people here from the minority party, and let me tell you, it's not easy to say that you belong to a party that is not in majority or even close to it; and that was my decision. I don't think I should have to have a letter from someone who may not even like me. I was a member of this party long before most of the people who are in charge today were members. I have been, if you want to call it, a grassroots member -- I've done the stuffing of envelopes; I've gone door-to-door; I've worked in parades behind the animals to clean up the parade. That's grassroots working!

"As a member of this party, I've spent 14 years as a representative and now to have people say that they're looking for people who are definitely a member of a party, I think that is going too far.

"I am voting 'no' and I hope my colleagues will at least consider it. Thank you very much."

Senator Graulty then rose in favor of the measure and said:

"Mr. President, I rise to speak in support of this bill.

"Mr. President, this is a process bill. I understand and I am very sympathetic to my colleague from Kailua and Waimanalo with regards to the problems he's had or may have had with his party. The point of this bill is that the burden to show whether you belong to the party or not, as you have declared or indicated that you are, really should not fall on the elections officials, but rather on the respective political parties. Now, if the party has stringent rules and one is unhappy with the stringent rules that the party may have in order to declare oneself a member of that party, that is a problem between the individual and that party, not a problem for the elections officials to deal with.

"Under the present law, Mr. President, we have the declaration being sufficient and we saw in the last election some of the problems that this created. The Green Party had an individual who did not subscribe to the principles of that party but advertised himself and campaigned as a member of the Green Party. The only recourse that the party had was to take the individual and the process to court and to sue the lieutenant governor to keep that individual from advertising himself or representing himself to the public as a member of the Green party when that individual did not really subscribe to the principles and philosophies of that particular party.

"So this bill is nothing more than a 'truth-in-advertising' bill, if you will. If you are a Democrat, the Democratic Party ought to be able to say whether in fact you are a bona fide member of the Democratic Party or not; if you say you are a Green Party member, then it is up to the Green Party to be able to certify that you are (or a Republican), rather than letting the elections officials take your word for it and be sued in court in order to determine whether or not you subscribe to the principles and philosophies of that particular party.

"So that is the point of the bill. And while I sympathize and understand where my colleague from

Kailua is coming from, I think that there is good reason to support this bill. Thank you, Mr. President."

At 12:10 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:11 o'clock p.m.

Senator Iwase also rose in support of the bill as follows:

"Mr. President, I rise to speak in support of the bill with reservations.

"Having just looked at the terms, I'm going to support it just to move it along. But I would hope, since we all know what it means to be members of political parties and what constraints each party operates under, that there would be assurances, institutionalized in statutes or rules, that there would be fair and proper procedures to effect this law, and that there would be a fair and effective method of resolving disputes within the party so that individuals are not unfairly left off the ballot. I think it's going to be incumbent upon the parties to have fair rules and procedures. I think it's going to be incumbent upon the parties, the political parties, to insure that there would be no errors in timely submission of letters. I would emphasize that we all know the parties are staffed by volunteers, and oftentimes when you call, at least with our party, you get a tape recorder and I don't think it's going to help on filing deadline to hear a tape recorder.

"So I hope that if we're going to move ahead with a bill like this, and if it's going to be pushed by political parties, that they understand the responsibilities -- the heavy responsibilities -- that are being placed upon them and if they are not able to execute them, that they come forward and ask that this bill not move forward. Thank you."

Senator Anderson rose again and stated:

"Just for clarification, Mr. President, the bill itself says: 'A letter that states that the candidate is a bona fide member of the party from the party's state or country chairperson as submitted in accordance with' If in fact you are not running in an election but you are appointed, as I was, and you have to prove that you are a bona fide member and get a letter, it makes it a little difficult when, in fact, the people on the top are saying you're not in a particular district; you're not this; you're not that. Who then is supposed to come up with that kind of proof? I had a card. I've been a party member. Just because I did not go along with the hierarchy and I did not agree with them, they can send in a letter and say that they no longer want me. This is not an election; it's an appointed deal.

"And this is not merely where you are going to clarify everything. It's making it harder for the administration; it makes it harder for anybody who is running -- anybody who's appointed. And that's why I'm voting against this bill.

"You can put personal differences with Whitney Anderson aside. I'll clear my name; I'll fight as hard as I have to, but I don't think we need a bill that statutorily tells people they can or cannot run or they have to have good relationships with the hierarchy -- and that's what this bill is saying.

"Thank you very much, Mr. President."

Senator McCartney, rising in support of the measure, then said:

"Mr. President, I rise to support this bill with reservations.

"I'd like to shed a little light on when we had the hearing. First of all, I'd like to clarify that the way I understand this bill is not whether the party officials want you or not, it's just to certify whether you are a member of the party or not; not whether they want you. There is a problem, though, of the three major political parties we have, the Republicans did not testify at the hearing. The Democrats did and talked about having loose guidelines about whether people should belong to a party or not. They emphasized that they want everybody and they wouldn't impose that. I think the confusion started when the Green Party was looking at only allowing people that would adhere to their philosophical values and they wanted to have a check on that. I think Senator Anderson is talking about some concerns that may begin to enroll that. We talked about it earlier with the Judiciary chairman. I think we'll continue to look at that to insure there are proper procedures in place and it does not get abused.

"On a personal note, Mr. President, I think it's time we begin to look at the whole elections process to see what role political parties play in the elections process, given the new environment we have here in Hawaii. I think maybe we need to look into the concept of non-partisan elections. This doesn't mean that people would not belong to political parties, would not be active in political parties, and would not be members of political parties, but maybe the elections process itself should be non-partisan rather than having political parties directly involved and limiting voters to choosing one ballot. On a personal level, I think I'd like to begin to look at that model because concerns like this will lead to greater problems down the road.

"Thank you."

Senator Baker also rose in support of the measure as follows:

"Mr. President, I rise to speak in favor of this measure.

"I would like to point out to my colleagues that Senate Bill 100, Senate Draft 1, addresses primary elections --partisan, party elections in which voters select the party ballot of their choice in order to determine who their party's nominees will be. This measure would not have affected appointments to Senate vacancies, a process with which Senator Anderson and I are both familiar. The bill provides a verification process to assure that candidates seeking a party nomination in our partisan primary elections are in fact members of that respective party. It is appropriate, I believe, that the verification be completed by party officials and not by the Lieutenant Governor's office. I urge my colleagues to vote in favor of this measure. Thank you."

Senator Ikeda then rose in opposition to the measure and stated:

"Mr. President, I rise to speak against this measure.

"Mr. President, I wish I could stand here and say I wish to speak in favor of this bill with reservations. I can't do that. I have to say that I'm against this measure. Having been on the receiving end of the kind of criticism which finally drove me to this side of the aisle and knowing fully well how one can be precluded from being a bona fide member of a party because you don't adhere to its platform or its principles in its entirety, I think that this bill would make it extremely easy for a party to disavow or disown any member they didn't agree

with and force them to not run as a party member and therefore run as a non-partisan. That wouldn't bother me, Mr. President, if this bill also changed the rule for a person to run as a non-partisan candidate, but it doesn't. And currently, as the law reads, it's virtually impossible for a non-partisan candidate to make it to the general election because they have to have a percentage of the total votes cast in order to make it to the general. That being the case, we are precluding people from the process by passing this measure and I therefore will vote against it.

"Thank you."

Senator McCartney rose again and said:

"Mr. President, I would like to have the ending statements of the previous speaker's remarks entered as my own. I think that is the problem, for example, for the Green Party situation. They were precluding people because of their philosophical positions. Democratic Party stated they're not going to do that, but that's a potential. The problem is that if somebody wanted to run as an independent, the way our primary election process is set up right now, they would need ten percent of the votes in the election, and because people are forced to pick one ballot, very few people pick the independent ballot because they are voting for the governor and all the other races. So I think if we are going to look at this, we also need to look at ways of allowing people to decide what they are going to do. That's why I think going non-partisan is easier because people can still belong to political parties and campaign on the basis that they belong to a political party, then allow the voters of the community to pick people based upon those political parties and who the person is, rather than being confined to picking up a particular ballot. Thank you."

Senator Levin then rose and said:

"Mr. President, I'd like to raise a question. If the Judiciary chair would yield to a question, I would appreciate it. If not I'll ask a rhetorical question. Will the Judiciary chair yield to a question?"

The President then posed the question to the Chair of the Judiciary Committee and the Chair having answered in the affirmative, Senator Levin continued:

"Thank you, Senator Graulty. The question is this: right now within the Democratic party, candidates are given copies of the party platform and the party resolutions and asked to comment on them. There is no litmus test requiring that one must endorse all the platform positions or all the resolutions. My question is whether in the future, if the membership of the Democratic Party as reflected by a convention, passed a resolution ordering its party chair to require endorsement of all resolutions or all party platforms or certain percentage of all resolutions or a certain percentage of platform planks, could that force the party chair to refuse to submit the kind of letter that is being required by this bill and thereby disqualify the candidate from running as a Democrat?"

Senator Graulty responded:

"Mr. President, in response. The testimony at the hearing was that this is a membership certification procedure. In other words, if you have joined the Democratic Party and you have a party card that says you are a member of the Democratic Party, that's all the letter is supposed to certify. It has nothing to do with substance or position on issues. The matter that is being addressed here is that someone who has not even joined

the Democratic Party or Green Party should not be able to say he's a Democrat or a member of the Green or the Republican Party; so therefore, it's much akin to joining the Lions Club or the Kiwanis Club. You've got to pay your dues and if you've got a card that says you're a member, you're a member. It doesn't mean that you agree to everything that the Kiwanis Club might do or propose to do, but rather it is a certification that you are, in fact, a member of either the Democratic Party, the Green Party or the Republican Party."

Senator Iwase rose again and stated:

"Mr. President, just to follow up on that. I think the problem which prompted my comments is the wording of the bill, it does not set forth what a bona fide member is. I think it leaves a lot of discretion to the respective parties. If it were as simple as sending a letter saying that you have paid your dues and you are a card-carrying Democrat, Republican or Green Party member that's one thing, but it says a bona fide member.

"Going back to what the Senator from the Big Island, Senator Levin, pointed out about adhering to resolutions, there are complaints filed with parties based upon how you voted in representing all of the people in your capacity as a legislator, and subjecting you to penalties, party disciplinary penalties, which I think may intrude or surface into this kind of amendment to the law, broadly worded as it is.

"I am going to support this measure because it has come out and I think I know why it is here. I commend the chair of the committee for at least moving it forward for discussion, but I would hope that if it moves over to the House, there's going to be at least some communication between us and the House that this would be drastically narrowed so that there is protection and there is fairness, and there won't be one or two individuals sitting in somebody's political party chairman's office dictating how we can or cannot vote on the floor of the Senate or the House. Thank you."

At 12:23 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:25 o'clock p.m.

Senator Graulty then rose again and stated:

"Mr. President, I've been listening to the debate of the other Senators, and I understand the problem. The Green Party wants to use the language bona fide to mean a litmus test, philosophically for their party. Democrats, having the great majority of elected officials, are more than happy to assure everyone that they mean certification. The Republicans unfortunately were not part of the debate; we don't really know what their position is. But sometimes it's very difficult to find one word that satisfies all three political parties. And it seems that the problem with this language is the word bona fide meaning different things to different parties. That being the case, Mr. President, since we have the luxury of time on this bill and a singular referral, I'd like to go back to try to find a better word than 'certified' and try to meet some of the other concerns in order to come up with a better bill that we can move on to the House.

"Mr. President, I'd like to ask that we re-commit this bill to the committee for further action."

On motion by Senator Graulty, seconded by Senator McCartney and carried, S.B. No. 100, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO ELECTIONS," was recommitted to the Committee on Judiciary.

At 12:27 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:28 o'clock p.m.

Senator Ikeda then rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege.

"I just wanted to thank the chairman for his sensitivity to this issue and if I can help in any way I'll be more than happy to. Thank you."

Senator Ige, chairman of the Committee on Higher Education, Culture, and Arts, requested a waiver of the 72-hour Notice of a Public Hearing on S.B. No. 1873.

Senator Ige explained:

"Mr. President, we had inadvertantly left S.B. No. 1873 off our hearing agenda. We have informed all of the appropriate parties who might be interested that we will add S.B. No. 1873 to our agenda this afternoon at 3:30."

The Chair then inquired as to what the bill was in relation to and Senator Ige answered: "An appropriation for the main street program."

The Chair then granted the waiver.

Senator McCartney rose on a point of personal privilege as follows:

"Mr. President, it's Aloha Friday so I just want to make a few comments. Senator Graulty has been called 'Senator Grouchy,' and Senator Chumbley has been called 'Crumbly' today. So that's an alignment and I think it's good. Another thing that was good today was that we had a debate on the floor and a discussion. I think there is value to that. We have some good ideas to rework a bill. So I think that was a good opportunity.

"And finally, in Judiciary (it's my first year with Judiciary and it's so exciting to be on that committee) you see a different perspective on things. Today we were able to witness something very special. We had a bill on graffiti about parents being responsible for a juveniles' actions and actually having to pay a fine if they got caught.

"I guess being in the Legislature does a lot of things to people -- it helps people to grow, to become transformed and become new people. Sometimes, sharing your past is very important. We had an opportunity for a Senator to go through a transformation today and that Senator is the good Senator from Hilo. He shared a story about when he was in intermediate school. Now this is the first time this story is coming out, Mr. President, so I want you to know he's a new man. While he was in the Kress Store, he stole a pack of playing cards. I guess he had the affinity for some kinds of adult entertainment that are in the other bills that we have. He stole the pack of playing cards; he got caught; and Detective Kubo came to see shim and asked, 'would you rather spend a night in jail or shall I tell your parents?' The good Senator from Hilo said, 'I rather go jail.'

"I think that had a big impact on his past and that's why he probably ended up being a politician. (Laughter.) His career paths were altered. But today was a big transformation because he went public with it. He actually got fingerprinted and went to jail. I think it takes a big man to come out and admit to his crimes and mistakes so that he can move on with his life. So we'd

like to thank the Senator for doing that and appreciate him for doing so on Aloha Friday."

Senator Levin then added:

"Mr. President, can the record please reflect that I'm the Senator from Volcano, not from Hilo." (Laughter.)

The Chair remarked:

"The Journal will so reflect. Senator Matsuura, would you like to defend yourself?"

Senator Matsuura answered:

"Yes, Mr. President, I have to defend myself because the hearing was on 'Olelo. I don't know if 'Olelo is broadcast to Hilo or not, but now that the Senator from Kaneohe has brought it out on the Senate floor, the news reporters back there have their tape recorders going so I've got to tell the whole story to set the record straight.

"I guess I was in the fifth grade at that time. Yes, I publicly admit that I did grow up in Waialua and did steal a deck of playing cards from the Kress store and got caught. I was put in the police car and taken to the Honolulu police station where I met Detective Kubo. You can imagine what an impact he had on me because I still remember his name to this date. He asked me, 'What did you do?' I said, 'I stole a card.' He said, 'You stole a car!' I said, 'No, I stole a card.' He said, 'What kind of a car did you steal?' So I told him, 'I stole a trump card, you know playing cards.' He said 'Okay, how much were the cards?' I told him and he said 'Oh, you're in bad shape,' because the value of those cards was just about five or ten cents over the limit when the crime becomes more serious. After that, I was fingerprinted and photographed. Detective Kubo then gave me a choice -- whether I would want him to call my parents or spend the night in jail. I told him I'll spend the night in jail because I knew if he called my parents, I would get a good lickings when I got home.

"I want to set the record straight since my political career is already ruined. (Laughter.) I did not spend a night in jail. Detective Kubo saw in this poor, illiterate boy who couldn't read or write at that time, the future of this boy and that someday, although he would be denied entrance into the University of Hawaii because he had the lowest test score for the entrance exam in the entire state, but beyond that turning point, that this skinny boy was going to get a Ph.D. from the University of Minnesota; that he was going to go to India and be a part of the 'green revolution' with Dr. Norman Borlaug who got the Nobel Peace Prize; that he was going to come back to Hawaii and help the Hawaiian homesteaders in Molokai start the Molokai watermelon; and that he was going to end up being a State Senator and head the Senate Special Investigating Committee and end up being the chair of the Human Services Committee (laughter) ... and chairman of the Food Bank.

"Since I made a public confession, I feel much better. (Laughter.) Print everything!"

At 12:37 o'clock p.m., on motion by Senator Ihara, seconded by Senator Liu and carried, the Senate stood in recess until 5:00 o'clock p.m.
