STANDING COMMITTEE REPORT

Senator Fukunaga, for the Committee on Communications and Public Utilities, presented a report (Stand. Com. Rep. No. 460) recommending that S.B. No. 643, as amended in S.D. 1, pass Second Reading and be recommitted to the Committee on Communications and Public Utilities.

On motion by Senator Fukunaga, seconded by Senator Chumbley and carried, the report of the Committee was adopted and S.B. No. 643, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC UTILITIES," passed Second Reading and was recommitted to the Committee on Communications and Public Utilities.

At this time, Senator Ige, chairman of the Committee on Higher Education, Culture, and Arts, requested a waiver of the 72-hour Notice of a Public Hearing on S.B. No. 637 as follows:

"Mr. President, I'd like to request a waiver of the 72-hour hearing notice to hear and have decision-making on S.B. No. 637. This is a short form bill and the purpose would be to flush out the bill and have it recommitted."

The Chair granted the waiver.

Senator Matsuura rose on a point of personal privilege as follows:

"Mr. President, may I speak on a point of personal privilege?

"I was hoping that Senate resolution 16 and Senate concurrent resolution 20 would be up for a floor vote. The reason why it's important to pass both of these resolutions is that all of the public utilities commissioners are going to the NARUC meeting in Washington D.C. next week. I feel that we should have these resolutions passed so that all the public utilities commissioners from all 50 states will have an opportunity to look at our resolutions. (I might as well give my speech in support of these resolutions now, and why I feel they are important.)

"All of us are aware of the State's jurisdiction of the ocean. Hawaii has a 3-mile jurisdiction while other states like Florida, Texas, Louisiana, Mississippi and Alabama have a 12-mile jurisdiction of the ocean.

"I have been trying for the past 12 to 14 years to convince Congress to have a uniform 12-mile state jurisdiction. However, Congress has no desire to extend the State of California's jurisdiction because of the federal revenues that will be lost from the off-shore oil wells in California that are within the 12-mile zone.

"We are all aware of the tremendous economic impact telecommunications has on Hawaii. We may have missed the train to be the telecommunications hub of the Pacific, but it is still not too late to at least try to be the telecommunications hub of the Pacific. A person must be illiterate not to understand the impact of telecommunications on education.

"Harvard and Stanford are known for their outstanding law schools. Hawaii is famous for its excellence in the fields of astronomy and ocean science and technology. We need to share these resources not only within the United States but also throughout the world. This will happen soon with the use of telecommunications as a teaching tool to exchange information to develop excellence in all fields of studies.

"Senate Resolution 16 and Senate Concurrent Resolution 20 are important because for the first time, a state is laying claim to the EEZ looking skyward. When I was in American Samoa, I learned that it was proper for a person to ask permission from the village chief before entering the ocean under his jurisdiction. I asked one of those chiefs how far was his EEZ. His reply was 'As far as my eyes can see.'

"Someone asked me a similar question, 'How far do you envision Hawaii's EEZ to be looking skyward?' My reply was 'From the land beneath the ocean and above the ocean that stretches from Hawaii to Midway Island and looking skyward to where God is.' That is Hawaii's EEZ space.

"The Federal Communications Commission has already generated money in excess of \$4 billion using some of the 50 states' air space. Therefore, it is only fair, proper, and honorable for the federal government to share that new source of revenue with all of the states in the United States for educational purposes.

"These two resolutions are only the first step toward the development of the telecommunications infrastructure to enhance telecommunications as a tool for all the educational institutions in the United States. Thank you."
