"I would like to call everyone's attention to the President's memo regarding how we plan to operate on Tuesday with regards to a consent and an ordinary calendar. Any bills that members want to vote 'no' on or want to speak on will be placed on the ordinary calendar and need to be identified to the Senate Clerk by 5:00 o'clock p.m., Monday, March 6."

Senator Fernandes Salling, on behalf of the Senators, extended Happy Birthday wishes to Senator Solomon.

Senator Liu rose on a point of order as follows:

"Mr. President, I rise on a point of order. Just for the record, in reference to the announcement made by the Majority Leader, I do believe that there will be some leeway should some changes of mind occur based on those reports."

The Chair responded: "That is correct Senator."

Senator Ikeda then rose on a point of personal privilege and stated:

"Mr. President, may I rise on a point of personal privilege?

"Mr. President, I'm a little perturbed by this (I guess you'd call it a) headline, 'House picks up key Senate ally for tax increase.' I would like to make my position extremely clear.

'Given the times that we face and the shortage of funds, we do not have the luxury of precluding or setting aside any kind of proposal that may help to resolve the problems that we face. The \$600 million settlement is just one of those problems, and it is a big one. I think I've gone on record from the very beginning saying that we cannot afford to pay this. However, in the event that the information that we receive compels us to make these payments, we will then have to look at alternatives available to us. And the House proposal -- and that's all it is, a House proposal, at this point in time -- is one of those options. It would be completely foolish for a Legislator to totally disregard a proposal -- any proposal -- at this point in time. I stress this because we are only near the mid-point of this session and we still have a ways to go. There will be a lot of other options and proposals that will be brought up for consideration.

"As you know, I have had some concerns about some of the bills we've had to pass. Among them, gambling; but again because we need to discuss this and because we should not preclude any options available to us in trying to resolve the problems that we face, I'm willing to vote to keep all options open.

"I would also like to take issue with the fact that the Governor seems to believe that we can very easily float capital improvement bonds to cover the debt by paying \$30 million a year over 20 years. I've looked at the CIP figures, Mr. President, and with the current expenditures and commitments that we have made, including the \$180 million that we allocate for educational facilities for the biennium, if we were to add 60 million more dollars of commitment to our capital improvement margin, we would be left with exactly \$8,223,738 for other capital improvement projects for the biennium. Now, I don't know what you can build with that. And may I remind you that this is not for just one biennium -- this is over a 20-year period. \$600 million over a 20-year period paid for by bonds will cost us approximately a billion dollars. So I think that has to be factored into the total equation; \$320 million today versus 40 years of debt and \$1 billionplus.

"I would like the people to understand all of the ramifications of a commitment of this nature and that is the reason why I felt I had to clarify my stand today. Thank you."

At 12:05 o'clock p.m., on motion by Senator Ihara, seconded by Senator Liu and carried, the Senate stood in recess until 5:00 o'clock p.m.
