Senator Matsuura then rose and said:

"Mr. President, just as an update, the Senate is winning the foodbank contest with the House. We are slightly ahead of the House in cash contributions.

"I also have another update on the Senate's FCC resolution. I just received a call from the State of New Mexico and they have also adopted a similar resolution. Our resolution is moving across the country like wildfire. Thank you."

Senator Solomon rose on a point of personal privilege and stated:

"Mr. President, your committee on Executive and Judicial Appointments had a committee hearing this past Tuesday. We had asked the Board of Education to be

present to discuss a situation referring to the school advisory boards. We also asked the Judicial Selection Committee if they would come to update us on the process and procedure. Mr. President, we did have the vice chairman of the Board of Education appear about 10 minutes late and we had no one from the Judicial Selection Commission so I guess they feel that they don't have to come forth and educate us or inform us as to what is happening.

"Because I did not have the opportunity to ask them this question, I would just like to pose the question on the floor. The issue that, as chairwoman, I wanted to discuss with them was why did they advertise for a vacancy of Justice Klein's seat, which is in fact not vacant? I wanted to express that concern to them.

"And another concern I wanted to ask them about was why they do not have a code of ethics, whereas we and other persons serving on different commissions have a code. Why is the Judicial Selection Committee above that?

"These are the kinds of questions I had prepared to ask them, but unfortunately nobody showed up. So I'm going to be talking with our Judiciary chairman and perhaps come up with some kind of resolution which would oblige them to be present. Thank you very much, Mr. President."
