# ORDER OF THE DAY

#### **RE-REFERRAL OF HOUSE BILL**

Senator Solomon rose on a point of personal privilege as follows:

"Mr. President, your Committee on Executive Appointments wishes to report on its progress to date. Yesterday your committee held the first hearings on nominations for cabinet level positions, specifically that of Kathryn Matayoshi for approval as Director of Commerce and Consumer Affairs and of Lorraine Akiba as the Director-Designate of the Department of Labor.

"The committee was particularly appreciative of the opportunity of having testimony from the governor in support of his nominees. We also heard from more than 20 persons, all supporting the nominees. The committee was well satisfied that the first two individual nominees to appear before it are of a high order of competence. The committee has continued the hearings on these two nominees in order to receive more detailed information from them, particularly as to the day-to-day management of the two departments in the context of present budgetary concerns and in context of avoiding any appearance of conflict between past professional association and proposed public duties.

"The continued hearings will be held on April 6, 1995. Thank you, Mr. President."

Senator Anderson also rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, this morning I received in the mail an anonymous letter, if that's what you want to call it, that says -- anything for a buck. And it has my name and 15 other Senators' names on it who voted for shipboard gambling. They also have my now 'infamous' quote. Yes, it says that this was actually said, and I'd like to say that I did say it -- 'We are not here to be moral; we are here to make laws in the best interest of the populous.'

"Mr. President, when we took office, we swore to uphold the Constitution of the United States and the Constitution of the State of Hawaii. Nowhere in either one of these two documents does it say anything about morality. And I'd like to say that I think it was in the wisdom of our founding fathers who wrote these documents. I believe each of us, Mr. President, takes care of our moral obligations at church, in our homes with our families and with our friends. I don't think that we come here to go ahead and do immoral issues, which are private. We are here to do public business and it's for that reason that I said what I said.

"And I would hope that the newspapers, if they are going quote me, would, once in a while when I call somebody an SOB, quote me for that. But no, they went and quoted this. (Laughter.) So in defense of myself and all others, I would again like to say that we are here to do

the business of the people. We are here to make laws that are affecting them and we will keep our morals at home with our families and we will keep it a private matter, I hope.

"Thank you very much for your time."
