Senator Solomon rose on a point of personal privilege and said:

"Thank you, Mr. President. I rise on a point of personal privilege.

"Mr. President, I just want to update you on the actions of your Committee on Executive and Judicial You know, Mr. President, we did Appointments. consider two of the governor's appointments last night. I felt that the hearing proceeded very, very well; I thought the dialogue was friendly; I thought the answers that both the nominees presented were acceptable. However, the committee did have some concerns about a 1995 legislative auditor's report which was directed to the director of DBEDT in which the auditor had brought to light the fact that Dr. Naya, in his new capacity, should be soliciting an opinion from the Ethics Commission concerning gifts from those agencies that have been or will be contracted with. This is in regards to \$152 million that was expended by DBEDT last year. Dr. Naya has assured the committee that he will be coming back to the committee with the appropriate information. This was not only a concern of your committee but we also had concerns from Common Cause and other interested groups.

"The other nominee was Mr. Kazu Hayashida to the Department of Transportation. We asked Kazu what I thought were good questions which he answered very well. However there was one area which the committee felt that we needed further information. He said they'd been developing an inner core within the department to handle a lot of the contracts that are now being given out to the private sector. We wanted to know more about the inner core, so we asked if he could come back to the committee to report on this. I gave him a deadline of April 8th when we will be rehearing Kathyrn Matayoshi, as well as Lorraine Akiba. However, I did advise them that if they could come in earlier with the information we requested that we would consider an earlier time for their rehearing.

"Mr. President, it really concerns me as your chairperson, as to the governor's reaction in view of the committee's hard work. We have gone through the Legislative Auditor's report of recent years to see if the auditor had any concerns about the various departments. We have taken our responsibility very seriously. I wish to reiterate, Mr. President, that I have always felt that these

executive appointment hearings really belong to the respective subject matter committee chairmen because I have felt that they are the ones who will be working with these appointees. They are the ones who really have the questions. I did send a memo to all the Senators this session asking if you have any specific questions that you would like me to ask on your behalf that I would do so.

"I also sent the same memo to the Speaker of the House because I felt that, although the Senate had the confirmation prerogative, the House should have some input. The Speaker was to circulate the memo to his subject matter committee chairmen.

"So I think that as far as your committee is concerned, we have run the confirmation process in a very open manner. It's unfortunate that the governor has stated that the committee is getting involved with, I quote from an article in today's paper, 'little details.'

"Mr. President, I do have a formal response on this matter which I will be submitting for the journal. I just would like to remind the governor that the 'advise and consent' process is a vital aspect of maintaining the balance of power between the legislature and the executive administration. This means, Mr. President, presenting tough questions to the governor's appointees about how they will administer their departments. As for your committee, we have been impressed by the character and background of the governor's appointments who have come before us. However, we have unanswered questions regarding the prospective administration of certain departments. Ŵе have given these appointees opportunities to come back before your committee and to respond more fully to these unanswered questions.

"It has been declared, Mr. President, that the principle of the separation of powers represents probably the most important principle of government, declaring and guaranteeing the liberties of the people, and preventing the exercise of autocratic power.

"It has been stated that no maxim has been more universally received and cherished as the vital principle of freedom. And Mr. President, it's with these kind of thoughts that your committee will be conducting the rest of their hearings.

"Thank you."
