Senator Solomon rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, this is in response to the Honolulu Star-Bulletin article which says, 'Cayetano: It's all Holt's fault.' I feel compelled, Mr. President, as your chairman of the Executive and Judicial Appointments Committee that we just have to clear the air. I think the whole, the whole, situation has gotten way out of hand. I'm going to make exception, Mr. President, in my remarks because as far as what the two Cayetano deputies have said or what was not said, is irrelevant.

"The point that I wish to make, Mr. President, is that the Governor, during his last news conference and even in this article, has stated that I had asked him for a job in his administration, specifically as the head of the Hawaiian Homes Commission or the Department of Agriculture. This is a lie, Mr. President! I never asked Governor Cayetano directly or indirectly for a job. It is very disturbing to me that in response to a question posed by the media, he accused me of using my position as chairman of your Committee on Executive and Judicial Appointments to shake him down. This is a lie, Mr. President. I demand that the Governor immediately subject himself to a lie detector test as I am prepared to do, these tests to be conducted by a mutually acceptable expert. The seriousness of the Governor's charges he has made against me, and now, my committee, Mr. President, requires no lesser response.

"Mr. President, I also want it to be known to you and my colleagues that the postponement of last night's hearing scheduled in my committee was at the expressed desire of the committee as a whole, based on its concern that the Governor's continued improper interference in the business of the Legislature could prejudice the rights, Mr. President, of the various nominees to a fair and impartial deliberation.

"Mr. President, what does this tell us. Is this not, Mr. President, interference from the Executive of our prerogatives and to the legislative process that you have charged your committee to perform?

"In closing, Mr. President, I'd like to assure you and the rest of my colleagues that the intent of your Committee on Executive and Judicial Appointments has been always to protect the integrity of the Senate. Mr. President, I cannot express my disappointment of the Executive targeting my vice chairman for making a motion and my committee members for agreeing to that motion. He is not even allowing us now, Mr. President, to conduct our business.

"Thank you very much."

Senator Baker also rose on a point of personal privilege and said:

"Mr. President, in keeping with the Vice President's idea that Friday should be designated as "Good News Friday," I think it is important considering the events of this week that we have some good news this St. Patrick's Day.

"I wanted to share with you, Mr. President, and all of my colleagues that there was a historic happening on the fourth floor of the SOT this morning when both labor and business organizations came together to support the Senate draft of the workers' compensation bill. I think this a great credit to Chair Kanno, Chair Holt and the members of the committees who have worked very hard and very diligently on this matter. I was very proud to be a part of the vote in support of that measure and would commend the two chairs for their efforts. I know that we go into conference, but I think the Senate can be very proud of the hard work that your committees, particularly your chairs, have done in this regard. Thank you."

Senator Bunda rose on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, I was just reading this article from the Honolulu Star-Bulletin and I know it seems that the feud is between the chairperson, the vice chair and the Governor, but I feel that this is also hurting us committee members. And I feel that by having something like this, blames all of the committee members, and I'm offended as a member, Mr. President.

"I feel that we have been going through this process in a very fair manner and that the nominees were given fair treatment. I commend the chair for bringing this process to what it is, to questioning the nominees and bringing them back because there are concerns, more concerns about some of the nominees. And I feel, Mr. President, that this is a very sad day for the process by having the Executive impeding on our hearings.

"Thank you, Mr. President."

Senator Holt rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege. First, I must apologize to my colleagues here for taking all the ink up this week. It was not intentional by any means.

"Mr. President, the Governor is also accusing me of shaking down his nominees. He's saying that this shakedown is tied to my asking him for a job, 'quid pro

quo', he says. In fact, Mr. President, last night I had sent you a memo which I'd like to read for the Journal:

'Dear President Mizuguchi:

'As a result of this morning's Honolulu Advertiser's article entitled "Cayetano-Solomon's scuffle over patronage remarks," our integrity as members of this body has been seriously questioned. I also believe that an immediate and final resolution of this matter is necessary in order to restore the public's trust and confidence. I am, therefore, willing to submit to an independent lie detector test to verify the accuracy of my previous statements, and hereby request your approval.'

"Mr. President, I never asked the Governor, directly or indirectly, for a job, and I'm begging you, begging you -- I won't get down on my knees -- but I'm begging you to please approve my request to take the lie detector test so we can put this issue to bed and go on with the work of the people. Thank you."
