"Mr. President, I rise on a point of personal privilege. This is good news day. I was surprised that before the foodbank deadline we had so much food brought to my office that it has become a warehouse. Senator Matsunaga was winning up to 4:30 p.m. with the most generous monetary donation of \$200 until the Senate President's check came in at \$500. So let's give President Mizuguchi a hand. "Senator Chumbley wanted to be No. 1 so he brought in extra money, but it wasn't enough to match the Senate President's contribution. I want to thank everybody. The response was just tremendous. Thank you."

The President then thanked the Senators for their kind and generous donations.

Senator Solomon also rose on a point of personal privilege and stated:

"In the spirit of Aloha Friday, Mr. President, I rise on a point of personal privilege.

"I wish to inform this body that your Committee on Executive and Judicial Appointments will be the guest of the governor at dinner tonight at Washington Place. Your committee has accepted the governor's invitation appreciative of his initiative in fostering good relations between the executive and legislative branches. I can assure this body that notwithstanding Governor Cayetano's unique and unprecedented practices of involving himself directly in the advise and consent function of the Senate, this invitation was extended by him and accepted by your committee members in the spirit of Aloha.

"Therefore, Mr. President, it is timely to review Section 5-7.5 of our Statutes which directs us that we should in exercising our power on behalf of the people and in fulfillment of our responsibilities, obligations and service to the people, the legislature, governor and lieutenant governor, contemplate residing with the life force and give consideration to the 'Aloha Spirit' and defines Aloha Spirit for us in these words:

"Aloha Spirit" is the coordination of mind and heart within each person. It brings each person to the self. Each person must think and emotive good feelings to others. In the contemplation and presence of the life force, "Aloha", the following unuhi laula loa may be used:

"Akahai", meaning kindness to be expressed with tenderness;
 "Lokahi", meaning unity, to be expressed with harmony;
 "Olu'olu", meaning agreeable, to be expressed with pleasantness;
 "Ha'aha'a", meaning humility, to be expressed with modesty; and
 "Ahonui", meaning patience, to be expressed with perseverance.

"These are the traits of character that express the charm, warmth and sincerity of Hawaii's people. It was the working philosophy of native Hawaiians and was presented as a gift to the people of Hawaii. "Aloha" is more than a word of greeting or farewell or a salutation. "Aloha" means mutual regard and affection and extends warmth in caring with no obligation in return. "Aloha" is the essence of relationships in which each person is important to every other person for collective existence. "Aloha" means to hear what is not said, to see what cannot be seen and to know the unknowable."

"And with that spirit, Mr. President, your Committee on Executive and Judicial Appointments will be enjoying their dinner with the governor tonight. Thank you very much."
