The Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1995, convened at 11:35 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Alan M. Urasaki, Honpa Hongwanji Hawaii Betsuin, after which the Roll was called showing all Senators present with the exception of Senator Holt who was excused.

STANDING COMMITTEE REPORTS

Stand. Com. Rep. No. 1394 (H.C.R. No. 142, H.D. 1):

Senator Ihara moved that Stand. Com. Rep. No. 1394 be adopted and H.C.R. No. 142, H.D. 1, be adopted, seconded by Senator Liu.

Senator Kawamoto rose to speak in support of the resolutions as follows:

"Mr. President, I rise to speak in favor of these resolutions.

"I appreciate, and am fully aware of the strong and valid reasons of both the supporters and opponents of these resolutions -- Urging the President of the United States, the United States Congress, and the State Legislature to join in a concerted effort in amending the United States Constitution to prohibit the physical desecration of the United States flag.

"As the print, electronic and other media swirl with stories of protests, individual rights, individual freedoms, the pros and cons as to what to call the end of World War II, and our changing times and changing values, there is at least one constant that has withstood, and will withstand, the ravages of war and conflict, as well as the pushing and pulling of various societal values and interests.

"That constant is our United States flag -- the Red, White and Blue -- the Stars and Stripes -- Old Glory -the Star Spangled Banner, if you will.

"By whatever name, for whatever occasion, and yes, even standing silently alone, our flag evokes memories of worthy causes and battles engaged in, brave comrades lost and wounded, and grieving families sometimes left behind -- all endured so that liberty and democracy may live on For all these, as well as any future challenges that may confront us, we must protect our flag and that 'for which its stands' from any form of desecration, especially physical desecration.

"We are very mindful of the constitutional rights and freedoms of speech and expression, and that the U.S. Supreme Court by a 5-4 decision almost six years ago held that burning our national flag was the expression of an idea, and that such expressions are protected by the First Amendment to the Constitution. In that light, unless the court reverses itself, the only way to consecrate and protect our flag from being so burned or otherwise desecrated is to join the other 48 states having memorials to the United States Congress urging action to protect our American flag.

"The VFW Post to which I belong -- Veterans of Foreign Wars, 1st Filipino Infantry Regiment, Post 1572 -- many of whom are veterans of World War II and more recently some of the Filipino veterans who were naturalized in Hawaii, and our families and friends, as well as a very substantial majority of our citizenry, including those who adopted our Country, all look to the U.S. flag as a symbol of freedom, and as the highest symbol of our country, its people, and its values, all of which we were willing to make the ultimate sacrifice for, and for which some or our comrades, indeed, made the ultimate sacrifice.

"Fellow Senators, witness the pride; witness the awe; witness the honor; witness the salutes and hands held over hearts; even witness the tears, when the United States flag passes by every veterans' day parade here in Honolulu, as well as everywhere else in our great country that such a parade is held.

"Every Veterans' Day I myself march with my fellow comrades in the Wahiawa Veterans' Day Parade. I go every year to see a young man with no right arm and no left leg. As we pass him with our flags on California Avenue, he tries to stand at attention and salute with his left hand. Seeing this pride, respect and honor at one glance is worth every pain it takes for this march. My comrades are mostly World War II veterans, as I said, in their 70's. This may be their last fight. Help me to help them to depart a winner.

"On a more personal note, Mr. President, and with heavy heart, but with as much conviction if not more, I have objected to the manner of the apparent involvement of our esteemed senior U.S. Senator from this honorable state who is essentially in opposition to the resolutions before us, and who has written: 'We have resisted the urge to attack the evils of the day by amending the Bill of Rights' and has gone on to say: 'While there have been repeated efforts to amend it, none have succeeded.'

"I say, Mr. President, there is always a first time. And as the old saying goes, 'If at first you don't succeed, then try, try again.' And if I may add -- especially,

especially, when the cause is right, and the time is here to return respect, loyalty and honor to our community, our families, and our way of life.

"As was noted by Professor Patricia J. Williams in her book four years ago: 'Cultural needs and ideals change with the momentum of time; the need to redefine our laws in keeping with the spirit of cultural flux is what keeps our society "alive" and "humane."'

"It is also time, Mr. President, to bring our country together and to rededicate ourselves to the basic elements and beliefs that made us strong. A good beginning, I very respectfully suggest, Mr. President, is by adopting these resolutions, and I humbly request that my fellow honorable colleagues join me in doing so.

"Thank you, Mr. President."

Senator Iwase then rose to speak against the measure as follows:

"Mr. President, I rise to speak in opposition to the resolution.

"I deeply admire the Senator from Waipahu and I wish, in his honor, I could have voted with reservation on this resolution but I cannot. I will be submitting to the Senate Journal a letter from U.S. Senator Daniel Inouye in opposition to the constitutional amendment called for in this resolution.

"Mr. President, I fully realize that this is a highly emotional issue. Our flag was and is a very visible symbol of our country -- particularly in times of war.

"Yet we must never forget that the flag is but a symbol of what our country is all about. And so we must remember what the dream of America is all about. It is not about a cloth, painted with stars and stripes. It is about the principle -- at our country's birth the revolutionary principle -- that exalts the freedom of the individual. Thomas Jefferson stated it with simple eloquence -- that the individual is endowed by the creator with certain unalienable rights: life, liberty and the pursuit of happiness.

"Our founding leaders took great care to insure that this fundamental principle was infused into the great document which guides our nation -- the Constitution of the United States and the Bill of Rights.

"The Constitution and the Bill of Rights, drafted and adopted by a generation which revolted against an oppressive king, is a document which restrains government, protects against the tyranny of the majority, and reaffirms the rights and freedom of the individual. It recognizes that it is the individual and not the government which is at the very core of our society.

"As Jefferson wrote, 'A Bill of Rights is what the people are entitled to against every government on earth ... and what no just government should refuse'

"It is not coincidental, Mr. President, that the very first constitutional amendment, drafted by the generation of Washington and Jefferson and offered in Congress by James Madison, stated, and I quote: 'Congress shall make no law' (I repeat, no law.) 'abridging the freedom of religion, speech, assembly, press, or the redress of grievance.' Our founding leaders recognized, and in the First Amendment, emphasized that these freedoms are at the very heart of a free society.

"Mr. President, I have never, ever, burnt or otherwise desecrated the American flag to protest the actions of my

government. I do not feel happy when I see it done. But I think we must stand up for the right of those protesting in the form they choose. And therefore, I cannot support this resolution which erodes the very principles upon which this country was founded, and which makes this country a special place.

"We are special because individuals have the right to free expression, to dissent, to question, to challenge and to protest against the actions and policies of the government. We are special because the Constitution and the Bill of Rights limit the power of government and protect the freedom of the individual. We are special for these reasons, and not because of the shape, color or these reasons and not because of the shape, color or design of our flag. Our flag is special because it is the symbol of a country which subscribes to the principles of freedom.

"In the words of Senator Inouye, 'It should not be a choice between protecting the Constitution and protecting one of its symbols, the flag. They are one and the same.'

"Mr. President, I agree. The Constitution and the flag stand for the principle that an individual has the right to freely and fully dissent. And my vote today against this resolution is a vote for the Constitution and its symbol -- the American flag.

"Finally, Mr. President, about a year ago, a reverend who gave the opening prayer here at the Senate quoted the writing of a pastor who spent seven years in a concentration camp during Word War II. I think the pastor's writing sums up why we must rise and speak out against any effort which erodes the freedoms guaranteed to us in our Constitution even if the act does not directly affect us at the moment.

'First, they came for the communists, and I did not speak out -- because I was not a communist.

Then they came for the socialists, and I did not speak out -- because I was not a socialist.

Then they came for the labor leaders, and I did not speak out -- because I was not a labor leader.

Then they came for the jews, and I did not speak out -- because I was not a Jew.

Then they came for me -- and there was no one left to speak out for me.'

"Mr. President, today we can and must have the courage to speak out for ourselves, for others, and for future generations on behalf of this unique and honored document -- the Constitution of the United States -- by voting 'no' on this resolution.

"Thank you, Mr. President."

The Chair having so ordered, the attachment of the letter from U.S. Senator Daniel Inouye is identified as Exhibit "I."

Senator Graulty then rose to speak in support of the resolution as follows:

"Mr. President, I rise to speak in support of these resolutions.

"Mr. President, in 1988 the Legislature as the voice of the people of the State of Hawaii passed a law that made desecration of the American flag a criminal offense. In 1989, as a result of the United States Supreme Court decision in Texas v. Johnson, our law was effectively mullified. Mr. President, I want to quote from the dissenting opinion of our Chief Justice William Rehnquist in Texas v. Johnson. He said:

'The American flag then, throughout more than 200 years of our history has come to be the visible symbol embodying our nation. It does not represent the views of any particular political party and it does not represent any particular political philosophy. The flag is not simply another idea or point of view competing for recognition in the marketplace of ideas. Millions and millions of Americans regard it with an almost mystical reverence regardless of what sort of social, political or philosophical beliefs they may have. I cannot agree that the First Amendment invalidates the act of Congress and the laws of 48 of the 50 states which make criminal the public burning of the flag.'

"Mr. President, as a young boy growing up I was taught that the flag was such a symbol of reverence that if I had to, it was important for me or it was necessary for me to keep that flag from touching the ground.

"Mr. President, I grew up in a memorial cemetery where there are 17,000 American dead from the Second World War, and in their silent reverence we respect both them and the flag that they fought to keep flying and the flag that they believed in.

"I went to college in the 60's and there as a college student engaged in public protest and demonstrations. It was a daily occurrence that the flag was burned. Shortly after I graduated from college I had the good fortune to come to Hawaii as an officer of the United States Army and I remember being on duty as the officer in charge at Punchbowl Cemetery and it was my duty then to present the flag to the widows of those who had died. And the words 'I present this flag to you on behalf of a grateful nation' still ring in my ears.

"Mr. President, ours is the only nation on earth that allows people to burn its national symbol without pain of prosecution or penalty. In Singapore they hang people for burning the flag.

"Mr. President, I'd like to quote again from the dissenting opinion in Texas v. Johnson because I feel that my sympathies lie with them. Justice Stevens wrote:

'The court is therefore quite wrong in blandly asserting that respondent was prosecuted for his expression of dissatisfaction with the policies of this country expressions situated at the core of our First Amendment values. Respondent was prosecuted because of the method he chose to express his dissatisfaction with those policies. Had he chosen to spray paint -- or perhaps convey with a motion picture projector -- his message of dissatisfaction on the facade of the Lincoln Memorial, there would be no question about the power of the government to prohibit his means of expression. The prohibition would be supported by the legitimate interest in preserving the quality of an important national asset. Though the asset at stake in this case is intangible, given its unique value, the same interest supports a prohibition on the desecration of the American flag.

"The flag is not just an opinion for which there are pros and cons. It is our national symbol worthy of respect of everyone who calls himself an American. How can our government conscript men and women into the armed forces where they must fight and perhaps die for the flag and the government not prohibit the public burning of the banner under which they fight.

"Mr. President, I urge all my colleagues to vote 'aye' on these resolutions.

Senator Matsuura rose in support of the measures as follows:

"Mr. President, I rise in support of these resolutions.

"Resolutions usually have the right or the wrong vote, but this is the only time that I know of where there is no such thing as a right or a wrong vote. In this situation there is only the right vote. I don't care how the vote is going to come out but whatever the vote is it is always the right vote.

"In caucus I heard the comments made by the Senator from Waialua (as you know, I'm also from Waialua), when I listened to him I didn't realize that one of his duties in the Vietnam war was to collect some of the casualties and I can understand why he's going to be voting for this resolution. The first casualty of the 442nd was from Waialua. For me personally and I speak on a personal level, the Bible, the Koran, the teachings of Buddha, or any of those religious documents are sacred. Even though I am not a Buddhist, their scriptures are sacred. I respect every flag of every nation. I think it symbolizes the heart of a nation. It is not a piece of cloth. It represents more than that.

"The national anthems of every nation are also very special. At the Olympics, when they raise the flag and play the national anthem of the gold medalist, I respect not only the athletes, but also the country the athlete represents -- the national anthem and the flag.

Senator Matsunaga, rising in opposition to the measures, then stated:

"Mr. President, I rise in opposition to these resolutions.

"I oppose these resolutions for two reasons: (1) a constitutional amendment is unnecessary and (2) a constitutional amendment would diminish the very freedom it is trying to protect.

"A constitutional amendment is unnecessary and unwarranted when we look at the facts. According to the Chicago Tribune, The Citizens Flag Alliance (and we are fortunate to have members of that organization here today) admits that since 1990, there have been only three incidents of flag burning in this country. As U.S. Senator Bob Kerry stated, "There is simply no line of Americans outside [the Capitol] or in this Nation queuing up to burn I ask you, are there more incidents of flag burning or homeless people in this State? Are there more incidents of flag burning or battered women in this State? Are there more incidents of flag burning or neglected children in this State? Flag burning simply is not a As Senator Kerry growing state or national crisis. concluded, "The fabric of America is not threatened by flag burners."

"A constitutional amendment would diminish the very freedom it is trying to protect. What are we trying to accomplish here? What are these resolutions trying to do? I believe that they are attempts to show how much we love our country, and I do commend the supporters of these resolutions for their patriotism. But the irony in this is that we love our country because of the freedoms we enjoy -- freedom of speech, freedom of religion, freedom from unreasonable search and seizure. And we embody these freedoms in the American flag. Yet a constitutional amendment prohibiting desecration of the flag would actually diminish the very freedoms and liberties for which the flag has stood for over 200 years. Protecting the flag by suppressing those freedoms suggests that we value the symbol more than the substance. As the

Supreme Court stated in 1990, 'Punishing desecration of the flag dilutes the very freedom that makes this emblem so revered, and worth revering.'

"For these reasons, Mr. President, I ask my colleagues to vote 'no' on these resolutions." $\,$

Senator Anderson rose in support of the measure as follows:

"Mr. President, in the essence of time would you please incorporate Senator Kawamoto's remarks as my own, and also Senator Graulty's."

The Chair so ordered. Senator Anderson continued:

"I will be voting in favor of this. I wrote no speech but I would like to remind people that what the good Senator from Mililani said is true. It is a document that we are trying to change. That is all it is, it is a document. And when you have a minority group that I believe that document took care of that now takes over what the majority believes in, it's time to change that document.

"When I went to school, I took a pledge of allegiance to the flag every morning and we watched it go up over Lincoln School. And as the good Senator said, when it came down it never touched the ground. We were also able to do prayer. We did a lot of things that minority groups today say are wrong and they have a right under what all of these people fought for. So I will be voting 'aye' and I wish that the rest of my colleagues would too.

"Thank you very much, Mr. President."

Senator McCartney, also in support of the resolutions, then said:

"Mr. President, I rise to speak in support of the resolutions.

"Mr. President, I have been wrestling with this and I know it's a very difficult decision for every member. I am just sharing my personal position on this and it really is intellect versus emotion -- the head versus the heart argument. And in any strong country, we must balance and coordinate the head and the heart and ensure that we have freedom for everyone.

"Mr. President, I grew up with the motto 'Duty, Honor and Country' and I believe that however people vote on this resolution, there is no right, there is no wrong. I think everybody in this chamber loves this country and respects all of those who went before us to fight for the freedoms that we have. So in any way the members vote is not a reflection on any disrespect for people.

"In my generation, Mr. President, I have been very fortunate that I never had to face the threat of a draft in Vietnam and to go to Vietnam. My year was the last year. They even cancelled out registration so I never had to register. My generation has been very lucky everything that we enjoy today has been handed to us. We never had to go through the trials and tribulations of maybe some of the people a few years before me who had to go to Vietnam to fight for a cause. And I'm very grateful for that.

"Today ten bodies just came back from Vietnam (missing in action) and their coffins were draped with the American flag, and as Senator Graulty has said, when any veteran dies, there at the funeral ceremony a flag is given to the family on behalf of the President and the country for the supreme sacrifice that they made.

"Also Mr. President, in 1993 I had the chance to go to France and visit one of the most historical battlefields, the Battle of Biffontaine and the Lost Battalion. I went there with Mayor Henry of Biffontaine and we walked into the forest where over 350 Hawaiian soldiers died rescuing 45 members from the Texas Battalion that were lost in the hills. And to this day I hear stories about the battle and about the sacrifices made there.

"So, Mr. President, for me it is difficult to turn my back and just look at the intellect. I need to look at the emotions. And today I cannot allow my intellect to overpower the spirit of gratitude and respect I feel in my heart for those who gave their lives for my generation.

"Thank you, Mr. President."

The motion was put by the Chair and carried, the report of the Committee was adopted and H.C.R. No. "HOUSE CONCURRENT entitled: 142. H.D. RESOLUTION RESPECTFULLY REQUESTING CONGRESSIONAL HAWAII'S **DELEGATION** AN AMENDMENT TO THE UNITED SUPPORT CONSTITUTION TO PROHIBIT STATES THE WILLFUL PHYSICAL DESECRATION OF THE UNITED STATES FLAG," was adopted.

On motion by Senator Ihara, seconded by Senator Liu and carried, the report of the Committee was adopted and S.R. No. 1780, H.D. 1, and the request for a conference on the subject matter thereof, the President appointed Senators Ikeda, chairman, Baker, Bunda, Fernandes Salling, Fukunaga, Kanno, Kawamoto, Solomon, Tanaka, Taniguchi, Liu as managers on the part of the Senate at such conference.

At 1:12 o'clock p.m., on motion by Senator Ihara, seconded by Senator Liu and carried, the Senate adjourned until 11:30 o'clock a.m., Thursday, April 13, 1905

Dear Senator Iwase:

Thank you for your inquiry regarding two resolutions, urging the President and the Congress to amend the U.S. Constitution to prohibit the desecration of the U.S. flag. I am pleased to share with you my position on such a constitutional amendment.

For two hundred years, our Bill of Rights has endured. It proclaims that the government of the United States is limited in its powers, and it continues to instruct and inspire people throughout the world. We have always found the strength necessary to live within its limits. We have resisted the urge to attack the evils of the day by amending the Bill of Rights. While there have been repeated efforts to amend it, none have succeeded. I do not believe that this is the time to tamper with the First Amendment, and, as difficult as it may be, we must insist that the suppression of dissent is a greater danger than the destruction of the flag.

It is not always easy to serve a country with a Bill of Rights that defends the rights of those who would destroy it. No other nation dares to make the commitment to freedom that is embodied in our Constitution. As a veteran and patriotic American, I am offended to see protestors burning the U.S. flag in their demonstration against the government. It grieves me to read of a renewed Neo-Nazi, Klu Klux Klan movement. I try my best to see in them our unrivaled commitment to the First Amendment's freedom of expression and speech.

I believe that what we hope to achieve -- protection of the U.S. flag -- can be accomplished through other means. Even if we enact no new laws, the sacred symbol of our flag will continue to be protected. I say this because perhaps, we have in the past relied too much on the law to protect our flag. For every person who would burn the flag, there are thousands of people who fail to salute it, or fail to teach their children to love it. No law can demand that Americans respect this national symbol -- whether through statute or constitutional amendment. Education, through example and instruction, is the best way to express and continue to ensure reverence for our flag. I am committed to this end. This is where we, as lawmakers, should place our emphasis.

Brave men and women sacrificed their lives in defense of our nation's principles of freedom, democracy, equality and justice for all. It should not be a choice between protecting the Constitution and protecting one of its symbols, the flag. They are one and the same. Our love of country is strong enough to withstand the voices and actions of those who would speak out and even abuse that which we hold dear.

I hope my explanation provides you with some insight into this most emotional issue, and helps you to focus your attention in the remaining days of the session on the most pressing issues of the day.

I pray that our stars and stripes will continue to fly over the land of the free and brave.
