Monday, April 17, 1995

The Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1995, convened at 11:31 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Major Jeffery Young, Fort Shafter Community Chaplain, after which the Roll was called showing all Senators present with the exception of Senator Holt who was excused.

The President announced that he had read and approved the Journal of the Forty-Ninth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Fernandes Salling introduced Bonnie Honma, Kauai coordinator of Hawaii's Annual Career and College Fair. Ms. Honma was presented a Senate certificate and a lei.

Senator Chumbley then introduced Linda Holt, Hawaii's 1995 State Teacher of the Year, who was accompanied by the principal of Haiku Elementary School, the Maui District Superintendent, and her husband. "Furthermore, Mr. President, he was recognized for his willingness to make controversial and difficult decisions and his ability to accept challenges. Your committee believes that these characteristics are critical at this time of fiscal austerity.

"With that, Mr. President, I am recommending to you and the rest of my colleagues to vote in the affirmative. Thank you."

Senator Solomon rose to speak in favor of the nomination and said:

"Mr. President, I'm speaking in support of Gov. Msg. No. 138.

"Ms. Akiba's legal career reflects her commitment to public service through her participation with the American Arbitration Association, the gender and other fairness committees of the State Judiciary, the Environment Council, the Hawaii Women Lawyers, Hawaii Women's Legal Foundation, as well as authoring and editing legal manuals in the fields of hazardous waste and women's rights. Although, Mr. President, her prior experience has not exposed her to a wide range of labor issues, as director designate, Ms. Akiba has proven herself to be a quick study as she has proceeded by diligently addressing one of the department's most challenging issues, the workers' compensation system and related policy.

"The testimony also indicated a broad base of support for Ms. Akiba, including labor unions, private businesses, the legal community, and various community organizations with which she has worked. This diversity of support is important to the mission of the department and in ensuring that state policy is implemented fairly and in response to the concerns of all the various constituencies.

"With that, Mr. President, I recommend to you and my fellow colleagues a positive confirmation. Thank you."

Senator Kawamoto also rose in support of the nominee as follows:

"Mr. President, in respect to the chair and her hard-working committee, I will be voting 'aye' with a concern.

"Throughout the legislative process I have been disappointed with the department leadership's effort or lack of effort to sustain the 17 transition centers in our public high schools. Many of you have voted for these transition centers in the high schools out of response to our President of the United States requesting that we look at the forgotten 50%. Currently, these transition centers are servicing 25,000 students. At the end of this year we may lose many of these transition centers. One hundred and thirty-three out of one hundred and thirty-four students came from public schools all over the State of Hawaii requesting that transition centers be made a curriculum or a service throughout all the high schools. I'm hoping that this vote will encourage the administration, the Department of Education and the Department of Labor to work together to look for federal funds under the school-to-work assets that we have out there and to retain these 17 transition centers in the state.

"Thank you."

At this time, the Chair ordered that remarks by Senator Matsunaga in support of the nominee be inserted into the Journal.

Senator Matsunaga's remarks read as follows:

"Lorraine Akiba comes to public service from a distinguished career in the private sector. She is an honors graduate from the University of California at Berkeley and Hastings College of Law. Since 1981, she has worked as a litigation attorney at the law firm of Cades Schutte Fleming & Wright. She served as the President of the Young Lawyers Division of the Hawaii State Bar Association, and was also President of the Hawaii Women Lawyers Foundation. She was also Vice President of the National Conference of Women's Bar Associations and a member of the Board of Directors and Treasurer of the Hawaii Institute for Continuing Legal Education.

"The productivity and prosperity of our state's workforce will be defined by the visions and tenacity of Lorraine Akiba. As Director of the Department of Labor and Industrial Relations, Lorraine Akiba will apply what is known in law as the balancing test -- the balancing between the interests of labor and management, between workers' skills and market demands, and between job security and fiscal constraints.

"In addressing these interests, Lorraine Akiba has stated her commitment to excellence and professionalism, to streamlining and efficiency, and to an equitable and effective union between the private and public sectors.

"I commend Ms. Akiba on her noble commitment, and look forward to working with her in fulfilling these goals."

At this time, Senator Taniguchi, for the Committee on Agriculture, Labor, and Employment, requested a waiver of the required hours of notice for a public hearing on H.C.R. No. 151, H.C.R. No. 210, H.C.R. No. 341, H.C.R. No. 153 and H.C.R. No. 312, and the Chair granted the waivers.

Senator Anderson rose on a point of personal privilege as follows:

"Mr. President, I'd like to stand on a point of personal privilege.

"I don't want my colleagues to get upset because of what I am going to say, but this is concerning some editorials that we had and I have been reading. This started last week Friday and I am still a little upset. One of them is about the flag burning, another is on the newspaper disclosure bill, and the other is from this morning on the Bishop Estate. The thing that really bothers me, I think, Mr. President, and again I hope my colleagues will go along with this, is that on Saturday the Advertiser had 4" x 5", roughly, for the flag burning and this morning it was 5" x 5" for the Bishop Estate, 'Wrong call at Legislature.' However, for the newspaper disclosure bill it was roughly 10 1/2" x 5".

"That sort of bothers me that they are doing that, but I think more than anything else, Mr. President, in the flag burning they more or less say that there is absolutely no reason for a resolution or a constitutional amendment. And yet, for the Bishop Estate this morning, they're saying that the Bishop Estate has really no business...that it's a private entity and the public's business who runs it. The Bishop Estate says that they should have no say into it. And down here, they're not sure and that's too bad, leaving the selection of trustees up to the courts and they feel that it's a 'very powerful, very influential' land holder.

"But for the newspapers, they believe that we are wasting our time and taking swipes at them, and that the exemption was granted because the Advertiser failed as a newspaper at that time. They also believe that it is erroneous that the anti-trust exemption should be cancelled because they could go back into being a failing newspaper and that Congress should have included this if they were interested when they did the Failing Newspaper Act. But no one, I think, realized that the failing newspaper was going to take 20 years, nor did they believe that it was going to sell for \$250 million. And then when they want to hide behind the First Amendment, they say that they are entitled to equal protection under the law and that they have a First Amendment right.

"Well, they also pay nothing for using public property. They make money putting their newspaper stands out on the sidewalks that they use public funds for. When I was running for mayor, it was my understanding that the people out in Waikiki had to pay no more than the Advertiser and Star-Bulletin and the rest of the newspaper people for their stands. Our Mayor today, Jeremy Harris, said in fact they pay nothing. He was at the same Lions Club meeting that I was at Downtown and he said they pay nothing at all. And I said, 'then I think that I would like to be mayor more than ever before because I think they should pay like everybody else.' They are making a profit.

"And for that reason, I've decided to stand this morning on this First Amendment because I don't think it is fair that they call us names and they say that there is no need for having an amendment to the Constitution for flag burning or anything else. And I believe that when the minority rules and the majority loses, it is a very, very bad time in history because people are using the First Amendment. I don't think our forefathers meant for anybody to use the First Amendment to burn flags, to not pay taxes, or to be able to get away with doing whatever they want to, because when they wrote the Constitution, it was broad. I don't think that the attorneys in those days wanted to have the Constitution used the way it is. So that's why I'm standing today. I have no problem at all with the newspapers writing down the facts. I believe in freedom of the press and I just think that it is a shame that they can use the Constitution when they want to.

"Thank you very much, Mr. President."

#### ADJOURNMENT

At 12:12 o'clock p.m., on motion by Senator Ihara, seconded by Senator Liu and carried, the Senate adjourned until 11:30 o'clock a.m., Tuesday, April 18, 1995.
