Amendment rights or because of some unhappiness on anyone's part with regard to their editorial comment. This is simply an attempt to determine whether the basis for which the monopoly that was granted by Congress should continue to exist and to provide a mechanism by which that information can be provided to the government—both the state government, which is also representative of the taxpayers and the citizens of the state, as well as the federal government.

"It has been pointed out that this is a federal exemption that is involved. But the state government does get involved in many federal matters and provides advice and information to Congress on a variety of issues. It is important that the state exercise its proper oversight role when it comes to the profits and the continued monopoly that has been granted by government to our two major daily newspapers. And it is in that light that this bill has arisen and made its way through the legislative process.

"Again, Mr. President, this is a bill not about editorial opinion; this is a bill about profits. This is a bill about a monopoly and whether there is a continued basis for that monopoly to continue or exist. It is also about this Legislature exercising its proper oversight role and receiving the information that it needs in order to assist Congress in formulating a good policy in this particular area. I therefore urge my colleagues to vote 'aye.' Thank you."
