"Mr. President, I'm urging all my colleagues to vote in the affirmative. We received testimony in support of the nominee that indicates Dr. Milke has a broad base of community support, including representatives of native organizations, Hawaiian private health organizations, social welfare advocates, individual health care providers, and public health associations. The testimony also indicated that Dr. Milke has been a dedicated public servant, working to advocate for improved health care services for the less fortunate members of Hawaii's community, and possesses the necessary medical and legal expertise to administer the department.

"As you know, Mr. President, your committee members diligently questioned the nominee regarding his administrative qualifications, his visions and priorities for the Department of Health. Your committee was concerned about the appearance of conflict raised by members of the public regarding Dr. Miike's previous affiliation with Hawaii Planned Parenthood and his endorsement of statements made by the Hawaii Firearms Control Coalition regarding his statutory responsibilities as the Director of Health. Your committee acknowledges that the nominee is aware of the committee's concerns about the appearance of conflict regarding his previous volunteer positions with the Hawaii Planned Parenthood, and your committee understands that he has terminated his affiliation with Hawaii Planned Parenthood.

"Your committee further acknowledges that Dr. Miike appeared conciliatory in his appearances before the committee especially in regard to the concerns expressed by the members, and he communicated to the committee that throughout his twenty-three-year career in health policies, he has maintained an objective approach to the many and sometimes very controversial issues which he has had to address.

"Your committee requested and received from Dr. Milke a written statement in which he disclosed all his previous professional and volunteer affiliations, and in which he also pledged: 'I am committed to the rule of law, and in my administration of the Department of Health I will be controlled and restricted by those provisions of the State Constitution and the Hawaii Revised Statutes which have specific application to the Department of Health.'

"Based upon the committee's intensive dialogue with the nominee, we feel very comfortable and we believe that this individual will take all these concerns of Hawaii's constituencies very seriously and be able to be an excellent health director.

"With this, Mr. President, I'm recommending a positive confirmation. Thank you."

Senator Liu also rose in favor of the nominee and said:

"Mr. President, I will be voting in favor of the nominee but I would like to have recorded that I do have some reservations on many of the grounds mentioned by the great chair of that committee. And I appreciate all the work that she has done.

Your committee finds that in view of the need for diversification the nominees are very supportive of a broader higher education accessibility on the neighbor islands. They support expansion of community colleges on the neighbor islands and to create a higher educational balance on the Big Island among the University of Hawaii at Hilo, Hawaii Community College and the West Hawaii Educational Center. Eventually there is envisioned a university campus in West Hawaii. For the immediate

future, the nominees support an expansion of the Outreach Program so that students on the neighbor islands can take as many courses as possible on their own island to save on expenses.

"The nominees are to be commended for their willingness to serve with compassion, commitment, and without compensation. And because of all these factors, Mr. President, I'm recommending a positive vote.

"Thank you."
