MESSAGES FROM THE GOVERNOR

The following messages from the Governor (Gov. Msg. Nos. 141 to 145) were read by the Clerk and were placed on file:

Gov. Msg. No. 141, letter dated February 1, 1996, as provided in Section 9, Article VII of the Constitution of the State of Hawaii, requesting immediate consideration and passage of S.B. No. 2884, which makes a supplementary appropriation for the Department of Public Safety to shift the authorization date of the Women's Community Correctional Center's construction cost element from Fiscal Year 1996-97 to Fiscal Year 1995-96.

Gov. Msg. No. 142, letter dated February 1, 1996, as provided in Section 9, Article VII of the Constitution of the State of Hawaii, requesting immediate consideration and passage of S.B. No. 2892, which makes a supplementary appropriation for the Department of Public Safety to prevent the shutdown of activities at several correctional facilities.

Gov. Msg. No. 143, letter dated February 1, 1996, as provided in Section 9, Article VII of the Constitution of the State of Hawaii, requesting immediate consideration and passage of S.B.
