"Mr. President, I rise to speak in favor of this bill.

"Mr. President, in your speech on opening day, you had said that tough times call for tough choices. With the passage of this bill, I feel that the Senate is dismissing the prevailing political winds and doing what is right and responsible for the people of Hawaii.

"I took no joy in passing this bill from my committee. I have seen the faces of those receiving general assistance, and I am fully aware of the ramifications of our committee's decision. But, Mr. President, I feel that this measure is the best opportunity available to provide some meaningful relief to those in need.

"Were we to fund general assistance at the levels of benefits currently for all recipients, we would need over \$8 million this year, and \$22 million for next year. This would represent a growth of 50 percent in this program alone. We simply cannot sustain the status quo.

"Knowing this, we sought to provide full assistance to those in greatest need. With this measure, Mr. President, families with children will still receive full benefits under the program. Without this measure, the levels of everyone's benefits would be cut across the board, and benefits for all would run out before the year's end. This was the decision your committee was faced with.

"The legislature has been assailed, especially by those in the lofty chairs of the <u>Honolulu Advertiser's</u> editorial board, as being cold and <u>unflinching</u> in our decisions. Rather than offer up genuine alternatives, they provide simplistic cliches and make nebulous references to 'cutting obsolete pre-Statehood programs.' Eight million here, twenty-two million there, it's just a matter of cutting somewhere else.

"Where would you like us to cut I ask? Over the past three years the University of Hawaii is facing almost \$45 million in budget cuts, the Department of Business Economic Development and Tourism has had its budget reduced by almost \$20 million; the Department of Health has had its budget slashed by more than \$37 million. Even the Department of Education has had its budget cut by almost \$25 million.

"My response to these voices is that my door is always open. If you have specific reductions to bring to the table, obsolete pre-Statehood programs, the committee will welcome your suggestions wholeheartedly. Mr. President, I fear, however, that this is only the beginning of a barrage of second guessing and armchair quarterbacking. We cannot, however, be drawn into hollow debates. We must continue to press forward and do what is right and not what is comfortable. The wellbeing of our State demands it. "I therefore ask my colleagues to support this measure. Thank you, Mr. President."

Senator Levin rose in opposition to the measure as follows:

"Mr. President, I rise to speak in opposition to this bill.

"I do so understanding the difficult choices that we face and with great respect for the decisions that have been made by the committees in bringing this bill to the floor. Nevertheless, I cannot help but feel that we need to do more with respect to protecting the safety net that we have provided for our people, proudly provided for our people, over the past many years.

"I have some statistics that I requested from the Department of Human Services as to the people who are on general assistance, and I thought I would like to share them with my colleagues. These are statistics based, I gather, on a one-month survey, so they may vary from month to month, but I assume that they are fairly accurate over a broad period of time.

"Fifty-two percent of the people on general assistance are born in Hawaii; they are not newcomers to the State. Ninety-two percent have lived in Hawaii at least two years before applying for assistance; so the image that we have sometimes, of people getting off the plane and going down to the Welfare Office, applies to very few of these Forty percent of all general assistance individuals. recipients are on welfare less than one year; so this is not a permanent situation for many people. Seventy-eight percent are on general assistance for less than two years; so more than three-quarters are on less than two years. Thirteen percent of the general assistance cases have some earned income, meaning that these individuals or these families are trying to make a go of it, but they cannot earn enough to get out of poverty, to keep their families intact or to be able to pay for a roof over their heads.

"There were about 13,600 recipients of general assistance in July of 1995, the month that these statistics came from. Eighteen hundred of those individuals were under the age of five. A thousand were between the ages of six and twelve. Another 345 were between the ages of 13 and 17. So what this measure will do will be to knock off 3,145 children from the general assistance rolls, either if they have already received six months' worth of assistance or when they do get to that six months figure. And of the balance of the 13,000, there were another 975 adults at the other end of the spectrum who are over the age of 55. And of course we know that general assistance is for individuals who are disabled, so we are talking about people who are over the age of 55 and who are disabled -- 975 such people will be taken off our rolls.

"I'd like to read an excerpt from a column that appeared in the <u>New York Times</u> by one of its columnists. The columnist had been in Africa, and upon returning to the United States was thinking about the comparisons. None of this relates specifically to Hawaii but he's referring to the United States. He says:

"We have something so special compared with almost every country in the world, but if we want to preserve it we have to pay for it. I don't know exactly where the budget compromises should come and there is certainly truth to the argument that to preserve our social safety nets, they have to be reformed and probably reduced in scope,' but we do need to do something.

'They don't worry about big government in Liberia. They don't worry about government at all -- thanks to the gangs and war lords who rule most of the land.

Employers don't have to fret at all about pesky workers' safety rules in Angola. let alone services for the handicapped. The 70,000 Angolans who have had limbs blown off by land mines during 25 years of civil war seem to make do just fine on their own. You see them limping around the streets of Luanda, hustling for food and using tree limbs as a substitute for the human variety. They sure looked happy to me. And in Rwanda and Burundi no one is asked to pay for Head Start, unemployment insurance, Medicaid, national service, or student loan programs. Instead they just have a brutal competition for scarce land, energy and water.'

[It's too bad that some people] 'never go on congressional junkets' (he's referring again to the national legislature). 'Too bad. They might want to come to Africa and glimpse what happens to countries where there is no sense of community, no sense that people owe their government anything; no sense that anyone is responsible for anyone else, and where everyone, rich or poor, is left to the tender mercies of the global marketplace.'

"The bill we have before us is meant to deal with the current crisis that we have, and I do not deny that there is a crisis. As this columnist has said, I don't know exactly where the budget compromises should come, and I think that the point made by the Ways and Means chair is absolutely valid. Those of us who would like to see this program funded should come up with alternatives and I don't have them. But the fact is that, hopefully, this is a temporary crisis. Hopefully we will come out of it, next year or the year after. This bill is not a temporary measure. There is no drop-dead clause. This bill will limit general assistance forever, unless and until we choose to change our statutes to repeal the six month limitation. I think that's unfortunate, and I think that what we apparently feel we must do, if we must do it, is also unfortunate.

"Thank you."

Senator Matsuura rose in support of the measure and said:

"Mr. President, as chair of Human Services, it's been always very difficult to make cuts in welfare benefits like this, especially when we have been very generous as a state. Once you give the benefits, it's very hard to take back. I just want to make a few comments on the other side of the coin so you don't feel so bad.

"There are two types of programs that deal primarily these physically handicapped and mentally with There's the federally funded program, handicapped. funded 100 percent by federal funds, that's called SSI. Those that are physically handicapped, mentally handicapped, they are already taken care of by the SSI program. They're all enrolled in the SSI program. The Department of Human Services with the assistance of Legal Aid are trying to get people on general assistance to Those who are in the so-called waiting period in SSI. which they most likely would be enrolled in the SSI, we have another fund that takes care of them financially. Once they are enrolled in the SSI program the federal government pays back to the state all the monies that we We are not have already given to that individual. neglecting the people who are handicapped. Believe me, I'm the last one that would want to cut the benefits from those who deserve to be helped because they truly need the help.

"The State of Hawaii is one of 22 states that have this general assistance program. General assistance funds are 100 percent state funded. No federal funds are involved.

I don't know what the other 28 states do to take care of their physically and mentally handicapped people who don't qualify for SSI. If we had the monies. I think we would continue with our generous benefits. However, because we are short of funds, we have to cut back.

"If you look at this bill you will find that some of the beneficiaries have been eliminated. The children who are being cared for by mothers, fathers, and 'hanai' parents qualify. They are the ones that qualify for benefits. We have eliminated grandfather, grandmother, brother, sister, step-father, step-mother, uncle, aunt, first cousin, nephew and niece from the definition of caregivers. In other words, we are cutting down the people who are entitled to general assistance. We are not being heartless. It's just the financial situation in which we find ourselves in. And as I said, we are taking care of the children. The children and single parents are taken care of by another welfare program called the AFDC, which is funded half by the federal government and half by the people who are poor and in need of help.

"I'll be voting 'aye' on this bill and if it was really unfair, I would be voting 'no', in fact, this bill wouldn't have come out of my committee. So I urge all of you to vote 'aye' on this measure. Thank you."

Senator Liu rose to speak in favor of the measure as follows:

"Mr. President, I rise to speak in favor of this bill, but also to point out that in sections of this bill we have revisited this issue because of a ruling by the court -frankly, a ruling which I think is indicative of rulings lately by various segments of the court, not just the circuit level, but also at higher levels that go much further than need be, I believe, than is required by reading of the law. I truly believe that the Legislature had the discretion last year to make distinctions as they felt was necessary in this area and that what we simply have here, to a large degree, is unnecessary meddling in legislative affairs, in setting policy, rather than interpreting the law as it should be

"Thank you, Mr. President."

The motion was put by the Chair and carried, Stand. Com. Rep. No. 1700 was adopted and S.B. No. 2304, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO GENERAL ASSISTANCE," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

RE-REFERRAL OF SENATE BILLS

Senator Solomon rose on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Mr. President and members of the Senate, I rise today on a point of personal privilege because I recently

received a letter from the U.S. Attorney, District of Hawaii, inviting me to attend a panel discussion on the impact of legalized gambling on Hawaii, sponsored by the U.S. Attorney's office and the Honolulu Police Department at which workshop at least five mainland speakers were scheduled to appear. I assume that the expenses of this scheduled panel discussion are to be defrayed by the sponsors including the travel expenses of those mainland speakers. Last year after the U.S. Attorney for the District of Hawaii on more than one occasion in his official position sought to influence our debate on the legalization of gambling by appearances before the Legislature and by way of press releases relative to the subject, I contacted the Honorable Janet Reno to determine whether in fact the federal government had a policy in regard to the legalization of gambling in the various states and was informed by her that, no, in fact the U.S. Government did not have such a policy and that the U.S. Attorneys were not authorized to speak on that subject in an attempt to influence legislation in the various states. We are engaged in a new legislative session and the practices of the U.S. Attorney for the District of Hawaii continue unabated in this regard.

"Mr. President, regardless of what one's position is on the issue of legalization of gambling in Hawaii there is no justification for the involvement of the federal government in attempting to influence the deliberation of this body on a matter of purely local concern. We must be eternally vigilant to protect the sovereignty of the States as guaranteed by the Tenth Amendment. Mr. President, I intend to again contact Attorney General Reno to insure that this type of interference is terminated.

"Additionally, Mr. President, I request that this body refer the subject of Mr. Alm's activities to the State Ethics Commission to determine whether he has complied with the provisions of Chapter 97, having to do with the registration of lobbyists, and if he has not, that proper action be taken pursuant to the penalties section of that Chapter.

"Thank you, Mr. President."

Senator Anderson rose on a point of personal privilege and said:

"Mr. President, I stand on a point of personal privilege.

"I'd like to have Senator Solomon's comments put into the Journal as though they were my own, and I'd like to add that I believe the people that come in to testify have a very direct concern or input of the committees that they've gone to in both houses. And that was one of the reasons that I thought if they are going to influence the votes of the individuals as far as the Senate and the House of Representatives, then in fact, we should have an advisory type of referendum which we do have that opportunity to have.

"But over and above that, I asked Mr. Alm before if he, in fact, is taking care of the job that he was put in office for and is watching all of the drugs that are coming into this state and taking care of the real necessity of his particular job, and I don't think that he is doing that, Mr. President. So I do thoroughly agree with the Senator from Hawaii. And I thank you very much."
