

## TWENTY-EIGHTH DAY

Friday, March 8, 1996

The Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1996, convened at 11:35 o'clock a.m. with the President in the Chair.

Your Committee further believes that Skippa is a 'keiki o ka aina' who exemplifies the Aloha Spirit through his active sharing of these values with his students. Testimony in support of the nominee indicated that Skippa possesses the character, compassion, consciousness, courage, and determination that will benefit the Stadium Authority.

"After full consideration of the background, character, experience, and qualifications, we find the nominee to be qualified for this position and recommend that the Senate advise and consent to the nomination."

Senator McCartney also rose in support of the nominee as follows:
