Senator Anderson rose on a point of personal privilege as follows:

"Mr. President, I stand on a point of personal privilege.

"Mr. President, this morning's paper said, 'Budget hits wall in Council,' and it's asking Mayor Jeremy Harris to take a stand on the firefighters' pay. And in here it says that we're trying to give every opportunity to the mayor to be involved to decline or accept. It also says that all four counties and the Legislature have to approve that pay raise.

"I read Letters to the Editor, and it said 'Fire Fighters feel tricked.' Now I'm not too sure, Mr. President, but if I remember correctly, the firefighters were one of the first to go into a binding arbitration. Under that, they had to live or die with whatever happened. And according to this, they were able to ask the governor for a 1.5 and everything was rejected. Then they went into binding arbitration and got a 7.2 percent wage increase.

"I think our integrity is really at stake here. We asked them to go into a binding arbitration and now we're saying we can't afford it, so now you go back to the table. I don't know what a binding arbitration is if it doesn't mean that we are going to be held responsible. And I think that it's terrible and I don't mean this as a point for politics or anything else. I think it's our integrity and I think it's our responsibility. So I would hope that we at the Legislature really look at that. It's a very important part and I think the council really has a responsibility to pay for that, rather than say 'reject' or 'accept.' To me, that's not binding.

Fire Fighters feel tricked

Employers' stubbornness brought big wage hike

The governor and the mayors of the four counties (the employers) have deliberately blocked efforts by an arbitration panel to make a decision it believed to be fair and equitable in our recent contract negotiations.

The employers have not accepted responsibility for the consequences. Instead, they have dishonored themselves and have shamelessly placed this responsibility on the shoulders of the Legislature and the county councils.

If the employers have their way, the legislative bodies will disapprove the final and binding decision (a two-year, 7.2 percent wage hike) and take the blame for making a mockery of the collective bargaining/arbitration process.

There is already an insidious public relations effort to

characterize this final and binding arbitration award as a mere "recommendation." It is not a recommendation. It is legally final and binding on both parties, not just on the Fire Fighters.

The chairman of the arbitration panel made extraordinary efforts to persuade the employers to grant the panel authority to choose something other than the union's final offer on wages. At one point, he even recommended a very modest 1 percent plus 1.5 percent wage increase settlement package.

In a Feb. 21 letter to chief negotiator Manabu Kimura, the chairman of the panel advised that . . . "the majority of the panel does not believe the employers have provided sufficient evidence to establish an inability to pay, which is a prerequisite to a zero wage offer. The employers' position in refusing to grant the panel flexibility leaves the panel little option. . "

On March 1, the decision and award said: "If the panel had the

authority, it would have selected a modified wage increase as more appropriate. But since the employers have refused to extend that authority to the panel, the only alternative is to accept the union's proposal as it was made with respect to wages."

It has been suggested that after the councils "just say no" to this arbitration decision, we will simply have to return to the bargaining table. For what? To apologize? We have a final and binding arbitration award. That's final.

The public is entitled to an explanation from the employers for this refusal to allow the arbitration panel to make a more reasonable decision.
