The Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1996, convened at 11:34 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Joseph A. Grimaldi, St. John Vianney Parish, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fortieth Day.

The following introductions were then made to the members of the Senate:

Senator Matsunaga, with the assistance of Senators Levin and Matsuura, introduced Dr. Ernest Bade and congratulated him for being named the 1996 Physician of the Year. Dr. Bade, who was accompanied by three representatives of the Hawaii Medical Association, was presented a Senate certificate and leis were presented to all of the guests.

Senator Anderson rose on a point of personal privilege as follows:

"Mr. President, I stand on a point of personal privilege.

"Mr. President, it's not very often that I apologize for things that I have said, but I would like to apologize to the chairman of the Transportation and Government Affairs Committee, and the committee, for some, I guess, emotional remarks that I made yesterday. I don't apologize because I was fighting for what I believed in as far as jobs and the economy, but I should not have let myself get emotionally involved against a particular company. So for that, I thank you very much for your patience that you had with me yesterday, and I do apologize for that.

"Thank you so much."

Senator Fukunaga, chair of the Committee on Communications and Public Utilities, requested a waiver of the 72-hour Notice of a Public Hearing on S.C.R. No. 208 and S.R. No. 161.

Senator Fukunaga explained:

"Mr. President, these resolutions were previously scheduled for decision-making yesterday afternoon but we ran a little overtime on our original time, so we would like to hear them this afternoon and conduct decision-making."

The Chair granted the waiver.

Senator Ige, chairman of the Committee on Higher Education, Culture, and Arts, also requested a waiver of the required hours of Notice of a Public Hearing on S.C.R. No. 172 and S.R. No. 136.

Senator Ige explained:

"Mr. President, this deals with requesting the Board of Regents to consider development of an education and research center at Hawaii Natural Energy Laboratory. We did have a hearing and decision-making on Wednesday but we received some late testimony, so we would like to reconsider action this afternoon."

The Chair granted the waiver.

Senator Bunda rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, I'd like to provide you and this body with an update on the Makua Beach situation. As most of you have read, the Governor finally met with Senator Solomon and myself. Mr. President, the Governor, however, still intends to evict the people at Makua by June 15th. However, I can report that it is our understanding that the Governor has committed to assembling a task force to work with the residents of Makua prior to the eviction date.

"Mr. President, it is also our understanding that this task force will bring together the different agencies and community agencies to find solutions which the Makua residents face. I've asked for specific plans on the task force to be given to this body and myself. The provider groups will be going out to Makua next week to look at the immediate needs, such as water, toilets, trash pick-up and telephone, and I understand that these things will be taken care of.

"But, Mr. President, based on this commitment, we are holding the Governor to his word. We have decided to defer on passing a resolution because we all know that the Senate's resolution would not really have an effect on the eviction date, which is pretty imminent, on June 15th. I'd like to say that we realize that by not passing out this resolution, the residents of Makua may feel somewhat betrayed by the system that they came to for help. But I'd like to reassure them that their efforts are really not in vain; that we are still working towards a win-win situation; and in hearing the reso, it did something. We were listening to the people and they were talking about how the eviction would have an impact on the children. So the Governor learned about that, and that's the reason why he thought twice about it and he moved the eviction date from April 15th to June 15th.

"But at this point, Mr. President, I'd like to state that only the Governor can take action to resolve the situation, and the residents of Makua have our word that we will be

holding the Governor to his word to insure that he really walks the talk.

"Thank you, Mr. President."

Senator Holt also rose on a point of personal privilege and said:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, on behalf of you, Senator Ikeda and the rest of this body, I'd like to extend our appreciation to the Governor for his prompt response to the letter sent him regarding auto insurance reform. Since receipt of the Governor's letter, your Committees on Consumer Protection and Ways and Means have been working late hours to address his biggest concern -- developing a reform proposal that will result in a significant rate reduction of 25 to 35 percent -- guaranteed.

"Mr. President, as I publicly stated earlier, we had crunched the numbers to achieve a rate reduction of 25 to 35 percent that could be actuarially supported. I am pleased to report, Mr. President, that we have developed a reform measure that will accomplish this and, in addition, provide more benefits to the consumer. Your committees are working on detailed language for a draft proposal to be available for the committee, this body and the general public on Monday. And we have scheduled a hearing on this proposal for Tuesday, April 2, at 6:30 p.m.

"Mr. President, we strongly believe that our plan is actuarially sound and addresses the Governor's key concerns. Further, Mr. President, the Senate's proposal will provide assurance that there will be no cost shift to employers. The Insurance Commissioner can implement a 25 to 35 percent rate reduction by October 1, 1996. And Pat Cabalse of Kau and others like Senator Levin who live in rural areas and drive 'rural' vehicles can purchase auto insurance for just over \$30 a month; be covered for 99 percent of all accidents, and be able to sue for intentional criminal conduct and if they are catastrophically injured.

"Mr. President, I look forward to Tuesday's hearing. I remain firmly committed to work with the Governor and the House to produce an auto reform measure this session. Thank you."
