THIRD READING

H.B. No. 3347, S.D. 1:

Senator Graulty moved that H.B. No. 3347, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator McCartney.

Senator Matsunaga rose to speak on the measure and stated:

"For the reasons I articulated on Tuesday, I will be voting 'aye' with reservations on this measure."

Senator Kanno added:

"Mr. President, I will be voting 'aye' with reservation."

Senator Holt rose in support of the measure and stated:

"Mr. President, I rise to speak in support of this bill.

"As you are aware, Mr. President, the issues with regard to the subject matter of this bill have been debated in the Legislature and in the public for a number of years. The major difference now, however, is the fact that the courts will essentially decide the matter for us if we adjourn without taking any action.

"I firmly believe, Mr. President, that it will be irresponsible for the entire Legislature to knowingly defer a final resolution of this or any other important public policy matter, which are properly determined by statute, to the courts. In attempting to address this issue, the House has proposed a constitutional amendment defining marriage. In contrast, the Senate has proposed enabling legislation for domestic partnerships. Both measures, however, appear to have failed to earn any support in the opposite houses of the Legislature.

"In our attempt to address this matter, Mr. President, we have lost sight of our basic responsibility to uphold and defend the intent and purpose of our existing laws regarding marriage. Very simply, Mr. President, this is precisely what the Supreme Court has asked us to do in their ruling that the state must show a compelling state interest as a basis for its laws regulating marriage. I believe that the bill before us accomplishes this. It reiterates the original intent and purpose of the law by amending Chapter 572 by adding a purpose clause.

"In addition, it would add a severability clause to Chapter 572 which would effectively sever any provision or application of any provision in this chapter if such a provision or application is found to be invalid by the courts.

"For these reasons, Mr. President, I urge my colleagues to carefully consider the bill's content and merit and join me in voting in support of this measure. Thank you."

Senator Taniguchi then added:

"Mr. President, reservations for me also."

The motion was then put by the Chair and carried, H.B. No. 3347, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO INTERPRETATION OF STATUTES," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 23. Noes, none. Excused, 2 (Ikeda, Fukunaga).

Senator Anderson rose on a point of personal privilege as follows:

"Mr. President, I'd like to stand on a point of personal privilege or point of information. I'm not sure which.

"In this evening's paper, and it more or less has to do with the bill which we just passed, it says 'Senate kills bill to ban same-sex unions,' and it says that we double-referred it to another committee.

"Now, it's my understanding, and I want to thank the President and the two chairs, but it's my understanding that in the past, the reason we held this up is that we had a Senate bill and there was no sense in hearing the House bill or the House version. But now that it's gone to two committees, the other committee has not heard the bill. So I would think you did that so the bill would be heard. And if I'm wrong, then maybe the paper is right or maybe the paper has got the wrong information. So, I'm not sure what we're trying to do on the re-referral. Does that then mean that since the other committee had not heard it, we are going to hear that particular bill from the House or is it that we did purposely icebox the bill.

"I'm not sure whether it was on a point of personal privilege or information that I stood. Thank you very much, Mr. President."

Senator Matsuura rose on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Yesterday, when the Senator from Kohala spoke about a rally that was taking place outside I really didn't know what was happening. I didn't know what the rally was about until I went upstairs and I saw the former Senate president giving a speech. The reason was primarily that the OHA budget was being cut,

"I've been involved in drafting a lot of legislation here. Ocean leasing is an example. I can remember the discussion where the Hawaiian rights were being taken away. I said, 'No, you can't do that. Those rights are inherent and they must be retained.' Geothermal was another example; mineral rights, same thing. Twenty percent of the revenues should go to the Hawaiian people. Water code was another that I was involved in drafting. The same thing happened trying to keep the rights of the Hawaiian people intact.

"I heard about the bill that was being introduced in the House this session. It would defer payment to OHA for three years. I don't know whether it was for 3 years or 5 years. I went to the person who introduced that bill in the House. I said, 'What's the purpose? Do you want to start a revolution? If your intent is to unite the Hawaiian people, terrific! I agree with that strategy. That bill didn't make it out of the House. Instead they sent over another bill that the rally was all about yesterday.

"Mr. President, I've been here long enough and if one looks at the history of the Hawaiian people one will understand the reason for the rally. Take a look at all the Hawaiian Homes lands that they have. Just take away the infrastructure of the water distribution system and those lands would be worth nothing. They were given the worse land by congress at the time of annexation. It was wrong! Are we going to balance the budget at the expense of the Hawaiian people? I'm against it! I want this body and the whole world to know that there's at least one Japanese who's going to stand with the Hawaiians on this issue. We must honor our commitment to the Hawaiian people.

"Thank you."

Senator Solomon also rose on a point of personal privilege and said:

"Mr. President, I'm also rising on a point of personal privilege.

"I'd like to thank my fellow Senator from the Big Island for his remarks. I think that they are appropriate in terms of the struggles of the Hawaiian people and I just want to reiterate that the Senate has taken a very strong position on this matter and is against changing the basis for calculating revenues from ceded lands, so, thank you very much for your support on that."
