The Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1996, convened at 11:39 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Ms. Treneater C. Horton, Baha'i Faith of the Hawaiian Islands, after which the Roll was called showing all Senators present with the exception of Senators Aki, Holt, Ikeda and Solomon who were excused.

The President announced that he had read and approved the Journal of the Forty-Eighth Day.

Senator Kawamoto, with the assistance of Senators Graulty, Fukunaga and Tanaka, introduced Lieutenant General Robert L. Ord, III; Rear Admiral W.G.
